a lot of the youth that came to the actual event range from the ages of 6 to 14 that day they came from. from

As far as where they reside 40203 for until April 294 to 11416 and 400 to 18 and we gathered all that prior to the event with registration. The youth had to with their families. Of course, go to different stations are all educationally based.
We worked with a lot of partners in the community, but every booth was educationally based with the Derby museum with the science center with the Pre public library.
derby museum with the science center with the pre public library
as well as so many others but they were able to do that we have families that stayed the event was from eleven to three o'clock we have families that came at eleven and didn't leave to two because they're youth were having such a great great time there was food of course for the families and we had over two hundred and twenty eight participants as far as the kids were concerned once they finished the activities they were able to come and get their backpacks and $t$ shirts and things of that nature after they finish out those
activities
With their families, and we do programs as councilman triplets stated all year long, because once these moments do occur, whether they're good or bad in their life, we need to make sure we're consistently connected to these.
Youth and their families, so we can at least guide them in the right direction, or send them to another organization that can help them. All of our team happens to be teachers or facilitators that are working with us outside of the school school time. So, hopefully that she has a little bit more light on what we do.

Their solution wise, um.
Report to us quarterly on project progress, which is basically.
We get to come in a couple of times a year and tell you why it's taking so long.
Bullet point number 2 was readjust your time expectations.
Which is basically another way of saying, don't think it's going to be quick.
Because it ain't so essentially, none of the solutions that were there really solved anything. Um, I will say, just again to kind of.
Clue everybody in on where $I$ think $I$ may throw out an amendment at some point and that would be that all of our NDS projects.
Whether they be parks public works or whatever, and this is let me back up. This is a spin off of what their last recommendation was, which is that we using Council.
Our council budget hire our own engineer or 2.
To design all projects, whether they're public works or parks or whatever city agency, we're trying to give money to. We have our own engineers over here on staff. Just like, we have PR, just like, we have finance, et cetera.
That would come out of that same pool of money.
Which was an interesting concept, but it gave me the idea. And this is the direction $I$ 'm now headed after making some phone calls to
subcontractor friends, which is.
Um, all the all that are.
That are basically paid for with cash. If it's a, that goes to bond, there may be some.
Issue and I'm sure they'll somebody will figure out a reason to tell me why I can't. But, um.
I just think that the moment we approve the money, it automatically gets
put out for bid and goes direct to a contractor who designs it design builds the project and it's done.
Pretty much everyone $I$ call today, who's in the construction business who I know and is, you know, some of them don't aren't even going to bid on government projects. So they don't even have a dog in the fight.
They more than convinced me that things could get done within the calendar year or fiscal within 12 months of appropriating the money. Most of these projects would be done.
So, I'm sure we have a list of approved contractors and instead of us him horn around and waiting for things to get done in order or whatever, just every 1 of our projects automatically get handed off to an outside contractor.
