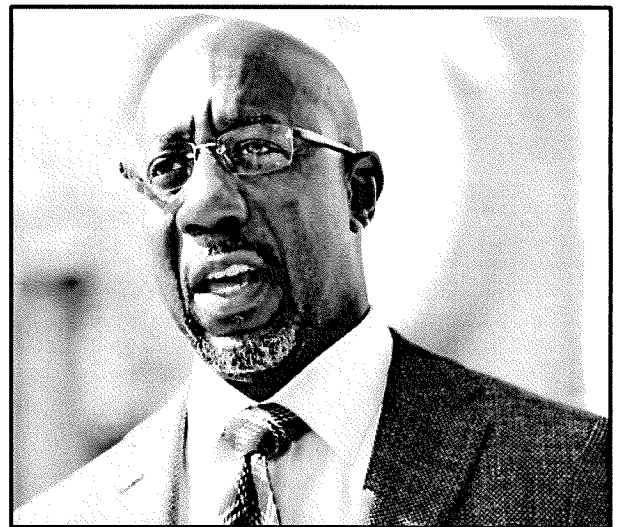

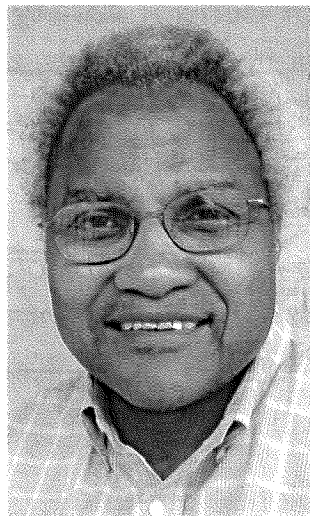

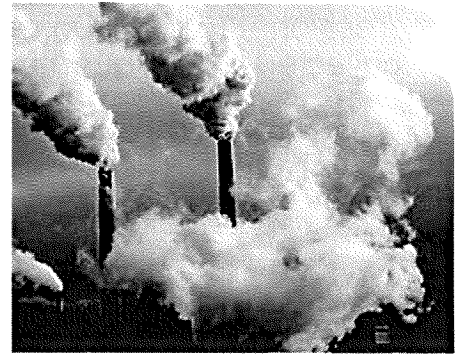


What is CCRP?

CCRP is a list of, thus far, 44 practical [sub]programs of ways to redirect carbon emissions back into the Earth, and to otherwise reduce emissions. Some of the programs will reduce water pollution. **The-Protect-America-Project.org** introduces 3 programs in Cobble's *Answers to the Kentuckians for the Commonwealth Candidates Survey*.

One of Cobble's CCRP proposals is the "Agricultural Greenhouse Program" (**AGP**).

AGP will comprise giant multi-level greenhouses that channel-in industrial smoke stacks (for LG&E, West Louisville, Etc.) to trap & absorb emissions into the greenhouse agriculture. In-turn, the emissions are a

B. Notice of 30 Days to Respond to this Tort

B-1. Though this tort action is for public benefit, it requires Mr. Cobble to claim a monetary \$amount for his injuries. And wherefore, the feasors are hereby given **30 days** to respond to the above/foregoing enumerated allegations of wrongs & injuries. Under common law (U.S. 7th Amendment), they admit to the herein enumerated injuries if not factually disputed thereof. – Remaining silent is a “default legal admission” that may result in a lien for payment to compensate for the injuries.

To wit:

- A.** The Kentucky State Treasury for \$100,000.00 and against the indemnity of Feasor Michael Adams; and
- B.** The Kentucky State Treasury for \$100,000.00 and against the indemnity of Feasor Karen Sellers; and
- C.** The Jefferson County Government for \$100,000.00 and against the indemnity of Feasor Bobbi Holsclaw.

A-4. The 700 voters per precinct solves the mystery that was always baffling of how vote counts were always ready on Election Night, even during presidential elections before the computer age. The precinct officers are only responsible for 700 votes that are counted relatively quickly (within a few hours) for reporting to the county clerk. – This “almost perfect” decentralized system (not controlled by the politicians) made it difficult to cheat.

A-5. **The motive for changing the voting system:** Obviously, to report-in vote counts on Election Night, all States operated on this same fundamental system of decentralized neighborhood voting precincts. Prior to the onslaught of mail-ins and EVMs (electronic voting machines), there were no persistent formal allegations of problems (voter irregularities) with the nation’s voting processes. -- Cobble believes the motive for the movement of politicians to change/centralize voting for their control of vote counts is related to the nation’s debt crisis.

A-6. The Federal Reserve’s three antitrust violations cited in Cobble’s lawsuit, 3:20-cv-298 (began in 1999 with repeal/termination of the Glass-Steagall Act), has steadily diminished the U.S. tax base. As a result, the 2006 **Postal Accountability & Enhancement Act** increased postage prices to now pay the healthcare & pension payments for postal workers. So it was predictable that voters would come to want to change the status quo. For, such as the Postal Service, the diminishing tax base is obstructing all Gov’t programs in funding cuts (education, infrastructure, global warming, etc.) and of course eliminating programs.

A-7. In 2016, decentralizing laws, such as §148 in Kentucky, ensured fair enough elections to elect Donald Trump to office. Then to centralize voting in Kentucky, again so that State & county officials can count/handle the votes, the KY legislature passed KRS 117.0861 (House Bill 574). However, Cobble’s case 20-ci-865 charged that §117.0861 conflicts with §148, and thus §117.0861 is unconstitutional.³

A-8. As in 2020 and the 2022 KY Primaries, **Feasors Adams, Sellers, and Holsclaw** are conspiring to again incorporate these obstructions of voting processes for the November 8 elections. They are involved in the wholesale disenfranchisement of voters, most especially to prevent Cobble from getting elected. And again, many other candidates will suffer collateral damage. Wherefore, as stated, the herein tort requires the feasors’ removal from office.

A-9. In addition, these obstructions by the feasors are causing pain & suffering upon Cobble’s household by his running for office. But due to the fiscal dangers that Jefferson County, Kentucky, and the nation at-large finds itself, Cobble’s only option is to run for office.

A-10. And again, **Feasors Adams, Sellers, and Holsclaw** are complicit with dark democracy, as herein described, precipitated by the local radio and TV stations to ensure the further disenfranchisement of the voters on November 8.

³ On his Election webpage, Feasor Adams explains some of the unlawful provisions of KRS 117.0861. He deceives the public by calling the provisions House Bill 574 that no longer exists.

9. Since only neighborhood precincts are allowed, the feasons are violating §148 to misappropriate tax dollars for countywide precincts where anyone can vote. Based on these violations, the 2020 U.S. Senate race of which Cobble was also a write-in candidate, **Feasor Adams** admitted to certifying a false election total of Cobble. The conflict-of-interest provided for State & county precinct officers to mishandle the votes for miscounting.

10. And finally, **as introduced**, the feasons should be- but are not discouraging the radio and TV broadcasters from blacking out local coverage of the races. The blackouts are to avoid mentioning Cobble's name. For example, the broadcasters' coverage as late as the August 6, 2022 Fancy Farm political event did not mention the Louisville District 3 race for U.S. Representative District 3 of which is the largest U.S. Rep race in Kentucky. And here as well, all other candidates in Jefferson County are impacted by this dark democracy blacking them out.

11. So through the above activity to prevent Cobble from winning the District 3 race, Feasors are again conspiring to violate §148 to disenfranchise the voters of Jefferson County. Even further, this obstruction of the District 3 race is obstructing the other races in Jefferson County and across Kentucky. And wherefore, the herein tort claim with subsequent liens are needed/required to remove the feasons from office.

A. **Kentucky Constitution §148 Decentralizes Voting to Prevent Cheating**

A-1 The 1891 (original ratification) §148 so states in part:

“ . . . all officers of any election shall be residents and voters in the precinct in which they act.”

Here, State officials are instructed that State and county personnel cannot serve as precinct officers. Only residents in that precinct can serve as officers.

A-2. Since residents can only be voters within their precincts, countywide precincts are unconstitutional. This fundamental constitutional “neighborhood provision” removes the conflict of interest of State and county officials counting the votes. In fact, the proper handling of mail-in ballots require the sealed/un-open ballots are delivered to the neighborhood precinct officers for handling and counting.²

A-3. **In addition**, §148 supports the necessity of KRS 117.055 that states:

“ . . . Each precinct shall contain, as nearly as practicable, an equal number of voters, based on the number of registered voters in the county, **not to exceed seven hundred (700) to a precinct.**” (Emphasis in bold & underline was added here.)

² GENERAL MAIL-IN BALLOTS FOR CONVENIENCE ARE UNCONSTITUTIONAL. **§147 of the KY Const.** require voter identification on ballots remain “secret” from Gov'mt officials. Thus, since mail-ins require the identification of voters, of which are “not secret,” then mail-ins **are not** lawful processes for voting except when the voter cannot travel to the voting poll. And whereby, mail-ins for mere convenience are unlawful since they unnecessarily reveal voter privacy to officials.

herein to prevent Cobble from winning, including the opportunity to certify false vote counts as done by the admitted election fraud in the 2020 U.S. Senate race.

3. The herein tort references the injuries & violations identified in KY civil case **20-ci-865**, and the **December 29, 2021 Criminal Complaint** to the Franklin County Sheriff, and the **June 17 & August 19, 2022 Notices of Tort Claim & Liens** to remove the several officials from office. **Feasors Adams, Sellers, and Holsclaw** have violated and thus conspiring to **continue violating KY Constitution §148** in the upcoming November 8, 2022 general election.

4. Violating §148 leads to the conspiracy, obstruction of the lawful election processes, other election fraud, and misappropriation of tax dollars to disenfranchise the voters of Jefferson County, as well as all other counties in Kentucky. Then, where practiced in Kentucky, the feasors supporting dark democracy will worsen the impact of disenfranchisement by the broadcast media not informing voters about the candidates.

5. **DISCLOSURE OF LAWSUIT** (for preventing dark democracy): Cobble has filed Case 3:22-cv-403-CHB in federal court (Louisville) for injunction to require the Federal Communications Commission to issue a general "Broadcast the Candidates Order" (**BCO**). A BCO would require local radio and TV stations to broadcast all registered candidates within their localities so voters can learn/know who is running for office. A BCO will eliminate dark democracy and diminish the effects of "ballot harvesting" and the "dark money" that pursue election campaigns.

JUSTIFICATION

6. Pursuant to the presented actions in above paragraph 1, Mr. Cobble has given the feasors every opportunity to correct this situation. But they have remained silent and thus in agreement with Cobble's allegations, despite the fact that Mr. Cobble is a registered candidate for the earlier Primaries and Nov. 8 elections. Furthermore, under the First Amendment and common law (7th Amendment), and with Cobble's household paying over \$6,800 annually in taxes & fees, the feasors are "warranted" to address/Answer the issues of Mr. Cobble. Their continuing silence is further "legal admissions" to the herein enumerated allegations.

7. The issues in the above named presentments affect the very nature of our voting system, of which, today, mostly all citizens (Democrats, Republicans, Independents, Etc.) are disgusted with the performance of Gov't. Yet the feasors will not recognize Mr. Cobble to correct these issues, not even for the public good.

8. As it stands now, the feasors are compromising voting and vote-counting and misappropriating tax dollars to do so. **This is a material conflict-of-interest** between §148 and what **Feasors Adams, Sellers, and Holsclaw** are doing. They are allowing county and State officials to handle and count the ballots for reporting for certification. This is forbidden under §148 of which requires precinct officers to reside within their respective neighborhood precincts to count and handle the votes.

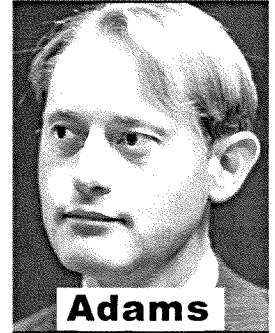

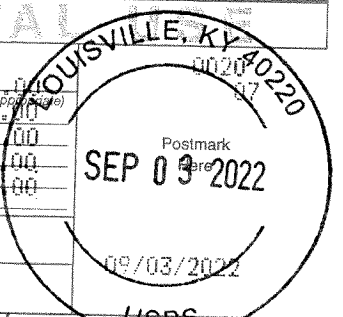

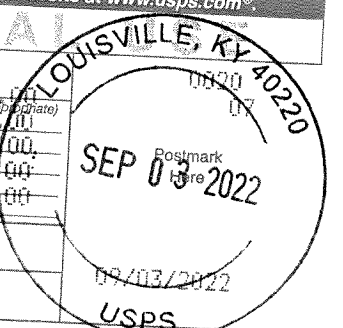

A-4. The 700 voters per precinct solves the mystery that was always baffling of how vote counts were always ready on Election Night, even during presidential elections before the computer age. The precinct officers are only responsible for 700 votes that are counted relatively quickly (within a few hours) for reporting to the county clerk. – This “almost perfect” decentralized system (not controlled by the politicians) made it difficult to cheat.

A-5. **The motive for changing the voting system:** Obviously, to report-in vote counts on Election Night, all States operated on this same fundamental system of decentralized neighborhood voting precincts. Prior to the onslaught of mail-ins and EVMs (electronic voting machines), there were no persistent formal allegations of problems (voter irregularities) with the nation’s voting processes. -- Cobble believes the motive for the movement of politicians to change/centralize voting for their control of vote counts is related to the nation’s debt crisis.

A-6. The Federal Reserve’s three antitrust violations cited in Cobble’s lawsuit, 3:20-cv-298 (began in 1999 with repeal/termination of the Glass-Steagall Act), has steadily diminished the U.S. tax base. As a result, the 2006 **Postal Accountability & Enhancement Act** increased postage prices to now pay the healthcare & pension payments for postal workers. So it was predictable that voters would come to want to change the status quo. For, such as the Postal Service, the diminishing tax base is obstructing all Gov’t programs in funding cuts (education, infrastructure, global warming, etc.) and of course eliminating programs.

A-7. In 2016, decentralizing laws, such as §148 in Kentucky, ensured fair enough elections to elect Donald Trump to office. Then to centralize voting in Kentucky, again so that State & county officials can count/handle the votes, the KY legislature passed KRS 117.0861 (House Bill 574). However, Cobble’s case 20-ci-865 charged that §117.0861 conflicts with §148, and thus §117.0861 is unconstitutional. ³

A-8. As in 2020 and the 2022 KY Primaries, **Feasors Adams, Sellers, and Holsclaw** are conspiring to again incorporate these obstructions of voting processes for the November 8 elections. They are involved in the wholesale disenfranchisement of voters, most especially to prevent Cobble from getting elected. And again, many other candidates will suffer collateral damage. Wherefore, as stated, the herein tort requires the feasors’ removal from office.

A-9. In addition, these obstructions by the feasors are causing pain & suffering upon Cobble’s household by his running for office. But due to the fiscal dangers that Jefferson County, Kentucky, and the nation at-large finds itself, Cobble’s only option is to run for office.

A-10. And again, **Feasors Adams, Sellers, and Holsclaw** are complicit with dark democracy, as herein described, precipitated by the local radio and TV stations to ensure the further disenfranchisement of the voters on November 8.

³ On his Election webpage, Feasor Adams explains some of the unlawful provisions of KRS 117.0861. He deceives the public by calling the provisions House Bill 574 that no longer exists.

9. Since only neighborhood precincts are allowed, the feasons are violating §148 to misappropriate tax dollars for countywide precincts where anyone can vote. Based on these violations, the 2020 U.S. Senate race of which Cobble was also a write-in candidate, **Feasor Adams** admitted to certifying a false election total of Cobble. The conflict-of-interest provided for State & county precinct officers to mishandle the votes for miscounting.

10. And finally, **as introduced**, the feasons should be- but are not discouraging the radio and TV broadcasters from blacking out local coverage of the races. The blackouts are to avoid mentioning Cobble's name. For example, the broadcasters' coverage as late as the August 6, 2022 Fancy Farm political event did not mention the Louisville District 3 race for U.S. Representative District 3 of which is the largest U.S. Rep race in Kentucky. And here as well, all other candidates in Jefferson County are impacted by this dark democracy blacking them out.

11. So through the above activity to prevent Cobble from winning the District 3 race, Feasors are again conspiring to violate §148 to disenfranchise the voters of Jefferson County. Even further, this obstruction of the District 3 race is obstructing the other races in Jefferson County and across Kentucky. And wherefore, the herein tort claim with subsequent liens are needed/required to remove the feasors from office.

A. Kentucky Constitution §148 Decentralizes Voting to Prevent Cheating

A-1 The 1891 (original ratification) §148 so states in part:

“ . . . all officers of any election shall be residents and voters in the precinct in which they act.”

Here, State officials are instructed that State and county personnel cannot serve as precinct officers. Only residents in that precinct can serve as officers.

A-2. Since residents can only be voters within their precincts, countywide precincts are unconstitutional. This fundamental constitutional “neighborhood provision” removes the conflict of interest of State and county officials counting the votes. In fact, the proper handling of mail-in ballots require the sealed/un-open ballots are delivered to the neighborhood precinct officers for handling and counting. ²

A-3. **In addition**, §148 supports the necessity of KRS 117.055 that states:

“ . . . Each precinct shall contain, as nearly as practicable, an equal number of voters, based on the number of registered voters in the county, **not to exceed seven hundred (700) to a precinct.**” (Emphasis in bold & underline was added here.)

² GENERAL MAIL-IN BALLOTS FOR CONVENIENCE ARE UNCONSTITUTIONAL. **§147 of the KY Const.** require voter identification on ballots remain “secret” from Gov't officials. Thus, since mail-ins require the identification of voters, of which are “not secret,” then mail-ins **are not** lawful processes for voting except when the voter cannot travel to the voting poll. And whereby, mail-ins for mere convenience are unlawful since they unnecessarily reveal voter privacy to officials.

herein to prevent Cobble from winning, including the opportunity to certify false vote counts as done by the admitted election fraud in the 2020 U.S. Senate race.

3. The herein tort references the injuries & violations identified in KY civil case **20-ci-865**, and the **December 29, 2021 Criminal Complaint** to the Franklin County Sheriff, and the **June 17 & August 19, 2022 Notices of Tort Claim & Liens** to remove the several officials from office. **Feasors Adams, Sellers, and Holsclaw** have violated and thus conspiring to **continue violating KY Constitution §148** in the upcoming November 8, 2022 general election.

4. 5. **DISCLOSURE OF LAWSUIT** (for preventing dark democracy): Cobble has filed Case 3:22-cv-403-CHB in federal court (Louisville) for injunction to require the Federal Communications Commission to issue a general "Broadcast the Candidates Order" (**BCO**). A BCO would require local radio and TV stations to broadcast all registered candidates within their localities so voters can learn/know who is running for office. A BCO will eliminate dark democracy and diminish the effects of "ballot harvesting" and the "dark money" that pursue election campaigns.

JUSTIFICATION

6. Pursuant to the presented actions in above paragraph 1, Mr. Cobble has given the feasors every opportunity to correct this situation. But they have remained silent and thus in agreement with Cobble's allegations, despite the fact that Mr. Cobble is a registered candidate for the earlier Primaries and Nov. 8 elections. Furthermore, under the First Amendment and common law (7th Amendment), and with Cobble's household paying over \$6,800 annually in taxes & fees, the feasors are "warranted" to address/Answer the issues of Mr. Cobble. Their continuing silence is further "legal admissions" to the herein enumerated allegations.

7. The issues in the above named presentments affect the very nature of our voting system, of which, today, mostly all citizens (Democrats, Republicans, Independents, Etc.) are disgusted with the performance of Gov'mt. Yet the feasors will not recognize Mr. Cobble to correct these issues, not even for the public good.

8. This ends my report. Thank you.

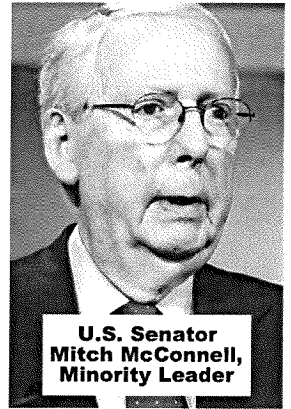

Dear Tort-feasors (Offenders),

1. Pursuant to the injuries & violations identified in presentments **federal civil suits 3:20-cv-298** and **3:20-cv-579** in Louisville, Kentucky, and the **September 28, 2021 Amended Criminal Complaint** filed with Sheriff Darren M. Popkin of Montgomery County, Maryland, and the written references, you are violating your Oaths-of-office to create crises against the sovereignty of the United States (**U.S.**).¹
 2. **Feasors Chief Judge Jeffery Sutton** and **Senior Judge Charles R. Simpson, III** are two of the federal judges refusing to process said suits. Sheriff Popkin has refused to process the 9-3-2022 Criminal Complaint against **Feasors Albert Bouria, Dr. Anthony Fauci**, et al. - Meanwhile, the feasors continue to cause the same irreparable harms suffered by the secured party (Daniel Cobble & family) and most other citizens in the U.S.
 3. This tort is necessary because the judges and sheriff have refused to process the claims that have shielded your silence. The claims do not charge **Feasor McConnell**, but he has been notified of the herein issues. Thus, this matter defaults to the common law "administrative claims process." The **U.S. 7th Amendment** instructs your jurisdiction is only by common law.
 4. The allegations of injuries & violations are summarized in the following enumerations entitled on page 2. **You have 30 days to dispute** the enumerations in writing. If not disputed, then under common law pursuant to the 7th Amendment, your continued silence are "legal admissions" to the allegations that requires your removal from office.

A. Debt Crisis by Feds' Antitrust Violations Collapsing the Economy; Repair is Ignored by Both Party Leaderships

- A-1. By the herein evidence, **Feasors Sutton, Simpson, Mitch McConnell, Jerome Powell, Joe Biden, Beshear**, and **Nancy Pelosi** are allowing collapse of the U.S. economy. As Republicans and Democrats, you are refusing to reverse the 3 antitrust violations that would prevent collapse.
- A-2. To wit, on April 17, 2020, Secured Party Daniel Cobble (hereafter called Mr. Cobble or Cobble) filed federal civil suit 3:20-cv-298 in Louisville, Kentucky. While the issue of "waiving the

unconstitutional filing fee” is under appeal, on January 26, 2021, he filed by mail the **second Amended Complaint** in the U.S. Court of Appeals, Appellate Case 20-5854/3:20-cv-298. 3:20-cv-298 identifies the Federal Reserve’s three antitrust violations that are transferring \$trillions every year to Wall Street corporations. This unlawful transfer-of-wealth (unlawful transactions) has diminished the U.S. tax base today by taxpayers paying over 50% of federal taxes & fees to the Federal Reserve debt. As shown in **Attachments 1 & 2** (pgs. 6 & 8) the \$transfer creates “un-payable circular debt” that continues to increase though every year \$trillions are paid to the debt.

A-3. Due to this \$transfer to Wall Street, this “remarkable problem” forces the continuing rises in taxes and fees at all three levels of Gov’t. For, since the federal gov’t is applying fewer tax revenues to the budget each year, States and cities receive less-and-less federal revenues, too.

A-4. **Said three antitrust violations** below, for corrections, are as follows:

VIOLATION 1: Reinstate provisions of the Glass-Steagall Act of 1933 that was repealed / terminated in 1999 by President Bill Clinton & the Republican Congress. Since 1933, Glass-Steagall had prevented derivatives and hedge funds traders, etc. from placing bank accounts & other consumer accounts at risk. Reinstating the provisions of Glass-Steagall will end these “free money trades” against consumer accounts to Wall Street, and “once again” allow people to safely deposit their monies into banks and other institutions, and for reasonable rates-of-returns on \$interest rates for account \$savings. As illustrated in **Attachment 3** (pg. 9), according to the *Bank of International Standards*, traders have accumulated, conservatively, over \$1.2 quadrillion in derivatives contracts, and over \$100 trillion in hedge funds contracts from the labor and fortitude of the American people.

VIOLATION 2: Reinstate the competitively higher prime interest rate (proposed at 4.75%; was 5.46% in 1999). With the threat of ending the **Fed, Feasor Powell** is raising the prime rate. Consumers and small business loans are once again becoming attractive to banks. The Fed prime rate, at 0.25%, reduces economic activity and tax revenues because the low rate chases dollars away from U.S. communities in search of higher \$returns. It discourages banks from lending to “retail consumers & small businesses” even though [loan] capital to consumers & small businesses makeup the primary engine of the economy. Instead, with such low rates, banks earn more from larger “corporate loans.” Ending this cheap money, too, to Wall Street corporations, will help stop the buying-up of property that is driving up prices across the marketplace and **decreases competition that also drives up prices.**

VIOLATION 3: Stop the illegal Fed loans to investment bankers (Merrill Lynch, Berkshire Hathaway, Vanguard, Etc.). **On May 2, 2008**, then Fed Chairman Ben Bernanke announced that “investment bankers” can now borrow directly from the Fed (then at 0.25%) in violation of the **Federal Reserve Act of 1913 (FRA)**, Section 13, clause 2. Again, **for buying-up property**, every year this practice removes \$trillions from “commercial sector circulation” for direct, illegal entry to the “financial sector” (Wall Street corporations). This practice also prevents “dollar monetization.” To make-up for these economic losses / transfer of dollars, similar to “too low interest rates,” we borrow more from the Fed that then forces constant tax & fee hikes and cutbacks on vital programs. This practice, too, has diminished the U.S. tax base leading ultimately to economic collapse.
