- There were several questions regarding further defining the term true threat.
- There were several questions regarding the "prudent man" or "reasonable person" standard.

- This legislation was created in response to a growing trend of thefts of scrap metals from vehicles such as catalytic converters and other restrictive metals.
- There was a discussion regarding how to discourage this type of theft, such as by imposing fines and increasing fees for the thefts and receiving stolen

property.

- There was a discussion regarding further defining types of metals, possession, and/or theft.
- There were several questions regarding to the actual value of catalytic converters versus street value.
- There was a discussion regarding adding civil penalties in addition to criminal penalties for the thefts of restrictive metals.

A motion was made by Committee Member Fox, seconded by Committee Member Shanklin, that this Ordinance be tabled.
