FOR IT COMPUTER UPGRADES (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$6,250 \$10,550 \$13,100 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,500 from District 13; \$1,000 each from Districts 16, 4, 14; \$500 each from Districts 9, 2, 8, 3, 14, 15, 5, 6, 10, 12, 1, 22, 24, 17, 18, 20; \$300 each from Districts 21, 23; \$250 each from Districts 25, 19, through the Office of Management and Budget, to Elderserve, Inc. for IT computer upgrades.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
