The following was discussed:

- This legislation will allow the City of Jeffersontown to create a contiguous area with Kirby Estates, an unincorporated area, which will allow residents to receive public safety and other resources from the City of Jeffersontown.
- There was a discussion regarding the initial request by the residents of Kirby Estates to the City of Jeffersontown.
- There were several questions regarding the infrastructure and drainage work that the Metropolitan Sewer District has conducted in this area.
- There were several questions regarding whether the former residents of Kirby Estates would continue to receive a storm water fee from the Metropolitan Sewer District after the annexation, although, other residents of the City of Jeffersontown do not.
- There were several questions regarding whether Louisville Metro has the authority to require suburban cities to enforce fees assessed by Metropolitan Sewer District after annexations.

- There was a discussion regarding an agreement of understanding between the City of Jeffersontown and the Metropolitan Sewer District to provide drainage for Jeffersontown residents.
- The City of Jeffersontown is a co-permittee with the Metropolitan Sewer District in adherence with the Clean Water Act.
- This agreement with the Metropolitan Sewer District allows the agency to continue to reconcile funds for infrastructure work completed in previously unincorporated areas.
- There was a discussion that although the City of Jeffersontown does not charge residents a drainage fee, it does incorporate the cost associated with drainage within its general fund.
- There were several questions regarding the Metropolitan Sewer District's request that the Metro Council require suburban cities to honor drainage agreements with the agency after annexing an unincorporated area.
- There were several questions regarding whether, pursuant to Kentucky Revised Statutes (KRS) 67C, the Metro Council has the authority to impose mandates on suburban cities.
- There was a discussion regarding a lack of precedence on utility rights under Kentucky annexation law.
- There was a discussion regarding adding a "whereas" clause within the legislation that could address this issue.
- There was a discussion regarding whether annexation is beneficial to Louisville Metro and consistent services throughout if unincorporated areas continue to annex to suburban cities.
- There were several questions regarding whether Louisville Metro has the authority to impose mandates for infrastructure improvements from suburban cities that annex unincorporated areas.
- There was a discussion regarding whether this legislation is time sensitive so further research may be conducted.
- There were several questions regarding whether Louisville Metro and the particular suburban city could create an intergovernmental agreement to address these and similar matters.
- There was a discussion regarding the financial outlay versus benefits between Louisville Metro and the City of Jeffersontown after annexation.
- There was a discussion regarding Kirby Estates residents paying higher tax rates after annexation and receiving additional services.
- There was a discussion regarding the financial analysis and revenue/taxes lost and/or gained between Louisville Metro and the City of Jeffersontown.
