AN ORDINANCE APPROPRIATING \$23,250 \$26,250 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3,000 FROM DISTRICT 6; \$2,250 FROM DISTRICT 9; \$1,875 FROM DISTRICT 15; \$1,500 EACH FROM DISTRICTS 2, 4, 7, 8, 10, 12, 14, 17, 19, 23, AND 26; \$750 EACH FROM DISTRICTS 20 AND 22; AND \$375 EACH FROM DISTRICTS 13, 21, AND 25; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO KENTUCKY SHAKESPEARE, INC FOR THE SHAKESPEARE IN THE PARKS JULIUS CAESAR 2022 TOUR (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of \$23,250 \(\) \$26,250 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 from District 6; \$2,250 from District 9; \$1,875 from District 15; \$1,500 each from Districts 2, 4, 7, 8, 10, 12, 14, 17, 19, 23, and 26; \$750 each from Districts 20 and 22; and \$375 each from Districts 13, 21, and 25; through the Office of Management and Budget, to Kentucky Shakespeare, Inc. for the Shakespeare in the Parks *Julius Caesar* 2022 tour.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
