BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$8,000 \$15,000 \$17,500 is hereby appropriated from District Neighborhood Development Funds as follows: \$5,000 from District 12; and \$3,000 each from Districts 14, 13, and 25; and \$1,000 each from Districts 24, and 15; and \$500 each from Districts 3, 10, and 21, to Metro Parks for expenses associated with the 2014 Riverview Park Independence Festival.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures, Section 3 as adopted by Resolution No. 290, Series 2011.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
