You know what, I think you're right. The money would be accepted by First Neighborhood Place, correct? If it were going through the church we would have to do the larger packet of paperwork I sent you, but if FNP is accepting the money, we shouldn't have to do all of that.

If so, I think your letter and confirmation of your approval in accepting \$1,500 D2 NDF of a total request of \$39,000 NDF for the Back to School festival should work. Dr. Shanklin can then request that the item go on "Old Business" and ask that any other Councilmember that would like to use their NDF funding to help support the event to add on at that time, so that we can get you all as close as possible to your total ask (\$1,500 x 26 = \$39,000.00).

So anyway, my apologies on sending you all of that initially—I had it in my mind that the event was going through an outside organization/the church, but if it's going through First Neighborhood Place, I won't need you to do all of that!

Just confirm with me that that's the case, and I'll get the paperwork in asap—I don't believe that the next available Appropriations meeting is until mid-April, but since we should have everything squared away for that meeting, I'm hopeful that your funding will get through OMB and to you all in time!

Dear Metro Council members,

The First Neighborhood Place is requesting funding for our annual Back to School Festival scheduled for Saturday, July 18th, 2026. We have been doing this event for over 20 years and have given backpacks and school supplies to well over 30,000 kids and families. We have been able to self-support the backpacks and supplies for the past few years. Unfortunately, our funding has been depleted. We are in need of support. We are asking each Metro Council person to donate \$1,500 to the cause.

We anticipate giving out over a 1,000 backpacks and school supplies again this year. Marginalized people of all races and ethnicities attend this event. We usually have well over 2,000 people attend every year. Families will be exposed to various community resources such as: registration to vote, mental health, clothing assistance, health care and much more. This event is a staple of our community and effects families city-wide. We have over 30 surrounding schools who participate in this event as sponsors. Over the years we have had families attend from just about every school in the district.

Without your help and support this year the Back To School Festival event will not be possible. We are asking for a relatively small amount of assistance from each of you in order to make a big impact in our city. As always we thank you for your support.
