Just so everyone knows, an ordinance moving \$15,000 for the D10 Indian Trail Beautification Project is in the process of being moved to Public Works. It was established in the Fy18 capital budget under Develop Louisville. It is my understanding \$4,328 will be used from that account and that if D2 wants to participate they should initiate a CIF for \$11,352. As long as the CIF is initiated within the next two weeks, all the money for this project will be available at approximately the same time - a month from now.

I hope all is well. I wanted to touch base with you again since it is now next year. The folks over in Petersburg and the East Indian Trail area are still asking for bus stops and shelter. Anthony Perry of Petersburg Estates Neighborhood Association called me to follow-up on these items. They need at least a bench on the North side of East Indian Trail at Petersburg (the Metro Council District 10, Councilman Mulvihill, side of the street). Also, they are asking for benches at East Indian Trail and Unseld Blvd and at East Indian Trail and Exeter Ave on the south side of the street (Metro Council District 2, Councilwoman Shanklin, side of the street). The bus stop at Exeter is near the Newburg Library. I wanted to suggest that if/when these benches are installed, if a shelter cannot be installed at this time, but planned for the future, please install a concrete pad that will accommodate a future shelter. Please let us know what is planned for these bus stops so we may relay this to the Neighborhood leaders.
