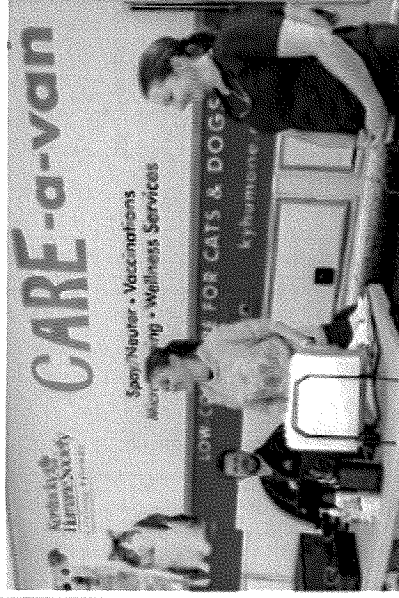
The following vaccines and services will be offered for free:

Amy sponsored a KY Humane Society Care-a-van clinic to have District 25 constituents have access to pet vaccines. I did not understand previously that there was a cost directly to our office, otherwise I would have been proactive in going through the NDF process in advance of the event. We need to ensure we pay \$2,500 to KHS for this event. What is the best way to do this?
