Cindy,

I did inspect 11606 Deering Rd. It's rated a 5. It doesn't look like it's going to settle further in the near future but it's hard to say for sure with these kinda situations. If you are planning to repair this sidewalk I recommend going and ahead and repairing the sidewalk at a nearby neighbor's address as well, otherwise the repair at 11606 Deering Rd is so small it's going to be hard to get a contractor to even consider the work. Here's an estimate for the repair at 11606 and the repairs of a neighbor's sidewalks. The sidewalks at 11610 are rated at least a 4.

I'll go inspect 7011 Nathan Hale Way and provide a rating and estimate within about two weeks.
