

3-Year Paving Program Projected Results

Using a standard rate of degradation for all classifications of road because adequate data do not exist to accurately predict degradation, the following tables show the impact of paving over the next fiscal years.

Table 1:

This is the average PCI for each classification of road at the beginning of each fiscal year based on changes to PCI due to paving projects and applying a rate of degradation to all other roadways. The table shows the positive change to the average PCI as funding has increased.

This table shows the percentage of roads at the beginning of each fiscal year in relation to the goals Public Works established to measure success. The goal for Public Works is to have at least 80% of the arterial and collector roads with a PCI > 55 and no more than 2% with a PCI < 40. The local road goal is to have at least 72% with a PCI > 55 and no more than 10% with a PCI < 40.
