- Clarification on whether this contract consisted of the proposed amendment changes
- If proposed amendment language is not going to be added LMPD supports the contract

A motion was made by Chair Dorsey, seconded by Committee Member Holton Stewart, that this Resolution be amended to add the following:

- "SECTION II: Three percent of all cases per fiscal year shall be randomly peer-reviewed by a forensic physician."
- 3 percent would equal roughly 21 cases per year
- Concerns about case timing

- Review of a presentation from Diana Faugno, Association of Forensic Nurses
- Whether the peer review is done directly after the case is performed or randomly
- 21 cases out of the year will be randomly pulled for peer review
- If LMPD was consulted on this item
- LMPD was not consulted about this matter but the Administration was
- Whether there was a compromise LMPD would be in agreement with
- LMPD would like the opportunity to discuss with UofL and S.A.N.E nurses
- Benefits of peer review
- Wanda Mitchell-Smith discussed this topic with the leadership of LMPD as well as the S.A.N.E nurses
- 3 percent physician review is more feasible, however not preferred contractual agreement considering UofL already utilizes 100 percent peer review by expert S.A.N.E leadership
- An experienced S.A.N.E nurse is qualified to complete the peer review
- UofL currently has a medical director that S.A.N.E nurses consult with in reference to more complicated cases
- Asked for clarification on the amendment
- Question as to how many cases have been proven to have mistakes -- this information is unknown as the cases have not been audited
- Question as to how many cases have went through the court system that errors was discovered in the case -- there has been one case recently within the past month
- Who requested the contract -- the contract is at the request of both LMPD and UofL
- Why this contract was not submitted in the budget -- the contract was not due during that time
- If the contract is currently active -- the contract is expired but S.A.N.E nurses are actively performing the necessary duties
- What the best medical practice recommendations are for handling cases -- third party auditing for peer review of the cases
- Cost for taxpayers for the 3 percent of cases to be peer reviewed -- currently no cost estimate is available
- Requested information for the next committee meeting included the following:
  - Cost estimate of what 3 percent of cases reviewed will look like for tax payers
  - Expert to speak or statement provided regarding peer review
  - Formal statement provided by Dr. Smock, LMPD, and state medical director about what the best practices would be
  - Request for Chief Erika Shields, LMPD, to attend in order to speak to the contract

  - On-going reporting
  - Document review required to receive state reimbursement
  - Appropriately structuring bond debt for projects
  - Running pro forma on tax increment financing ("TIF") and doing an in depth financial analysis to ensure the project
- Most relevant practical experience in dealing with transactions listed above across the Commonwealth
- Much of their work with the agencies consists of the following:
  - Refinancing of certain bonds
  - Various proposed TIF projects
  - Economic impact and feasibility of other large scale real estate ventures
- Whether they provide services for the city only or also business entities needing consultation services
- The contract pertains to services being provided directly to Louisville Forward
- While going through the project, information is received from business entities and Commonwealth Economic Partners LLC, which helps Louisville Forward run through the analysis and financial feasibility of the specific project to confirm eligibility of certain TIF
- Other projects Commonwealth Economic Partners, LLC has worked on, which include the Lynn Family Stadium (Buchertown) and the Louisville Omni Hotel TIF, and any type of large scale project -- additional examples can be

provided

- Whether every TIF is covered that comes before the Metro Council or are they specifically chosen
- Guidance is sought for any TIF considered coming before Metro Council
- If the contract is a "to-not-exceed" amount
- Whether the services as well as the prices for the contract are the same as in 2020 -- all terms of the agreement are the same

- Whether the MORE Center is trying to increase capacity
- Capacity is increased based on an hourly service rate so if capacity is increased it will need to be inside of the listed contract amount
- Over the past two years, what was the impact for the future and outcomes of the MORE Center
- Directing people from the syringe exchange program to a safer medication assistance treatment facility
- The MORE Center capacity is as much as it can handle with the number of current employees
- Expanding from only Methadone use and adding Buprenorphine also as a second service line option, however not yet ready to go live
- Asked for data to be provided of success outcomes
