

ORDINANCE No. 054, SERIES 2015

AN ORDINANCE CHANGING THE STREET NAME CHANGE OF ROCK BLUFF DRIVE TO RIVER ROCK DRIVE AND BEING IN LOUISVILLE METRO (CASE NO. 15STREETS1004).

Sponsored by: COUNCILWOMAN MADONNA FLOOD

WHEREAS, the Louisville Metro Planning Commission, as set forth in the minutes and records of Case No. 15STREETS1004, has recommended to the Legislative Council of the Louisville/Jefferson County Metro Government (the "Council") that the street name change of Rock Bluff Drive to River Rock Drive and being in Louisville Metro be approved due to street changes on revised preliminary subdivision plans; and

WHEREAS, the Council concurs in and adopts the findings of the Planning Commission in Case No. 15STREETS1004 and approves and accepts the recommendation of the Planning Commission as set out in said minutes and records;

NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

**Section I:** That the street name change of Rock Bluff Drive to River Rock Drive as shown on the attached exhibit is approved.


**Section II:** This Ordinance shall take effect upon its passage and approval.

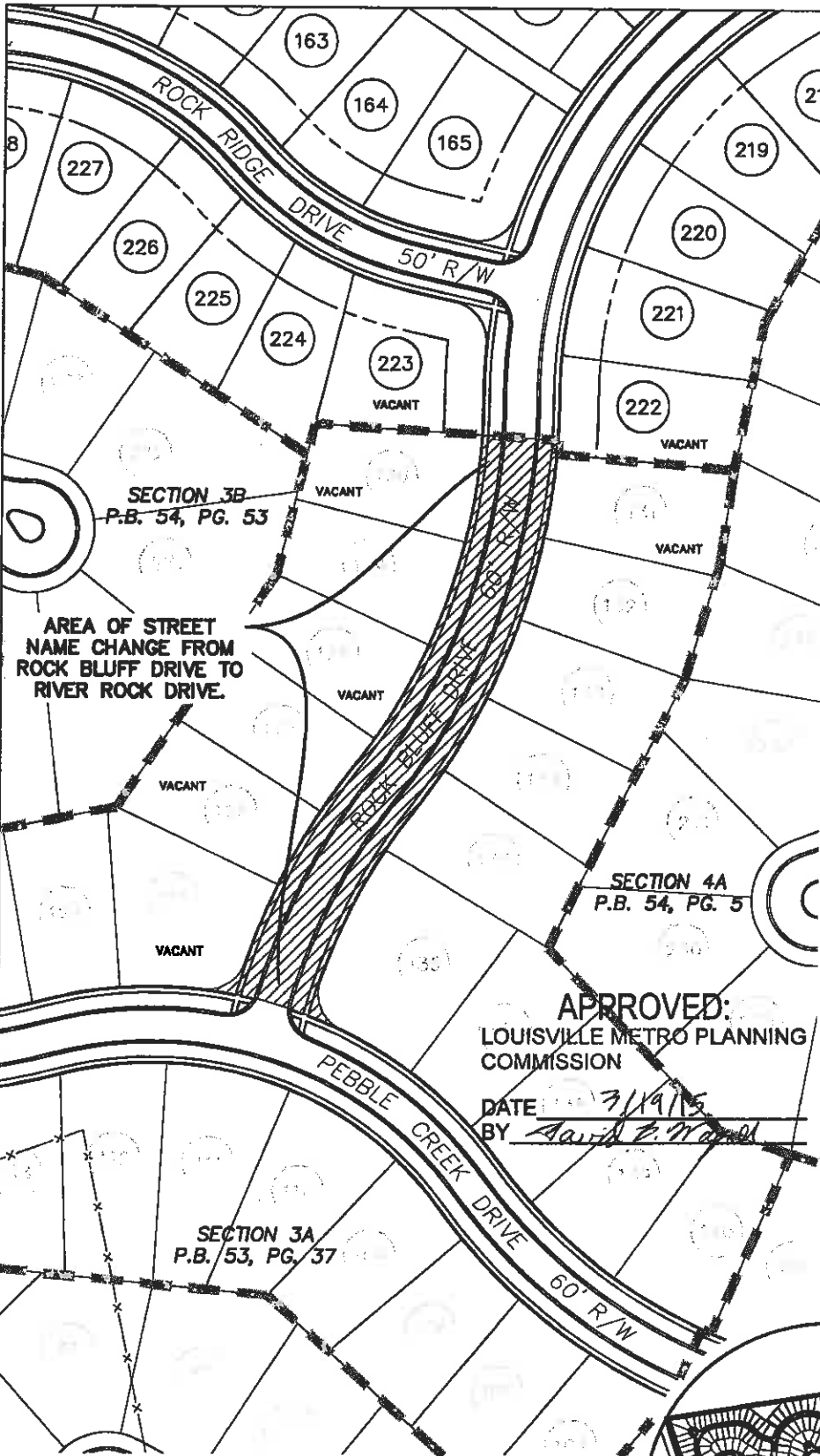

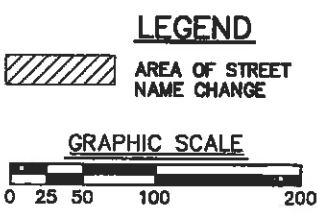
