IT'S THE HIGHEST RECOGNITION AWARD PRESENTED TO LANDOWNERS BY A LOCAL SOIL AND WATER CONSERVATION DISTRICT FOR INDIVIDUAL LAND AND STEWARDSHIP EFFORTS. LESS THAN 2% OF PRIVATE LANDOWNERS ARE RECOGNIZED AS MASTER CONSERVATIONISTS. TO QUALIFY THEY MUST HAVE COMPLETED 90% OF THEIR SOIL AND WATER CONSERVATION PLAN IN THEIR CONTROL. IF NOT ALL OF THEIR LAND BASED NATURAL RESOURCE ARE PROTECTED FROM SERIOUS DEGRADATION AND MANAGED FOR SUSTAINABILITY THE CONSERVATION PRACTICES AND MANAGEMENT TECHNIQUES ARE MODELED AND -- THIS YEAR THE -- AWARD IS FOR THE RAISING HOPE ORGANIC FARM OWNED BY RAMSEY. A 4-ACRE PARCEL -- A 14-ACRE PARCEL. THE SMALL FARM BOARD -- CERTIFIED AS ORGANIC BY THE KENTUCKY DEPARTMENT OF AGRICULTURE. SET ASIDE FOR GROWING VEGETABLES, ORCHARD AND GRAZING AREAS. ONE OF THE FIRST PARTICIPANTS IN JEFFERSON COUNTY TO USE THE USDA EQUIPPED PROGRAM TO CONSTRUCT A CLASTIC COVERED HOOP HOUSE FOR VEGETABLE PRODUCTION. MARY'S ACADEMY IN COUNCIL MEMBER REED'S DISTRICT. THEY HAVE A VARIETY OF LOVES AND ACTIVITIES THEY PARTICIPANT IN. CECILIA HAS BEEN STUDYING PIANO FOR SEVERAL YEARS. PLAYED SOCCER FOR MULTIPLE YEARS. EXCELS IN MATH AND HOPES TO ONE DAY TAKE A CAREER THIS APPLIES HER MATH SKILLS. I'M

CROSSING MY FINGERS FOR ENGINEERING. BESIDE THIS. WE CALL OURSELVES THE RENEWABLE ENERGY ALLIANCE OF LOUISVILLE. REAL. WE HAVE RESEARCHED AND DEVELOPED A DETAILED PROPOSAL FOR A GRADUAL TRANSITION. RENEWABLE ELECTRICITY FOR THE CITY OF RATIONS BY 2030. ALL ENERGY FOR CITY OPERATIONS BY 2035, AND ALL FORMS OF ENERGY FOR THE ENTIRE COMMUNITY BY 2040. 130 OTHER CITIES HAVE PASSED VERSIONS OF THIS RESOLUTION. INCLUDING ATLANTA, CINCINNATI, NASHVILLE, INDIANAPOLIS, AND CHICAGO. IN THE 10 MONTHS SINCE WE'VE BEEN WORKING ON THIS PROPOSAL, THE ART'S -- EARTH'S ATMOSPHERE HAS CLIMBED FROM 412 -- AND THERE HAVE BEEN MORE FLOODS, MORE HURRICANES AND MORE FIRES.  MY NAME IS CONNOR ALLEN I LIVE IN THE OAK DALE NEIGHBORHOOD. I

 AM HERE TO DISCUSS THE ORDINANCE OF PANHANDLERS. THIS ORDINANCE

WILL ONLY LEAD TO MORE PAIN AND MISERY FOR THE MOST VULNERABLE AND OPPRESSED PEOPLE IN OUR CITY. IF WE WANT TO BE A COMPASSIONATE CITY AS WE CLAIM, I URGE THE COUNCIL TO REJECT THIS ORDINANCE. THIS WILL DO NOTHING TO INCREASE PEDESTRIAN SAFETY. PEDESTRIAN ARE NOT GOING TO CHANGE THEIR BEHAVIOR BECAUSE THE COUNCIL PASS -- PASSES AN ORDINANCE THAT WILL FINE THEM. DO YOU REALLY THINK THE SINGLE MOTHER WITH KIDS IN TOW THAT HAD TO RIDE THE BUS TO GET GROCERIES IS GOING TO CONSIDER SHE MIGHT BE FINED TO CROSS THE ROAD INSTEAD OF WALKING A THOUSAND FEET IN 100 DEGREE HEAT TO THE NEXT CROSSWALK. I DON'T THINK SHE WILL. THE NUMBER OF DEATHS THAT HAPPEN ON THE ARTERIAL RODE ROADWAYS HAPPEN IN THE MIDDLE OF THE NIGHT. DO YOU THINK -- BECAUSE THEY MIGHT GET FINED? NO THEY AREN'T. IF YOU PASS THIS ORDINANCE, IT'S JUST GOING TO END UP SQUEEZING MONEY OUT OF BLACK PEOPLE AND POOR PEOPLE. IF YOU DON'T THINK THIS ORDINANCE IS GOING TO BE OVER ENFORCED AGAINST BLACK COMMUNITY TO. YOU'RE KITING YOURSELF. IN SACRAMENTO BLACK PEOPLE WERE FIVE MORE TIMES LIKELY TO BE CITED THAN WHITE PEOPLE. IN SEATTLE WHERE BLACK PEOPLE MAKE UP 7% OF THE POPULATION 28% OF THE CITATIONS WERE AGAINST BLACK PEOPLE. IN JACKSONVILLE BLACK PEOPLE WERE THREE TIMES MORE LIKELY TO BE TICKETED FOR JAYWALKING AND -- I KNOW IT'S DIFFICULT TO UNDERSTAND WHAT IT'S LIKE NOT TO HAVE A CAR TO RELY ON BUS, BICYCLES AND YOUR FEET FOR WALKING, BUT WE HAVE AN UNSAFE CITY. WE HAVE ATROCIOUSLY

DANGEROUS DESIGN. FROM A PRACTICAL PERSPECTIVE, IF WE REALLY WANT TO IMPLEMENT EVIDENCE-BASED PRACTICES, WE NEED MORE TRAFFIC CONTROL AND PEDESTRIAN FRIENDLY URBAN DESIGN. AS FAR AS PANHANDLING IS CONCERNED, WE CAN PAT OURSELVES ON THE BACK FOR THROWS \$500,000 IN HOMELESSNESS RESOURCES. I KNOW MONEY IS TIGHT. THAT'S 5% WE GIVE TO THE YOUNG CENTER EVERY YEAR.

ONE-THIRD OF 1% WE GAVE TO THE OMNI. I DON'T THINK WE FOLLOWED ANY OF THE RECOMMENDATIONS OF THE MAYOR'S TASK FIRST AND WHAT IS GOING TO HAPPEN WHEN WE FIND A PANHANDLER? ARE THEY GOING THE GET A COURT DATE AND SHOW UP AND PAY THE FINE. ALL WE'RE GOING TO END UP DOING IS LOCK UP PEOPLE BECAUSE THEY'RE HOMELESS.

TO PROSECUTE TO THE FULLEST EXTENT. DRUG DEALERS IF YOU WANT TO

SELL HEROIN IN LOUISVILLE 20 TO LIFE. WE NEED TO GET TOUGH. WE NEED TO HIT IT HEAD ON. THIS CITY IS RIDDLED. HE SMOKE ABOUT HOMELESS -- SPOKE ABOUT HOMELESSNESS. WHY ARE SO MANY PEOPLE BEGGING FOR MONEY? MONEY -- NUMBER ONE THEY HAVE A DRUG PROBLEM AND THEY KNEE JESUS. I WILL SAY THIS. I THINK THAT WE NEED NEW LEGISLATION. I WANT TO ASK -- I THINK WE NEED KENTUCKY [INDISCERNIBLE] AND WE NEED TO GET STIFFER AND YOU HAVE TO. YOU WANT TO SELL DOPE HERE, GO TO THE PENITENTIARY. WE'LL PROSECUTE YOU. 20 TO LIFE. WE'RE NOT GOING TO PLAY GAMES ANYMORE. WE'RE TOO EASY ON DRUG DEALERS. IF WE NEED TO BUILD BIGGER PRISONS, GREAT. I WAS IN ORLANDO ON MINISTRY. THEY HAVE 6,000 PERSON JAIL THERE. WE NEED A BIGGER. WE NEED -- JAIL. WE NEED A BIGGER JAIL. AT LEAST 4500 SO THERE'S NO MORE JAIL OVERCROWDING AND DON'T CUT PEOPLE OUT. BUILD A BIGGER JAIL. WE NEED MORE FEDERAL FUNDING. WE NEED TO STEP IT UP ON NAP AND WE NEED TO HELP THE HOMELESS. THE PEOPLE. CENTER STONE HEELING -- HEALING PLACE THEY'RE PACKED. WE'RE NUMBER ONE WE GO AFTER DRUG DEALERS. WE MAKE WAR ON DRUGS. THE LARGEST INDOOR FAIRGROUNDS IN THE UNITED STATES. THIS LAST MONTH JULY, THIS MONTH NOW. WE HAVE 29,000 BASKETBALL PLAYERS AND 4,000 ESPN COACHES HERE. WE HAD 129,000 KIDS SKILL CRAFTS HERE. AND WE HAD 9,000 WHEELCHAIR PEOPLE AT OUR CONVENTION CENTER. THESE ARE

THE FIRST ONES IN THE UNITED STATES. AND 311. THESE PEOPLE THAT ARE SITTING ON THE STREET. PEOPLE [INDISCERNIBLE] TWICE. PEOPLE ARE FAKING THEIR WHEEL CHAIRS. ONE GIRL, I'M SORRY I MADE YOU MAD. PEOPLE IN THEIR WHEELCHAIR ARE NOT REALLY IN THEIR WHEELCHAIR. MY FATHER WAS A PARAPLEGIC FROM A -- THE POLICE. I KNOW WHAT A WHEELCHAIR IS. IN -- I HAD TO HELP TAKE CARE OF MY DADDY. PEOPLE ARE WALK OUT OF THESE WHEEL CHAIRS AND ASKING PEOPLE FOR MONEY. PEOPLE ARE ON DISABILITY. I TALKED TO A COUPLE OF THESE PEOPLE. I ASKED THEM. WHY ARE YOU NOT GOING TO HUD OR SECTION 8. THEY DON'T KNOW ABOUT METRO CALL 211. WE'RE NOT A STATE. WE'RE A COMMONWEALTH. THERE'S PEOPLE BACK HERE KNOW YOU GET FREE HEARING AIDS, FREE EYEGLASS AND FREE MEDICINE. THIS IS THE UNITED STATES OF AMERICA. WORK THE ELECTIONS AND GET \$200. AT MY BOOTH AT THE STATE FAIR, I TELL THE PEOPLE. AND

THESE PEOPLE HAVE FAKE SIGNS AND GET OUT OF THEIR CHAIRS AND WALK AWAY. THIS HAS MADE US LOSE CONVENTIONS. IN OCTOBER WE GOT 300 THOUSAND KIDS COMING HERE FOR FAA FOR THE NEXT FOUR YEARS.

I'M ON THE CONVENTION BOARD. THEY SEND IT TO ME EVERY MONTH. WE GOT FOUR MORE HOTELS GOING UP DOWNTOWN. FOUR MORE. IS THAT MEAN WE'RE GOING TO HAVE FOUR MORE WARMER PLACES FOR PEOPLE TO BE?

NO. THEY DON'T HAVE A TICKET, THEY HAVE FOOD STAMPS. THEY DON'T HAVE FOOD STAMPS, THEY CAN DO LABOR ON THE HIGHWAY.

BELIEVE ALL COPS ARE BAD COPS. WHEN THE INTEGRITY OF AN
REPRESENTABLE JUDGE IS -- BY OFFICES WHO BELIEVE THEY ARE ABOVE
THE LAW THE INTEGRITY OF THE ENTIRE JUDICIAL SYSTEM SHOULD BE IN
QUESTION. [INDISCERNIBLE] I BELIEVE POLICE OFFICERS ACT
OUTSIDE THE SCOPE OF THE LAW BY FALSIFYING SEARCH WARRANTS TO
ILLEGALLY PERFORM [INDISCERNIBLE] TO WRONGLY CONVICT OF DRUG
CRIMES. [INDISCERNIBLE] TO ENSURE THE SAFETY, SECURITY AND
TRUST BETWEEN ORDINARY CITIZENS AND THE OFFICERS WHO HAVE SWORN
TO SERVE AND PROTECT THEM. ON APRIL 27, 2017, MY HOME WAS
ILLEGALLY INVADED BY LMPD WHO [INDISCERNIBLE] I WAS IN

AT HIM MULTIPLE TIMES WHEN ALL HE DID WAS TRY TO GET TO MY
16-YEAR-OLD DAUGHTER WHO WAS SCREAMING BEFORE SHE WAS SHUT INTO
HER ROOM COMPANIED BY FIVE [INDISCERNIBLE] AT GUNPOINT. I

WARNED HIM ABOUT [INDISCERNIBLE] AND THEY RADIOED UPSTAIRS AND ONE OF THE AGENTS OF MY AUTISTIC SON WHO WAS ALSO SHOT -- I WAS MADE TO BE MAKE A -- [INDISCERNIBLE] FROM MY EXPOSED BODY. MY DAUGHTER WAS HELD AT GUNPOINT TO HER HEAD, FLOCKED HER ROOM WHILE THEY TOLD ME SHE WAS NOT IN THE HOUSE FOR AT LEAST 30 MINUTES. ALONG -- A LONG STORY SHORT I CALLED FOR MONTHS TO OBTAIN SEARCH WARRANT AND GIVEN THE RUN AROUND. I [INDISCERNIBLE] I NOTICED IT DID NOT HAVE ANY PROOF OF [INDISCERNIBLE] SO I CALLED THE JUDGE'S OFFICE WHOSE SIGNATURE WAS ON IT AND TOLD BY HER SECRETARY SHE DID NOT SIGN IT THAT LED ME TO DO FURTHER RESEARCH -- THAT THE COURT DID NOT HAVE A TRUE COPY NOT VERBATIM. WITH THE EXCLUSION OF SOME AREAS WHERE THE COMMISSION IS REPRESENTING A CERTAIN GEOGRAPHY OF JEFFERSON COUNTY. BUT THIS ONE IS IMPORTANT AS WELL. LY DO THE SAME I WILL DO THE SAME REPRESENTING -- IN ADDITION TO THIS DOCUMENT WHICH SHOWS YOU THAT WE AREN'T FULFILLING THE REQUIREMENT BY HAVING DIVERSITY OF POLITICAL AFFILIATION. IF YOU GO TO, AND THE SYSTEM IS MOVING SLOW. IF YOU GO TO THE APPLICANTS FOR THE BOARD, WHICH IS ANOTHER ONE OF THE DOCUMENTS, YOU'LL SEE THERE WERE FOUR APPLICANTS FOR THIS POSITION. TWO DEMOCRATS AND TWO REASONS. THE ADMINISTRATION -- REPUBLICAN, THE ADMINISTRATION HAD TWO APPLICANTS FOR THIS POSITION WHO WOULD HAVE, EITHER OF WHICH WOULD HAVE FULFILLED THE POSITION AND EVEN IF, I WANT TO MAKE THIS POINT CLEAR AS WELL. EVEN IF, I DON'T NEEDS KNOW THESE TWO APPLICANTS. MR. HALL AND MR. ASHTON FROM DISTRICT 7 OR DISTRICT 18. I DON'T KNOW THEM PERSONAL. I WILL DON'T KNOW THEIR QUALIFICATIONS AND MR. MR. WATSON HAS BETTER QUALIFICATIONS. I'M GLAD TO ENTERTAIN THESE TOPICS. THE CATCH IS, IF THE ADMINISTRATION IS SEEING THAT THEY ARE NOT FULFILLING ONE OF THE AREAS THAT THEY'RE STATUTORILY REQUIRED TO HAVE DIVERSITY, I WOULD EXPECT THEY COME TO THE METRO COUNCIL AND ASK FOR ASSISTANCE AND APPLICANTS. I'VE DONE SO IN MY NEWS LETTER AND

SPEAKING EVENTS. I -- WE'VE SEEN UP TICK IN PEOPLE APPLYING.

GLAD THAT AND HELPING THE ADMINISTRATION GET MORE QUALIFIED

APPLICANT. THAT IS NOT THE DUTY OF THE ADMINISTRATION AND THE TO

ENSURE THIS IS FOLLOW LOUD.

- >> PRESIDENT JAMES: COUNCIL MEMBER FLOOD.
- >> THANK YOU. DURING ONE OF THE MEETINGS I ASKED ABOUT THE SECOND SHEET HE IS REFERRING TO THAT SHOWS PEOPLE WHO HAVE APPLIED FOR THOSE. ALTHIA SAYS IT'S NOT A DOCUMENT SHE SUPPLIES. SHE DOESN'T KNOW WHERE THEY COME FROM. THE REASON I QUESTION ACCURACY IS BECAUSE I STARTED NOTICING PEOPLE WHO HAD BEEN APPOINTED ON THE BOARD WHO HAD BEEN THERE TWO YEARS, WHY WOULD THEY REAPPLY FOR REAPPOINTMENT WHEN THEIR POSITION IS NOT EVEN UP. ONE WOMAN WHO SUPPOSEDLY LIVED IN MY DISTRICT HAS NOT LIVE MADAM MY DISTRICT FOR EIGHT YEARS BECAUSE I KNOW THEM PERSONALLY BUT THEIR NAME APPEARS AS IF THEY'RE IN THE SAME DISTRICT. THEY HAVEN'T IN EIGHT YEARS. I DON'T KNOW WHERE THAT LIST IS COMING FROM. IT COULD BE A BIG LIST ADDED ON FOR YEARS. BUT WE DID NOT WHERE WE WERE GETTING THAT LIST FROM. THOUGHT I WOULD BRING IT TO LIFE.
- >> THANK YOU. I WOULD SAY THAT BOLSTERS MY ARGUMENT THAT WE NEED TO QUESTION THIS WHOLE PROCESS. IF WE CAN'T EVEN TRUST THE DOCUMENTS BEING PRESENTED TO US AND THE VASTY OF IT. THIS IS APPLICANTS FOR BOARD. I HAVE TO ASSUME THESE ARE THE CURRENT APPLICANTS FOR THIS BOARD. IF THAT'S NOT, IF THAT'S NOT ACCURATE

OR IF THERE'S A LIST THAT'S INACCURATE THAT IS BEING PRESENTED FOR DOCUMENTS FOR THIS. THIS NEEDS TO BE OUESTIONED. AND OUITE FRANKLY, MY POINT IS ALSO, EVEN IF THE CURRENT APPLICANTS FOR THE BOARD WHICH DOESN'T SEEM TO BE AS SUCH IF I TRUST THE DOCUMENT I HAVE. WE'RE ALL DEMOCRATS IN THIS CASE. OR IF THERE WERE ONLY MEN ON A BOARD AND ONLY MALE APPLICANTS TO THAT BOARD, IT WOULD BEHOOVE THE ADMINISTRATION AND THINK ABOUT THAT SCENARIO. ALL MALE CURRENT APPOINTEES ON A BOARD, AND ONLY MEN A -- SUBMITTED APPLICATIONS TO THAT BOARD. IT WOULD BE INCUMBENT UPON THE PROSECUTION TO WORK AND PARTNER -- THE ADMINISTRATION TO WORK AND PARTNER TO FIND QUALIFY FEMALE APPLICANTS. THAT IS WHAT THE LAW REQUIRES AND A STEP THAT SHOULD BE TAKEN BEFORE WE VIOLATE THE SPIRIT OF THE LAW WHICH IS TO HAVE THE DIVERSITY ON THESE COMMITTEES. WHETHER THE DOCUMENT IS RIGHT OR NOT. I HOPE THEY ARE IN FUTURE AND WE NEED TO LOOK AT THAT PART OF THE PROCESS AS WELL. EITHER WAY THAT IS WHAT IS REQUIRED. THAT IS WHAT WE SHOULD BE FOCUSED ON.

>> PRESIDENT JAMES: THANK YOU. TO ADD A BIT OF CLARITY YOU I WILL CALL ON THE CLERK TO EXPLAIN THE DOCUMENT.

>> MR. CLERK: THE DOCUMENT THAT YOU SEE UNDER ITEM 60 THESE ARE DOCUMENTS THAT THE CLERK CREATE AND WHEN I SAY CREATE, IT MEANS WE TAKE THE INFORMATION THAT IS PROVIDED BY THE APPLICANT AND THE MAYOR'S OFFICE. ALL WE DO IS TAKE THE BOARDS AND COMMISSION SYSTEM AND COME PILE THAT INFORMATION. THAT IS -- WE

GENERATE THAT REPORT THAT IS COMPILED BY THE APPLICANTS' ENTRIES AND THE MARE'S OFFICE.

- >> PRESIDENT JAMES: THANK YOU. COUNCILMAN COAN.
- >> THANK YOU. I WILL FIRST SAY, I SUPPORT COUNCILMAN PIAGENTINI'S EFFORT TO ENSURE THAT WE HAVE DIVERSITY ON OUR BOARDS. I AM GOING TO VOTE YES TO AFFIRM DR. WATSON. I WILL BE TO JOIN YOU, COUNCILMAN PIAGENTINI WRITING A LETTER OR GETTING INVOLVED TO DO SOMETHING AFFIRMATIVE ADDRESS THE ISSUE. INSTEAD OF A NO VOTE HERE. I THINK, WE WANT TO HAVE DIVERSITY ON OUR BOARD. HUMAN BEINGS ARE VERY COMPLEX. I'M LOOKING AT THESE FOUR PEOPLE OUT OF THE ROWS INSTEAD OF THE COLUMNS. AS I LOOK AT THE ROWS BASED ON WHERE THESE PEOPLE LIVE AND THEIR ETHNICITY AND GENDER AND POLITICAL PARTY, IT PRESENTS TO ME AS FOUR DIVERSE PEOPLE REGARDLESS OF IF THEIR A REPUBLICAN OR NOT. DEMOCRATS HERE AND DEMOCRATS HERE AND REPUBLICANS HERE AND I AM LOOK AT THE FOUR PEOPLE. I'M NOT SURE ANY OF THESE FOUR PEOPLE LIVE ANYWHERE WHERE THERE'S A MARKING -- A PARKING METER IN THEIR DISTRICTS. I CAN'T SAY THESE ARE THE FOUR BEST CHOICES TO BE ON THIS BOARD. I'LL BE HAPPY TO JOIN YOU IN ANOTHER KIND OF PROACTIVE EFFORT TO ADDRESS THIS.

>> ECHO COUNCILMAN COAN'S COMMENTS AND WE SHOULD STRIVE FOR DIVERSITY. IT CUTS ACROSS MULTIPLE FACTORS. TWO, IT'S DIFFICULT WHEN YOU HAVE A BOARD OF ESSENTIALLY FOUR. TO THEN SAY, THIS BOARD SHOULD HAVE PROPORTIONAL REPRESENTATION OF EVERY SUB CATEGORY. TO ME SORT OF THE SPIRIT OF THE LAW IS MORE SYSTEMWIDE THAN ANY ONE PARTICULAR BOARD. I UNDERSTAND COUNCILMAN PIAGENTINI HAVING MADE THIS ARGUMENT ON MULTIPLE APPOINTMENTS THAT THE ARGUMENT IS SYSTEMWIDE. I JOIN COUNCILMAN COAN IN BEING HAPPY TO SEND A LETTER TO THE ADMINISTRATION AND ARGUE FOR THAT DIVERSITY IF YOU FEEL SYSTEMWIDE IT'S UNDER REPRESENTED. AGAIN, IT'S -- I TEND TO FEEL LIKE DIVERSITY IS MULTIFACETED.

- >> PRESIDENT JAMES: THANK YOU. COUNCILMAN ENGEL.
- >> THANK YOU. THIS IS NOT NEW. THIS PROCESS HAS BEEN GOING
 ON DOWNTOWN FOR A LONG TIME. I'VE MADE POSITIVE COMMENTS IN
 COMMITTEE ABOUT MY COLLEAGUE, COUNCILMAN BLACKWELL, WHO IS A
 LEADER FOR MANY YEARS IN MAKING STATEMENTS ABOUT THIS PROCESS.
 SO TO MY COLLEAGUE, COUNCILMAN COAN, IT ISN'T A SURPRISE TO ALL
 OF A SUDDEN HAVE A CANDIDATE THAT WE'RE GOING TO CONSIDER A
 NO-VOTE. THAT'S NOT A SURPRISE. BECAUSE COUNCILMAN BLACKWELL HAS
 DONE THIS. HE'S DONE IT, AND HE DID IT FOR A LONG TIME FOR A
 VERY GOOD REASON, AND A PURPOSE. HE WANTED DIVERSITY. HE WANTED
 THIS WHOLE COMMUNITY TO BE INVOLVED AND NOT JUST ONE PARTICULAR
 DISTRICT GETS FIVE APPOINTEES. SO I FOLLOWED COUNCILMAN

SYSTEM. AND HE SEES A REAL PROBLEM. SO I THINK, WHAT A GREAT

OPPORTUNITY FOR THIS COUNCIL TO COME TOGETHER AND FINELY SAY,

- >> THERE MR. PRESIDENT. ULTIMATELY WE'RE THE BODY THAT
 APPROVES OR DISAPPROVES. WHAT BETTER TIME, IT MIGHT BE RIGHT OR
 WRONG, THAN RIGHT NOW. IT'S CLEAR TO ME THAT EVEN THOUGH I DON'T
 KNOW THIS APPLICANT PERSONALLY THAT THERE WASN'T A LOT OF
 THOUGHT PUT INTO THIS. AND THERE WAS NO DIVERSITY IN TERMS OF
 POLITICAL AFFILIATION THAT WAS GIVEN ANY CONSIDERATION. I KNOW
 ONE OF THE APPLICANTS THAT WAS NOT CHOSEN AND SEEMS TO ME HE'S

- >> COUNCILMAN PIAGENTINI WAS NEXT.
- >> PRESIDENT JAMES: HE'S BEEN TALKING. I'LL GIVE YOU THE OPPORTUNITY. [LAUGHTER]
- >> THANK YOU, MR. PRESIDENT. I'LL TAKE IT INTO

 CONSIDERATION WHAT COUNCILMAN PIAGENTINI STATED AS WELL AS

 COUNCILMAN ENGEL. I'M JUST CONCERNED WITH THE LACK OF DIVERSITY

 AND I WONDER WHAT WILL THE DAY BE LIKE WHEN WOMEN ARE EXCLUDED?

 AFRICAN-AMERICANS EXCLUDED OR ANY OTHER RACE OR POLITICAL

 AFFILIATIONS WOULD BE EXCLUDED. SO I CAN SAY THAT I'M NOT VOTING

 YES. I DON'T KNOW IF I'M VOTING NO OR PRESENT BY WILL NOT BE

 VOTING YES FOR THAT REASON. I WANT TO GO ON RECORD AS STATING

 THAT.
 - >> PRESIDENT JAMES: THANK YOU.
- >> I HAVE MIXED EMOTIONS ABOUT THIS. ONLY BECAUSE I FEEL IT WOULD NOT BE FAIR THIS TO YOUNG MAN. I DON'T KNOW WHO HE IS. I DON'T KNOW HIM PERSONALLY. HE HAS COME BEFORE US HAVE TO -- I WOULD HAVE TO ASSUME HE IS QUALIFIED AND IT LOOKS AS IF HE IS. I DO WANT TO SAY THAT WHILE I WILL BE A YES VOTE, I CERTAINLY UNDERSTAND WHERE YOU'RE COMING FROM, MY COLLEAGUE, COUNCILMAN PIAGENTINI. AND I THINK WE DO NEED TO LOOK INTO THIS. - >> THANK YOU FOR YEARS I DID WORK ON GEOGRAPHIC DIVERSITY, HAVING LET GO OF THAT. YOU KNOW HOW THINGS COME AND GO IN TERMS OF WHAT YOU PUT YOUR EFFORTS INTO. I DO APPRECIATE COUNCILMAN PIAGENTINI'S APPOINTING THIS OUT AS WELL. FOR A NUMBER OF YEARS I WOULD TAKE THAT SAME VOTE -- I WOULD LIKE TO ALSO SUGGEST IN TERMS OF THE PROCESS, I THINK WE'RE MISSING A PIECE OF THE PROCESS. SO IN THE TWO -- PAST TWO WE HAD THE MARE'S REPRESENTATIVE -- MAYORS REPRESENTATIVE SPEAK TO THOSE COMING BEFORE US AND WE -- FOR WHATEVER REASON WE'RE NOT DOING THAT. - >> I SHARE COUNCILMAN PIAGENTINI FRUSTRATION. I SHARED APPOINTMENTS FOR TWO YEARS. IT'S BEEN MANY YEARS WITH COUNCIL MEMBER DONERED AND DENTON BEATING OUR HEADS AGAINST WALL WITH THIS PROCESS. I HAVE CONCERNS OF US IDENTIFYING A RANDOM INDIVIDUAL AND MAKING AN EXAMPLE OF THIS PERSON. I DO KNOW DR. WATSON PERSONALLY. HE IS HIGHLY QUALIFIED. A DEDICATED MEMBER OF THIS COMMUNITY, AN AFRICAN-AMERICAN, DENTIST IN WEST LOUISVILLE WHO MY FAMILY MEMBERS ATTEND HIS PRACTICE AND OWNS A HOME FOR INDIVIDUALS THAT ARE DISABLED. HE HAS A MOBILE DENTIS VAN THAT HE TAKES AROUND TO DISENFRANCHISED NEIGHBORHOODS TO HELP AND ASSIST INDIVIDUALS. WHILE I SHARE THE FRUSTRATION AND THE CONCERN, THIS INDIVIDUAL IS MORE THAN QUALIFIED AND HAS DEMONSTRATED HE IS -- HIS COMMITMENT TO THE COMMUNITY BY WILL BE TO SERVE ON THE BOARD IN DEMONSTRATIVE WAYS THROUGH OUT THE [INDISCERNIBLE] MY VOTE WILL BE YES FOR DR. WATSON TONIGHT. THANK YOU.
 - >> PRESIDENT JAMES: THANK YOU. COUNCILMAN HOLLANDER.
- >> I ECHO WHAT COUNCILMAN WINKLER SAID. THERE'S MULTIPLE
 WAYS TO DETERMINE DIVERSE WE HAVE HERE A QUALIFIED

 AFRICAN-AMERICAN CANDIDATE. THE TWO REPUBLICAN APPLICANTS, IF
 THEY ARE APPLICANTS ARE CAUCASIAN. WE WOULD BE TAKING
 THIS -- TAKE APPARENTLY. I DO NOT KNOW DR. WATSON BUT I RESPECT
 COUNCILWOMAN GREEN VIEWPOINT. AND REPLACE THEM WITH A CAUCASIAN
 REPUBLICAN. I THINK THAT FOCUSING ON THAT ONE ASPECT IS

>> PRESIDENT JAMES: THANK YOU. COUNCILMAN PIAGENTINI.

>> A COUPLE THINGS, FIRST OF ALL, ALTHOUGH DIVERSITY COMES IN A VARIETY WAYS THE ONES THAT ARE STATUTORILY REQUIRED FOR THE -- SPELLED OUT. RACE IS ONE OF THEM. YOU'RE RIGHT. IT'S NOT ABOUT, YOU KNOW, IF WE'RE DOING COUNTS, RIGHT, THERE'S ANOTHER CURRENT BOARD MEMBER WHO IS AFRICAN-AMERICAN. IT'S NOT ABOUT COUNTING. THERE'S 50% OR 25% OR ANYTHING. IT'S ARE THERE ANY. THERE ARE 0%. ZERO REPRESENTATION. MY OTHER RESPONSE FOR COUNCILMAN COAN A POLITICAL PARTY BEING A -- I TOTALLY DISAGREE. YOU DIDN'T RUN AS A REPUBLICAN. YOU RAN AS A DEMOCRAT. RIGHT? THAT MEANT SOMETHING TO YOU. RIGHT? THAT EMBODIES A BELIEF SYSTEM, A VALUE SYSTEM. IT EMBODIES A PLATFORM YOU CHOSE AND THAT'S GREAT. NO PROBLEM WITH THAT. JUST LIKE I CHOSE TO RUN AS A REPUBLICAN. THERE -- IT MEANS SOMETHING. IT DOESN'T MEAN EVERYTHING. BECAUSE WE ARE COMPLICATED HUMAN BEINGS. BUT IT DOES MEAN SOMETHING. I THINK AT ONE POINT WE HAVE TO BE PREPARED TO EXERT MORE PRESSURE THAN LETTER WRITING OR SUGGESTION TO THE ADMINISTRATION BECAUSE QUITE FRANKLY AS COUNCILWOMAN GREEN SAID AND COUNCILMAN BLACKWELL SAID THERE'S YEARS DEDICATED TO THIS EFFORT AND WE'RE STILL NOT THERE. WHAT DOES THAT TELL US ABOUT THE EFFORT SO FAR? THANK YOU.

- >> PRESIDENT JAMES: COUNCILWOMAN PARKER.
- >> I SAT ON THIS COMMITTEE FOR SEVERAL YEARS. AND BEING IN A MINORITY PARTY, YOU DO LOOK OUT FOR YOUR PARTY TO MAKE SURE THERE'S THE DIVERSE. I WILL SAY THAT DIVERSITY BETWEEN PARTIES YOU MAY HAVE A MALE AND FEMALE AND THEY THINK JUST ALIKE. YOU MAY IS A BLACK PERSON AND A WHITE PERSON. AND THEY THINK JUST ALIKE. BUT TO COUNCILMAN PIAGENTINI'S POINT. WHEN YOU DO ASSOCIATE YOURSELF A POLITICAL PARTY, YOU WOULD LIKE FOR YOUR CITY TO BE RENTED ON -- REPRESENTED ON THESE BOARDS AND COMMISSIONS WITH NOT JUST RACE OR GENDER, OR WHAT NOT. I DON'T SEE THOSE AS THE BIG DIFFERENCES. I DON'T SEE THAT WHERE THE BIGGEST DIVERSITY IS. AND YOU SEE IT IN IDEALOLOGY AND REPRESENTED BY THE FOLKS THAT LIVE HERE. THERE WAS ONE FRUSTRATING APPOINTMENT. I HAD A VERY QUALIFIED
GENTLEMAN THAT HAD A RESUME FIVE MILES LONG, DIDN'T MAKE THE
APPOINTMENT WHICH EVERYONE WOULD THINK THAT HE WOULD AND ANOTHER
PERSON THAT WASN'T EVEN ON THE APPLICANT BOARD ACTUALLY GOT
APPOINTED. AND I KNEW THAT PERSON AND CALLED THEM UP AND THEY

>> FOR GETTING READY FOR THE DISCUSSION, OUR LOVELY PAGES
PASSED OUT A REFERENCE EARLIER. THIS DOCUMENT YOU CAN SEE HERE.
SAYS SEE MCOAN. AND ON THE LAST PAGE IS THE RECKING ORDINANCE WE
PASSED LAST YEAR IN THIS COUNCIL. I WANT PEOPLE TO HAVE THAT
HANDY IN CASE THEY REFERENCE IT. PRESIDENT JAMES CREATED AN AD
HOC COMMITTEE ON LAND MARKS FOR THIS CALENDAR YEAR. TO ACCEPT
RECOMMENDATIONS FROM THE LAND MARKS COMMISSION ITSELF THAT SPENT

THE MAJORITY OF THE CALENDAR YEAR 2019 LOOKING AT THE LAW AND RECOMMENDING CHANGES. I WILL SAY THAT AT ONE POINT I WAS REPRESENTING THE METRO COUNCIL ON THE LAND MARKS COMMISSION, AND I URGED MY COMMISSIONERS TO TAKE A LOOK AT THE LAW AND TRY TO RECOMMENDS. BECAUSE THE LAND MARKS ORDINANCE WAS SORT OF AN EXTENSIONAL CRISIS. I THOUGHT IF WE DIDN'T FIX IT, THIS BODY MIGHT BE MORE INCLINED TO GET RID OF IT FRANK. TO ELIMINATE CONFUSION ON THE COVER PAGE AND LOOK AT THE TECHNICAL AMENDMENTS IN THE HIGHLIGHTED TEXT, ONE OF THE THINGS THE LAND MARKS COMMISSION DID WAS TWEAK THE DEFINITION SOME FOR EXAMPLE, THEY TOOK THE DEFINITION FOR PROPERTY, WHICH WAS A DEFINED TERM. THIS IS THE LIST OF THINGS THAT SOMEONE WHO LIVES IN AN HISTORIC PROPERTY OR DISTRICT CAN DO WITHOUT PERMISSION. IF YOU LIVE IN AN HISTORIC NEIGHBORHOOD AND YOU WAND TO DEMOLISH YOUR HOME OR DO SOMETHING DRAMATICALLY DIFFERENT YOU NEED PERMISSION. THERE ARE EXCEPTIONS TO AWAY WHAT EWE NEED PERMISSION FOR. PREVIOUSLY THERE WERE NINE ENUMERATED. WE ADDED A 10. IF YOU WANT TO PUT A VIDEO CAMERA, YOU CAN DO THAT.

PACKET. S IN WHERE EVERYTHING IS. ONE OF THE THINGS, I'LL RUN

THROUGH IT QUICKLY. IN SECTION B, DESIGNATION PROCESSES,

PREVIOUSLY MOST OF US HAVE EXPERIENCED LAND MARKS BECAUSE

SOMEONE CAME IN WITH A PETITION AND WANTED TO LANDMARK SOMEONE'S

PROPERTY. THERE THIS PETITION PROCESS AND IF YOU OWN THE

PROPERTY YOURSELF, YOU CAN IMPLY AND PEOPLE DO THAT. WE'RE

THIS IS SOMETIMES WHERE YOU'LL SINGLE OUT ONE PROPERTY OUTSIDE OF THE NEXT DOOR NEIGHBORS AND OVER THE WILL OF THE PROPERTY OWNER. THIS IS WHERE WE'VE HAD THE CONTROVERSIAL IN THE PAST. >> THANK YOU. THIS IS A WELCOME DEVELOPMENT AND A POPULAR AND WELL KNOWN LOCATION THROUGHOUT THE CITY. MOST EVERYONE KNOWS ABOUT SWISS HALL. IT'S IN THE SAINT JOSEPHS NEIGHBORHOOD. IT'S BEEN LOOKED AT FOR A WHILE NOW. THIS IS A WELCOMED DEVELOPMENT BY THE NEIGHBORHOOD. THERE'S NO OPPOSITION AND EVERYONE IS EXCITED ABOUT IT. 41 UNITS OF HOUSING WHICH ALWAYS GOOD TO HOUSE -- TO SEE HOUSING TO ADDRESS OUR ISSUES THERE. REPURPOSE OF SWISS HALL ITSELF IS A WELCOME ADDITION AND SOMETHING THAT

THE NEIGHBORHOOD WOULD BE PROUD OF. AND I'LL BE VOTING IN FAVOR OF THIS AND ASK FOR YOUR SUPPORT AS WELL.

- >> PRESIDENT JAMES: THANK YOU. MOTIONED BY BENSON, SECOND BY COUNCILMAN TRIPLETT. RESOLUTION BUFFERS. DISCUSSION?

- >> THE VICE CHAIR RAN THIS COMMITTEE I WOULD DEFER HIM
 [INDISCERNIBLE]
 - >> PRESIDENT JAMES: THANK YOU. COUNCILMAN PIAGENTINI.
- >> A COUPLE INTRODUCTORY COMMENTS. THIS IS THE LAND FOR THE LOUISVILLE URBAN LEAGUE RELATED TO THE TRACT DEVELOPMENT. WHICH YOU'RE FAMILIAR WITH THIS PROJECT. I WOULD SAY IT WAS A MIXED VOTE OUT OF COMMITTEE. WITH ONE PRESENT, ONE NAY, TWO YES VOTES. I WANT TO CLARIFY SOMETHING AND I'LL MAKE BROADER COMMENTS AFTER

PASSING TO COUNCILWOMAN PURVIS. EVERYBODY VOICED THEIR SUPPORT OF THIS PROJECT. JUST SOME CONCERNS ABOUT THE PROPERTIES

THAT -- PROCESS THAT THE ADMINISTRATION GOES THROUGH RELATED

TO -- SURPLUS PROPERTIES. I WILL PASS TO WITH HOLD -- --

>> COUNCILMAN PIAGENTINI THANK YOU. COLLEAGUES WE'VE HAD A
LOT OF DISCUSSION ABOUT THIS AND RIGHTFULLY SO. I WANT TO GO ON
RECORD AND STATE THIS DEVELOPMENT AGREEMENT WAS DRAFTED AND
CRAFTED LONG BEFORE I ARRIVED HERE. BUT NEVERTHELESS I FIRMLY
BELIEVE DISTRICT FIVE AND WEST LOUISVILLE DESERVES THIS WIN.
I'VE HAD MANY CONVERSATIONS OVER THE PAST FEW DAYS WITH YOU ALL
PERTAINING TO THIS. I TALK TALKED WITH [INDISCERNIBLE] SARA
MARTIN AND FEEL AS WE DEVELOPED LANGUAGE THAT WILL PROTECT
LOUISVILLE METRO ASSETS. WITH THE DEVELOPMENT AGREEMENT, IT WILL
NOW READ THAT IF THE PROPERTY IS NOT DEVELOPED WITHIN FIVE YEARS
FROM THE DATE OF TITLE TRANSFER OF THE PROPERTY FROM METRO TO
DEVELOPER, DEVELOPER AGREES THAT THE PROPERTY WILL REVERT BACK
TO METRO. SO THIS IS NOT A MOTION BUT WANTED TO READ INTO THE
RECORD THE CHANGES AND I ASK FOR YOUR SUPPORT IN VOTING FOR
THIS. THANK YOU.

- >> PRESIDENT JAMES: THANK YOU. COUNCILMAN PIAGENTINI.
- >> THANK YOU. I WANT TO CLARIFY SOME OF MY CONCERNS THAT

 CAME OUT OF COMMITTEE AND DISCUSSION -- DISCUSS THIS PROJECT.

 FIRST AND FOREMOST, I WHOLEHEARTEDLY SUPPORT THE PROJECT. I'M

 GOING TO VOTE YES ON THIS. AND REALLY APPRECIATE COUNCILWOMAN

PURVIS, YOUR COMMENTS. I UNDERSTAND HOW MY COMMENTS DURING COMMITTEE MAY HAVE BEEN MISUNDERSTOOD. I WANT TO CLARIFY THEM FOR THE RECORD. I THINK WE HAVE A SERIOUS PROBLEM WITH THE PROCESS THAT THIS ADMINISTRATION GOES THROUGH RELATED TO SURPLUS PROPERTY. I THINK COUNCILMAN ACKERSON WHO IS NOT HERE TONIGHT, BROUGHT UP A FEW INSTANCES PRIOR INSTANCES OF ISSUES -- ISSUES RELATED TO HOW THE HAD GONE THROUGH -- ADMINISTRATION HAD GONE THROUGH THIS PROCESS AND PROBLEMS THAT RESULTED AFTER THE FACT BECAUSE THE PROPER DUE DILIGENCE WAS NOT DONE. THE LEGAL DOCUMENTS WERE NOT WRITTEN IN A WAY THAT PROTECTED ALL PARTIES. CERTAINLY PROTECTED TAXPAYERS WHEN DEVELOPMENT PROJECTS DON'T GO WELL. DEVELOPMENT PROJECTS CAN BE RISKY, DIFFICULT, AND WE HOPE THAT ALL OF THEM GO EXACTLY THE WAY WE WANT THEM TO. I HOPE THIS ONE GOES EXACTLY THE WAY THE URBAN LEAGUE HOPES AND THE SHINING SUCCESS WE ALL FRAY PREY IT IS. I PLAN ON DONE -- AND ENSURE IT CONTINUES AND IS A WIN FOR THE WHOLE COMMUNITY. TO BE CLEAR WHEN ANY DISTRICT, I'VE HAD THE OPPORTUNITY RIDE WITH COUNCILWOMAN PURVIS IN HER DISTRICT AND COUNCILWOMAN DORSEY IN HER DISTRICT AND I'M SCHEDULING WITH OTHERS RIGHT NOW. IN ANY WIN IN ANY DISTRICT IS A WIN FOR THE WHOLE CITY. I HOPE IT GOES WELL. I WANT TO BE ON THE RECORD AND CLARIFYING MY COMMENTS THAT THERE'S GOING TO BE, I WAS DISAPPOINTED WITH HOW SOME OF OUR QUESTIONS WERE ANSWERED IN COMMITTEE RELATED TO THIS PROCESS. MAYBE OTHERS ARE. I'M NOT CONVINCED PERSONALLY THAT WE HAVE GONE THROUGH THAT PROCESS WITH EVERY DEVELOPMENT PROJECT THROUGH THIS CITY. -- [INDISCERNIBLE] WE NODE TO SEE THIS PROJECT MOVE FORWARD. I AM, AND I THINK THE ECONOMIC DEVELOPMENT AND CONTRACT COMMITTEE DOES NEED TO DELVE DEEPER INTO THIS PROCESS INTO HOW THESE DECISIONS ARE MADE PROVIDING THE PROPER OVERSIGHT AND MAKING RECOMMENDATIONS BASED OFF OF PROBLEMS WE'VE HAD IN THE PAST. BASED OFF OF EXPERIENCE TO MAKE THIS PROCESS CLEARER FOR THE TAXPAYERS AND MORE SECURE FOR THE CITY OVERALL. THERE'S EXAMPLES RECENTLY WHERE THIS LEVEL OF CONFUSION CAN LEAD TO SERIOUS RISK FOR THIS CITY. I THINK WE NEED TO BE CAREFUL ABOUT HOW WE CREATE THESE OPPORTUNITIES BECAUSE THEY CAN CREATE RISK NOT JUST FOR THE CITY BUT THE ENTITY INVOLVED IN IN CASE THE URBAN LEAGUE. I LOOK FORWARD TO ENGAGING IN THE PROCESS WITH THE ADMINISTRATION. I LOOK FORWARD TO MAKING SURE THEY GO THROUGH A PROCESS THEY FEEL IS A MORE THOROUGH PROCESS. I ENCOURAGE MY COLLEAGUES TO. LY SUPPORT THIS. I WISH THE BEST TO THE URBAN LEAGUE AND THIS DEVELOPMENT PROJECT.

>> I'M GOING TO ECHO AND HOPEFULLY EXPAND UPON COUNCILMAN
PIAGENTINI. I SUPPORT THIS PROJECT AS WELL. HAVING TWO TEENAGED
DAUGHTERS WHO HAVE GROWN UP. YOU HEAR HEARD ME SAY
[INDISCERNIBLE] REAL MONEY IS IN OVERZEALOUS PARENTS WHO THINK

THEIR KIDS ARE BETTER THAN THEY ARE. I DROPPED THOUSANDS OF DOLLARS WE NEED A SOCCER COMPLEX. WE NEED A BASEBALL COMPLEX. WE'RE GETTING THIS TRACK COMPLEX. THAT'S AWESOME. BUT AT THE SAME TIME, I WILL ECHO THE OTHER CONCERNS. WE NEED A STANDARD LINE ON EVERY DEVELOPMENT AGREEMENT ON EVERY SURPLUS PIECE OF PROPERTY THAT WE HAND OUT THAT BASICALLY GIVES US RIGHT OF FIRST REFUSAL TO GET IT BACK. IF WHATEVER YOU'RE DOING DOESN'T WORK OUT, IF YOU TRY TO FLIP IT, WHATEVER IT IS, WE HAVE THE RIGHT TO BITE BACK FOR WHATEVER -- BUY IT BACK FOR. THAT SYMBOLIC DOLLAR WE SOMETIMES CHARGE OR A FEW THOUSAND MORE AND THAT WOULD TAKE CARE OF A LOT OF THE ISSUES THAT COME WITH A BREWERY THAT DOESN'T COME TO THE HIGHLANDS OR A SOCCER STADIUM AND THE SURROUNDING ENTERTAINMENT DISTRICT. SOCCER STADIUM LOOKS LIKE IT'S GOING. THAT'S IMPRESSIVE. WHETHER -- THE THOUGH. IT CAN BE JUST A FEW THOUSAND SOUARE FEET WE HAND OFF BECAUSE WE DON'T WANT TO CUT THE GRASS ANYMORE. SOMEWHERE NEEDING THE PROTECTION. WE MAY EVEN LOOK AT IT AND GO, YOU KNOW IT'S ALL YOURS. THANKS FOR TAKING CARE OF IT FOR THE LAST FEW YEARS. GIVE US THAT, AGAIN, IT'S NOT SOMETHING MANDATORY. BUT EVERYONE OF THEM WE NEED THE OPTION TO SAY, YEAH, THAT'S GOING TO LOOK REALLY BAD ON OUR BALANCE SHEET THAT WE GAVE YOU LAND THAT YOU FLIPPED FOR \$1.1 MILLION. AND WE NEED TO FIX THAT KIND OF STUFF. WHICH LEADS ME TO, ANOTHER THING THAT'S GOING AROUND ABOUT THIS PARTICULAR PROJECT, AND IT HAPPENED TO US THE FIRST TIME WHEN YOU HAD THE

FAILED WALMART WOUND UP WITH LAND THAT HAD, AS I UNDERSTAND IT,
A COUPLE OF \$2 .4 MILLION IN DEBT. BECAUSE IT WAS USED TO SECURE
A LOAN AND WE'VE HEARD EVERYONE TALKING ABOUT IT ON THIS PIECE
OF PROPERTY AS WELL. LEADS ME TO A QUESTION OF MS. MARTIN. IF
PUT THIS AMENDMENT IN HERE TO GET BACK AFTER THIS FIVE-YEAR
WINDOWS AND AGAIN, I HOPE WE DO NOT HAVE TO EXERCISE THAT.
HOPEFULLY IT WILL GET UP AND RUNNING AND WE WILL HAVE THE MASON
DIXON 21ST CENTURY ON THE A REGULAR BASIS. IF WE GET THIS
PROPERTY BACK FOR WHATEVER REASON AND THERE IS ANY DEBT ATTACHED
AT ALL. DOES THE CITY TAKE THE DEBT ALONG WITH THE LAND?

>> SARA MARTIN WITH THE COUNTY ATTORNEY'S OFFICE. SO THE RECENT AMENDMENT TO THE DEVELOPMENT AGREEMENT MODIFIES SECTION 3.14 WHICH IS THE DEFAULT CLAUSE. IT HAS A RIGHT OF REVERTER FOR THE CITY. AND IT ALLOWS THE, IF THERE'S ANY KIND OF MATERIAL BREACH OR DEFAULT, LOUISVILLE METRO, TO SEEK REPOSITION OF THE PROPERTY. SO THERE WILL BE A RIGHT OF REVERTER CLAUSE IN THE DEED WHEN IT'S TRANSFERRED OVER TO THE URBAN LEAGUE. IF THIS BODY APPROVES THE SURPLUS RESOLUTION. LOUISVILLE METRO WOULD HAVE A SUPERIOR RIGHT TO THE PROPERTY OVER ANY BANK LIEN.

>> PRETEND I'M NOT A LAWYER. AND EXPLAIN THAT LIKE I'M FOUR. [LAUGHTER]

>> SO --

>> IF THERE'S -- I THINK YOUR ANSWER WAS NO WHICH WOULD HAVE BEEN HELPFUL IF YOU JUST SAID NO.

- >> I WOULD LIKE TO SAY NO BUT IT'S DIFFICULT TO ANSWER A HYPE CALL LEGAL QUESTION ON WHAT WILL HAPPEN TO THE PROPERTY.
- >> THE THERE'S ONLY TWO PARTS TO THE QUESTION AND THAT S

 IT'S COMING BACK TO US AND THERE'S -- AND IT'S BEEN USED TO

 SECURE A MORTGAGE OF SOME KIND OR ANOTHER ARE WE ON THE LOOK FOR

 THAT MORTGAGE?
 - >> NO.
 - >> OKAY. THERE WE GO. THANK YOU.
 - >> PRESIDENT JAMES: THANK YOU. COUNCILWOMAN SEXTON SMITH.
- >> THANK YOU. AM I EVER THRILLED TO BE IN THE YOU BEHIND A HAPPY COUNCILMAN PEDEN. THE POINT WANTED TO MAKE IS WE ARE FINDING OURSELVES FOR ME, IN A VERY EXCITING HISTORIC MOMENT THIS EVENING IN OUR CHAMBER AS WE'RE GETTING READY TO VOTE ON THIS PIECE OF PROPERTY. BECAUSE THIS WILL BECOME A HISTORY MAKING EVENT NOT JUST FOR WEST LOUISVILLE BUT OUR ENTIRE COMMUNITY AND THE REGION, AND IT'S BEEN LAID OUT BY THE BOARD OF DIRECTORS IN THE PRESIDENT CEO OF OUR LOUISVILLE URBAN LEAGUE, THIS WILL DRAW ATTENTION FROM ALL OVER THE COUNTRY. THE WORLD. PEOPLE ARE GOING TO COME HERE BECAUSE WE ARE GOING TO HAVE THE PREIMANT INDOOR TRACK AND FIELD FACILE TIP. AND MUCH OF THAT THANKS GOES TO ALICE HOUSTON WHO IS SEATED IN THE AUDIENCE WHO HAS PUT EVERYTHING ON THE LINE TO BE HELPFUL MIND, BODY, AND SOUL, FOR THAT I AM GRATEFUL. SHE'S A HUMBLE WOMAN WHO WOULD NEVER TAKE THAT KIND OF PRAISE PUBLICLY. COUNCILMAN PIAGENTINI

HAS BEEN SPOT ON ON ASKING THESE OUESTIONS. I KNOW SOMETIMES IT'S PAINFUL, AND IT TAKES A LONG PROCESS. SOMETIMES WE MAY BE FRUSTRATED WITH ONE ANOTHER. I'M GRATEFUL FOR COUNCILMAN PIAGENTINI FOR ASKING THE QUESTIONS AND SPECIFICALLY SAYING, ARE WE LEARNING ANYTHING AS WE GO ALONG? I DO THINK THAT WE ARE LEARNING SOME THINGS AS WE GO ALONG. IN MY SHORT TIME ON COUNCIL, WE HAVE LEARNED SOME VERY HARD LESSONS ALREADY. WE'RE LEARNING A GOOD ONE IN THIS PARTICULAR AGREEMENT, THANKS TO YOUR QUESTIONING. AND THAT IS WE NOT ONLY HAVE A RETURE -- RECAPTURE CLAUSE THANKS TO COUNCILWOMAN PURVIS WE HAVE A SECOND MEASUREMENT IN THE DEVELOPMENT AGREEMENT THAT WILL MAKE SURE WE ARE PROTECTED. I JUST APPRECIATE MY COLLEAGUES FOR DOING THE DUE DILIGENCE AND ASKING THE HARD QUESTIONS. AND GETTING US TO THIS POINT. I'M LOOK FORWARD TO CELEBRATING. PY WILL BE SUPPORTING THIS AND COK NOT WAIT UNTIL WE HAVE THAT ROLL CALL VOTE, THANK YOU.

- >> PRESIDENT JAMES: THANK YOU. COUNCILWOMAN PARKER.
- >> I'VE GOT A QUESTION ON WHY IS THIS TO THE COUNTY
 ATTORNEY. WHY IS THIS A RESOLUTION VERSUS AN ORDINANCE?
- >> SO IT'S A RESOLUTION BECAUSE IT'S AN APPROVAL OF A SURPLUS. IT'S GIVING THE MAYOR AUTHORITY TO SURPLUS -- TO TRANSFER THE PROPERTY. SO THE ONLY DECISION YOU'RE MAKING IS AN UP AND DOWN. WE AGREE THE SURPLUS THAT IS THE PROPERTY OR WE DON'T GIVE THAT AUTHORITY [INDISCERNIBLE] YOU'RE NOT ACTUALLY

CHANGING THE LAW IN ANY WAY. YOU'RE JUST APPROVING THE MAYOR'S AUTHORITY TO ACT ON TRANSFERRING THIS PROPERTY. THE DEVELOPMENT AGREEMENT THAT IS ATTACHED AS REFERENCE TO THE AGREEMENT THAT LOUISVILLE METRO IS ENTERED INTO WITH THE URBAN LEAGUE REGARDING THIS PROPERTY. THE AMENDMENT DISCUSSED WAS AN AMENDMENT TO THE DEVELOPMENT AGREEMENT. IT'S NOT TO VOTE ON FAVOR SAY AYE IT'S FOR YOUR REFERENCE. PART OF THE AGREEMENT THAT WAS EXECUTED IN JUNE OF 2018. IT'S RELEVANT TO THE DECISION YOU'RE MAKING BECAUSE IT RELATES TO THE PROPERTY. SO WHAT'S BEFORE YOU IS THE METRO COUNCIL'S APPROVAL TO EXECUTE FOR THE TRANSFER THE PROPERTY TO THE URBAN LEAGUE. UPON THE TIME AT WHICH THE URBAN LEAGUE AND LOUISVILLE METRO HAS COMPLIED WITH ALL THE OBLIGATION AND THE DEVELOPMENT AGREEMENT AND THE DOCUMENT CAN BE FOUND ON [INDISCERNIBLE] ONE EXECUTED IN JUNE 2018.

>> OKAY. DO WE KNOW IF THE URBAN LEAGUE, ALL THEIR FUND-RAISING GOALS ARE MET?

>> THAT WAS A MATTER DISCUSSED IN COMMITTEE. OR MAYBE
THERE'S SOMEBODY ELSE THE PRESIDENT WANTS TO CALL ON FOR THAT.
BUT AS A LAURA FERGUSON TESTIFIED LAST WEEK DURING THE COMMITTEE
MEETING, THE URBAN LEAGUE WILL BE REQUIRED TO SHOW PROOF OF
FINANCING BEFORE LOUISVILLE METRO WILL MOVE FORWARD WITH THE
TRANSFERS OF THE PROPERTY.

>> OKAY. THEY JUST IF THEY CAN'T -- IT IF THEY -- THEY CAN'T SHOW.

>> TO RECLARIFY. IF WE GIVE THIS OVER FAR FOR A DOLLAR AND IF I COUNCIL MEMBER -- COUNCILWOMAN WOOLRIDGE WOULD HAVE A FIT BECAUSE SHE WAS ALWAYS UPSET SISTER AND BROTHER GIVE -- UPSET ABOUT THE GIVEAWAYS. CLARIFY AGAIN, WE CAN'T GIVE THIS TO THEM FOR A DOLLAR AND THEN THEY TURN AROUND AND SELL IT FOR HALF A MILLION OR A MILLION OR --

MAINTAINED AS AN INDOOR TRACK. AS THE INDOOR TRACK FACILITY THAT

IS PROPOSED IN THE DEVELOPMENT AGREEMENT.

- >> FOR HOW LONG?
- >> THE FIRST 10 YEARS.
- >> OKAY. AND SO.
- >> WHAT IF IT'S NOT FINANCIALLY VIABLE? AS HAPPENED IN THE PAST WITH OTHER DEALS LIKE THIS.
- >> WHAT HAPPENS IF IT'S NOT FINANCIALLY VIABLE? IS ON THE LOOK?
- >> IT'S DIFFICULT -- I'M -- I'M NOT UNDERSTANDING WHAT
 YOU'RE ASKING. 10 YEARS DOWN THE ROAD? FIVE YEARS DOWN THE ROAD.
 TWO YEARS.
- >> WELL, I MEAN, THERE'S SECTION 3.14 DEFAULT SECTION THAT ALLOWS METRO, IF THERE'S ANY KIND OF MATERIAL BREACH OR DEFAULT

OF THEIR AGREEMENT THERE'S A RIGHT OF REVERTER CLAUSE TO GET THE PROPERTY BACK. IT'S DIFFICULT TO ANSWER A HYPOTHETICAL QUESTION ABOUT -- THAT YOU'RE ASKING. - >> WOULD IT BECOME OURS TO TAKE OVER?
- >> WHAT IS BEFORE YOU IS THE TRANSFER OF PROPERTY. THE

 DEVELOPMENT AGREEMENT ITSELF ANTICIPATES. SETS FORTH PROPOSED

 SCHEDULE FOR THE URBAN LEAGUE TO FOLLOW IN TERMS OF THE

 CONSTRUCTION. IT DETAILS THE OBLIGATIONS OF THE URBAN LEAGUE AND

 CONSTRUCTION AND MAINTAINING AND TAKING OVER LIABILITY AND NOT
