COUNCILMAN GREEN INDICATED THAT IT WORKS WITH THE S.O.P.S AND I'M

NOT SURE IT IS 95 PERCENT BUT IT IS 85 PERCENT.

THE POLICE DEPARTMENT HAS DONE A GOOD JOB AND SHOULD BE PROUD OF THE USE OF FORCE POLICIES IT HAS IN PLACE NOW.

OF COURSE THEY'RE ACCOUNTABLE FOR FOLLOWING THEM.

THAT'S SOMETHING THAT WE'LL BE DISCUSSING IN THE FUTURE.

WE'RE TRYING TO GET TO 100 PERCENT IN TERMS OF THESE BEST PRACTICES.

IT IS SOMETHING THAT OTHER CITIES ACROSS THE COUNTRY ARE DOING, ST.

LOUIS RECENTLY ENACTED BROAD USE OF FORCE POLICY.

AKRON, OHIO PASSED THE DUTY TO INTERVENE ON CHOKE HOLDS.

SEATTLE BAN, WASHINGTON, D.C. A VERY BROAD EMERGENCY ORDINANCE NOT ALLOWING CHOKE HOLDS.

DIFFERENT CITIES TAKE THIS ACTION IN DIFFERENT WAYS.

I WANT TO REITERATE THAT SIX WEEKS AGO MAYOR FISHER SENT A LETTER,
THIS WAS IN ALL OF OUR PACKETS WHEN HE WAS RETURNING THE RESOLUTION
EXPRESSING NO CONFIDENCE BACK TO US, HE INCLUDED A LETTER SENT TO
THE JEFFERSON COUNTY LEGISLATION HOUSE AND SUBCOMMITTEE.

IT SAID DEAR MEMBERS, I SUPPORT THIS IN THE 2020 LEGISLATIVE SESSION AND ACTIVATING PUBLIC SAFETY.

I HOPE THESE PROPOSALS WILL BE INCLUDED IN THE SPECIAL OR -- IN THE SESSION AGENDA.

HE SAYS BAN CHOKE HOLDS, STRANGLEHOLDS AND WEIGHT ON SUBJECTS UNLESS NECESSARY.

REQUIRE ALL POLICE DEPARTMENTS TO TRAIN ON DEESCALATION TECHNIQUES.

REQUIRE OFFICERS TO ACT TO PREVENT OR STOP ANY MEMBER REGARDLESS OF RANK OR ASSIGNMENT FROM USING UNLAWFUL OR EXCESSIVE FORCE.

INTERVENTION MAY BE VERBAL AND OR PHYSICAL, CURRENT POLICY.

BAN SHOOTING AT MOVING VEHICLES EXCEPT IN SITUATIONS WHERE OFFICERS ARE RETURNING GUNFIRE AND PREVENT A VEHICLE ATTACK.

THIS IS CURRENT LMP POLICY.

REQUIRE COMPREHENSIVE REPORTING AND PUBLIC RELEASE OF DOCUMENTATION WHEN OFFICERS USE FORCE.

HE SPECIFICALLY ENUMERATED AT LEAST FIVE OF THESE POLICIES THAT ARE PROPOSED IN THE ORDINANCE, INCLUDING SOME ARE EXISTING POLICY AND SOME WHERE THEY FLAGGED THEY WERE NOT POLICY.

IT IS CLEAR THAT THE ADMINISTRATION SUPPORT STATE LAW REQUIREMENTS BUT NOT CITY LAW REQUIREMENTS.

IF THE STATE LAW PASSES THAT BECOMES A CITY LAW.

I THINK FROM THE VERY TOP OF THE LEADERSHIP ACROSS THE STREET AND FROM ACROSS THE COUNTRY AND CERTAINLY FROM OUT IN THE STREETS AND I KNOW IN MY CONSTITUENCY AND MANY OTHERS THERE IS A REASONABLE CRY FOR GUARANTEES AGAINST THE USE OF EXCESSIVE FORCE AGAINST CITIZENS BY THE POLICE DEPARTMENT.

THESE ARE BASIC PROTECTIONS.

THEY'RE BASIC EXPECTATIONS.

I WOULD URGE YOU ALL TO VOTE YES IN FAVOR OF IT TONIGHT.

I'LL START BY SAYING THAT THE REQUESTS OF THE MAYOR FOR POLICE REFORM
ARE PROBABLY THE LAST PERSON I WOULD TAKE THAT ADVICE FROM IN THIS

CITY.

HE WAS THE MAYOR WHEN BRIANNA TAYLOR WAS KILLED.

HE'S BEEN THE MAYOR WHEN WE'VE SEEN OFFICERS NOT HELD ACCOUNTABLE FOR DISCIPLINARY ACTION WHEN THEY SHOULD HAVE BEEN ACCOUNTABLE.

HE WAS THE MAYOR WHEN CHILDREN WERE ABUSSED WITHIN THE LMPD.

A CASE WE STILL DON'T HAVE COMPLETED.

VICTIMS HAVE NOT BEEN MADE WHOLE FROM.

HE WAS THE MAYOR WHEN THE POLICE DEPARTMENT ABUSED -- DIDN'T HAVE APPROPRIATE OVERSIGHT AND SOME MEMBERS STOLE MONEY FROM THE CITY. FRANKLY, I'M NOT SURE IF HE'S THE PERSON I WOULD GO TO REGARDING POLICIES.

WITH THAT SAID, I HAVE TWO COLLEAGUES HERE WHO I DO TRUST.

BRANDON COAN AND JESSICA GREEN.

I TRULY APPRECIATE WHAT IS ATTEMPTED TO BE COMPLETED HERE.

AND I APPRECIATE PRECISELY WHAT COUNCILMAN COAN SAYS RELATING TO THE OUTCRY.

THERE'S NO OUESTION ABOUT IT.

I SAW A GOVERNOR OF FLORIDA ONE TIME INTERVIEWED AND HE SAID WHAT WAS THE TOUGHEST THING YOU HAD AS CHIEF EXECUTIVE THAT YOU HAD TO DO?

HE SAID THE TOUGHEST THING WAS SOMETIMES NOT DOING SOMETHING BECAUSE THAT WAS THE RIGHT THING TO DO.

THERE'S ALWAYS PEOPLE AND WE KNOW THIS AS ELECTED OFFICIALS WHO ARE ASKING FOR SOMETHING TO BE DONE.

ASKING FOR JUSTICES TO BE CORRECTED.

SOMETIMES THOSE POLICY CHANGES, SOMETIMES THOSE MEAN LAW CHANGES.

I SUPPORTED BRIANA'S LAW.

BRIANA'S LAW WAS IN CLEAR AND DIRECTLY TRYING TO PREVENT SOMETHING THAT LED TO THE DEATH, THE TRAGIC DEATH OF AN INNOCENT WOMAN IN LOUISVILLE.

THAT MAKES A LOT OF SENSE.

BUT I DON'T SEE HERE SPECIFICALLY, PARTICULAR WHEN AS MY COLLEAGUES
ARGUED THAT WE ALREADY MADE IT AGAINST A POLICY WHY WE WOULD GO THE
EXTRA STEP.

THERE'S A LOT OF POLICIES I DISAGREE WITH AND A LOT I AGREE WITH.

I WOULD LOVE TO TAKE THE POWER AWAY AS MANY OF YOU KNOW FROM THE MAYOR

TO MAKE CHANGES TO THOSE LAWS.

BUT I DON'T BECAUSE I RESPECT THE FACT THAT MY JOB AS A LEGISLATOR
IS TO MAKE BROADER LAW.

HIS IS TO EXECUTE THE LAW.

SOMETIMES I SAY TO MY CONSTITUENTS, DO SOMETHING ABOUT THE HOMICIDE RATE.

DO SOMETHING ABOUT THE VIOLENT PROTESTS.

THAT'S THE EXECUTIVE BRANCH'S JOB AND IF I GET TOO INVOLVED THERE COULD BE REPERCUSSIONS.

IT HAS BEEN THROUGHOUT THE COUNTRY.

IT IS DUBBED THE FERGUSON EFFECT WHERE WHEN TRAGEDY OCCURS AN EVERYREACTION CAN CAN RESULT IN WORST OUTCOMES AT THE END.

WE HAVE NO IDEA WHAT THE NEGATIVE POLICY OUTCOMES COULD BE.

WE'RE HOPING THAT THEY DON'T [INDISCERNIBLE].

THE TRAGEDIES YOU'VE SEEN.

100-PLUS HOMICIDES.

I HAVEN'T SEEN THIS METRO COUNCIL DO MUCH IT PASS LAWS, TO PASS RESOLUTIONS OR DO ANYTHING ABOUT THAT YET.

OKAY?

SO I'M NOT DISPUTING THAT THEY'RE JUST.

I UNDERSTAND THAT THIS TRUST OF THE EXECUTIVE BRANCH, I HAVE THAT.

THERE'S LOTS OF THINGS I WANT TO CODE GUY INTO LAW.

I THINK WE WANT TO BE CAREFUL.

I MET WITH CHIEF GENTRY AND WAS BLOWN AWAY BY HER HERE, BY THE DIRECTION SHE'S TAKEN BY THE DEPARTMENT, SHORT-TERM, I BEGGED HER WALKING OUT TO SEE IF SHE WOULD RECONSIDER WHAT HER FUTURE LOOKED LIKE.

SHE TALKED ABOUT OVERSIGHT, BETTER OVERSIGHT OF OFFICERS WHICH WOULD HAVE PREVENTED MANY SCANDALS THAT WE'VE SEEN.

THAT IS ACTION THAT WILL HAVE DEFINITIVE RESULTS AND IT IS DUE AND IT COMES FROM TRAGEDIES WE'VE SEEN AND APPROVED ADDITIONAL COMMANDERS IN THE FIELD AND ADDITIONAL ACCOUNTABILITY.

SHE TALKED ABOUT POLICING SOMETHING WE HAVE NOT DONE EFFECTIVELY IN THIS CITY THAT WILL PREVENT THINGS LIKE YOUNG BLACK MEN UNJUSTLY BEING PULLED OVER IN THEIR CAR FOR NO OTHER REASON THAN THEY'RE DRIVING A NICE CAR.

IT WILL TARGET THE ENFORCEMENT OF LAW AS OPPOSED TO DOING SO IN A WAY THAT COULD CAUSE DISTRUST IN THE COMMUNITY.

WE'RE NOT CODIFYING THOSE INTO LAW TODAY, WHICH I SAY WOULD CHANGE
THE TRAJECTORY OF THE POLICE DEPARTMENT.

IT IS NOT A QUESTION OF WHETHER OR NOT I AGREE WITH THE INTENT OR IF THIS IS A GOOD IDEA.

BUT THIS TYPE OF LEGISLATING UNCHECKED COULD HAVE SIGNIFICANT DOWNSTREAM CONSEQUENCES.

POLICE SOMETIMES NEED TO MAKE GOOD POLICY CHANGES.

NOW IF WE CONTINUE DOWN THIS ROAD, THEY WILL HAVE TO COME TO 26
MEMBERS, 26 POLITICIANS FRANKLY TO MAKE THOSE CHANGES BEFORE THEY
WANT IT.

I THINK WE NEED TO GIVE THE CHIEF AN OPPORTUNITY AND THE NEW CHIEF AN OPPORTUNITY.

WE NEED TO SEE WHAT LEGISLATION WILL BE PASSED BY THE LEGISLATURE SOME OF WHICH I WHOLEHEARTEDLY AGREE WITH.

THE GOOD NEWS IS THAT WE CAN GIVE BOTH OF THESE GROUPS THEIR

OPPORTUNITY TO MAKE SOME OF THE SUBSTANTIVE CHANGES THIS WE'LL HAVE

HUGE IMPACT.

I WOULD ARGUE MUCH BROADER THAN THIS PARTICULAR LEGISLATIVE CHANGE
AND THEN SEE WHERE THEY MISSED THE BOAT AND WHERE THEY MISSED THE
BOAT, WHEN THEY'RE GIVEN A CHANCE TO CHANGE THEN WE CAN COME IN AND
MAKE THOSE CHANGES.

I'M AFRAID THAT WE'RE JUMPING THE SHARK A LITTLE HERE.

AND FRANKLY, THIS HAS BEEN FILED, OUR NEW -- OUR NEW METRO COUNCIL GETS SEATED IN THE FIRST MONDAY OF JANUARY SO WE COULD BRING THIS UP THE SAME EXACT LAW IF WE DON'T SEE THE LEGISLATURE TAKE APPROPRIATE ACTION.

WE HAVE 130-PLUS HOMICIDES.

WE'RE LOSING FOCUS.

WE'RE IN THE DOING ANYTHING TO END THE CONVERSATION.

WE MUST -- THE NAME OF BRIANNA TAYLOR HAS RIGHTFULLY SO BECOME SYNONYMOUS WITH REFORM.

THAT'S GOOD.

LET OTHER NAMES LIKE TRINITY RANDOLPH, A THREE-YEAR-OLD THAT WAS ASSASSINATED IN HER HOME BECOME SYNONYMOUS WITH TARGETED POLICE AGAINST THOSE THAT WILL DESTROY THE COMMUNITY.

I'M AFRAID THAT WE MAY SWING THE PENDULUM SO FAR UNDER THE AUSPICES
OF REFORM AND THAT WE MAKE IT MORE DIFFICULT TO PREVENT AND IT FIND
JUSTICE FOR THE TRINITY RUDOLPHS OF LOUISVILLE.

FOR THOSE REASONS, NOT BECAUSE I QUESTION THE INTENTION, AGAIN THE INTENTIONS ARE JUST BUT FOR THOSE REASONS I'LL BE VOTING NO AGAINST THIS ORDINANCE AND I -- I CALL ON MY OTHER COUNCIL MEMBERS TO CONSIDER WHAT THAT OVERREACH COULD CAUSE.

I JUST FEEL LIKE CODIFYING POLICE POLICY PUTS US ON A SLIPPERY SLOPE.

I QUOTE FROM MINUTES AGO THE SPONSOR OF IN LEGISLATION.

THE TEAR GAS POLICY ON LMPD WAS REVISED.

CODIFY IT, THAT AIN'T GOING TO HAPPEN.

CODIFY, IT IS GOING TO BE AT LEAST A MONTH IF YOU GET THE TIMES RIGHT.

CODIFYING POLICE POLICY INJECTS TIME INTO THOSE CRITICAL PROCESSES

WHERE OFTEN YOU DON'T HAVE -- ALLOWING PROFESSIONALS TO DEVELOP

POLICIES REMOVES THEM FROM POLITICS AND INDIVIDUAL INTERESTS AND

THAT'S THE MOST CRITICAL AREA OF A FREE AND CIVILIZED SOCIETY.

POLICE POLICIES ARE DEVELOPED AND REFINED OVER MANY MANY YEARS.

THEY INVOLVE GROUPS THAT A LOT OF YOU HAVE HEARD OF YOU AND SOME OF YOU HAVEN'T.

THE INTERNATIONAL ASSOCIATION OF CHIEFS OF POLICE.

THE POLICE EXECUTIVE RESEARCH BOARD.

THE NATIONAL ORGANIZATION OF BLACK POLICE EXECUTIVES, THE SOUTHERN

INSTITUTE OF WHICH A LOT OF POLICY WRITERS ARE GRADUATES.

THE UTILITY SCHOOL OF GOVERNMENT WITH A LOT OF POLICY WRITERS ARE GRADUATES.

THE NATIONAL FTI ACADEMY THE SAME.

AND NOTE LMPD IS A CERTIFIED LAW ENFORCEMENT AGENCY AND THAT'S THE COMMISSION ON ACCREDITATION FOR LAW ENFORCEMENT AGENCIES.

THERE'S AN EXTENSIVE PROCESS TO OBTAIN THAT ACCREDITATION.

IT PROVIDES FOR ANNUAL AUDIT THAT IS INSURE CONTINUED AGENCY
COMPLIANCE AND POLICY AND IMPLEMENTATION STANDARDS.

IT INVOLVES OVER 800 POLICE AGENCIES THROUGHOUT THE COUNTRY AND THOUSANDS OF LAW ENFORCEMENT PROFESSIONALS THAT WORK IT IDENTIFY WHAT OUR BEST PRACTICE.

HOW THE LMPD POLICY DOES WELL AND DOES LEADERSHIP WELL, FOLLOWING AMERICAN CITIES HAVE POLICE CHIEFS THAT CAME FROM THE LOUISVILLE POLICE DEPARTMENT.

THE CITY OF BALTIMORE, CITY OF DENVER, SYRACUSE NEW YORK, WALTON KANSAS, GREENVILLE NORTH CAROLINA, THE PARENT ORGANIZATION,

JEFFERSON COUNTY POLICE PRODUCED THE LAST KENTUCKY STATE POLICE

COMMISSIONER.

ALSO THE CHIEF OF KING COUNTY WASHINGTON AND BOISE IDAHO.

THESE PEOPLE KNOW POLICY.

THEY KNOW IS WELL AND THEY SPEND MORE TIME DEVELOPING THAT THAN IT TOOK TO DEVELOP THIS ORDINANCE.

THE INTERESTING THING ON MY MIND AND I SIT ON THE COMMITTEE, THERE WAS A LOT OF VOICES.

MY VOICE WAS MADE LOUD AND CLEAR.

CHIEF GENTRY HAS CONCERNS WITH THIS AS WELL.

IT WAS KIND OF PORTRAYED LIKE THEY WERE ON BOARD AND I DIDN'T GET THAT FEELING.

YOU COULD GO BACK AND WATCH THE VIDEO AND DRAW YOUR OWN CONCLUSION.
POLICE POLICY IS A LIVING DOCUMENT.

IT MUST BE ALLOWED THE FLEXIBILITY TO CHANGE QUICKLY AS TECHNOLOGY CHANGES, THE OPERATIONAL ENVIRONMENT CHANGES, AND CITIZENS DEMAND EXPECTATIONS CHANGE.

THIS MUST BE LEFT IN THE HANDS OF A CAPABLE AND PROFESSIONAL POLICE CHIEF THAT WE CAN AND WE DO HOLD ACCOUNTABLE.

COUNCILWOMAN GEORGE.

>> THANK YOU, PRESIDENT.

I'M NOT ON THE PUBLIC SAFETY COMMITTEE BUT I HAVE CERTAINLY BEEN FOLLOWING THIS ORDINANCE CLOSELY AND I'VE BEEN FOLLOWING IT BECAUSE IT IS IMPORTANT.

IT IS IMPORTANT BECAUSE SUBJECT MATTER EXPERTS MAKE POLICIES BASED ON LAW.

I WAS IN STATE GOVERNMENT FOR 15 YEARS.

I WORKED AS POLICY ANALYST.

THIS IS HOW POLICY IS MADE, THOSE THAT MAKE LAWS.

DURING THE TIME THAT THIS ORDINANCE HAS BEEN IN THE COMMITTEE, I'VE SEEN SEVERAL ITERATIONS THAT REFLECT THE FEEDBACK THAT HAS COME FROM PD.

I'VE SEEN ITERATIONS THAT REFLECT AN ATTEMPT TO COME TO CONSENSUS AND MAKE CONSESSIONS.

LAWS REFLECT VALUES.

OUR ABILITY TO LISTEN TO OUR COMMUNITY IS REALLY IMPORTANT IN THIS MOMENT.

IT IS NOT MY INTENTION TO MICRO MANAGE POLICIES.

I DON'T PRESUME TO KNOW MORE THAN THOSE IN LMPD PRACTICING LAW ENFORCEMENT.

BUT I DO UNDERSTAND COMMUNITY NEED.

I ALSO UNDERSTAND THAT LAWS REFLECT VALUES.

EVERY LEGISLATION, EVERY ORDINANCE THAT WE PASS HAS UNINTENDED CONSEQUENCES.

THAT'S POLICY 101.

IT IS OUR JOB TO BALANCE THAT, TO VIEW AS BEST WE CAN CAN TO LOOK AHEAD AND TO MAKE THE DECISIONS WITH THE INFORMATION WE HAVE IN THIS MOMENT.

WITH THAT I'LL VOTE YES AND I ENCOURAGE OTHERS TO DO SO.

- >> COUNCILMAN SEXTON.
- >> THANK YOU, MR. PRESIDENT.
- I WILL DEFINITELY BE VOTING YES THIS EVENING.
- I WANTED TO EXPLAIN MY VOTE.

FOR SOME OF THE VERY REASONS THAT OTHER FOLKS VOTING NO.

THE REASON I WILL VOTE YES, I THINK IT IS VERY IMPORTANT THAT WE TAKE
THE SUBJECT OF USE OF DEADLY FORCE WHICH IS ARGUABLY ONE OF THE MOST
IMPORTANT DISCUSSIONS, AMONG THE MOST IMPORTANT THAT ELECTED
OFFICIALS WILL EVER HAVE.

IT IS VERY CRITICAL THAT WE DO NOT DO SOMETHING THAT CREATES A FRAMEWORK THAT EVERY TIME THERE'S A CHANGE IN THE ADMINISTRATION OR EVERY TIME THERE'S A CHANGE IN THE CHIEF OF POLICE, THE WHOLE COMMUNITY BECOMES AT RISK AT THAT INDIVIDUAL MAKING CHANGES TO POLICY.

THAT'S EXACTLY WHY WE NEED TO CODIFY THESE PARTICULAR ELEMENTS.

THERE ARE EXAMPLES OF THIS METRO COUNCIL JUST VOTED UNANIMOUSLY.

EVERY ONE OF US VOTED YES FOR BRIANNA'S LAW ON JUNE 11TH.

I'M NOT SURE IF EVERYBODY RECALLS HOW WE GOT THERE.

BUT WHEN WE GOT THERE THAT NIGHT AND WE WERE GOING TO CAST SHOWS VOTES,
BRIANNA'S LAW HAD ALREADY BEEN PUT IN A POLICY.

IT JUST WASN'T CALLED BRIANNA'S LAW.

MAYOR MADE IT VERY CLEAR, WE'VE ALREADY BANNED NO KNOCK WARRANTS.
YES, YOU DID.

WE'RE GOING TO CODIFY THAT.

THE FIRST QUESTION EACH OF US MAY WANT TO ASK OURSELVES, IF YOU'RE ON THE FENCE OR MAYBE IF I COULD SAY SOMETHING OR ANYBODY ELSE COULD SAY SOMETHING, IT MIGHT CHANGE SOMEONE'S MIND TO SEE A DIFFERENT PATHWAY FORWARD.

IF YOU VOTED YES TO PAST BRIANNA'S LAW, IT IS COMMON SENSE THAT YOU

VOTE YES TO PASS THIS TONIGHT.

WHY WEREN'T THESE ELEMENTS INCLUDED ON JUNE 11TH?

AT THAT TIME THERE WAS A FEW PEOPLE WORKING AROUND THE CLOCK TRYING TO GET A PIECE OF LEGISLATION PUT TOGETHER THAT WE COULD CAN ALL LIVE WITH.

SO WE -- WE FOCUSED ON TWO THINGS THAT WE COULD ALL AGREE ON.
BANNING NO KNOCK WARRANTS.

WE DID THAT AND THE REGULATION OF USE OF BODY CAMERAS AND ALL SEARCH WARRANTS.

THAT TOO WAS PART OF A NEW POLICY THAT HAD JUST BEEN ENACTED.

SO WE MUST CHOOSE TO CODIFY THIS.

I DO NOT THINK THIS ORDINANCE IS A SWIFT OVERREACTION AT ALL.

WITH ALL DUE RESPECT, EVERYBODY HAS THEIR OWN OPINION BUT THIS LIMITS

AN OVERREACTION OF THE CONSISTENT USE OF DEADLY FORCE ALL TOO OFTEN.

MANY TIMES RESULTING IN HARM AND INJURY AND DEATH OF ONE OF OUR

CITIZENS WHO VOTED TO PUT US IN THE POSITIONS THAT WE'RE IN.

AND LASTLY, I DO THINK THIS ORDINANCE DEFINITELY IS A GREAT EXAMPLE

OF AN END CONVERSATION.

IT WAS STATED EARLIER IT WASN'T.

SURE IT IS BECAUSE THIS ORDINANCE IS THE ADMINISTRATION OF THE COUNCIL AND THE PUBLIC WORKING TOGETHER TO DO SOMETHING THAT EVERYONE IS SAYING IT IS ALMOST 100 PERCENT PERFECT.

I HEARD SO MANY TEAMS THAT IT IS SO CLOSE.

MY GOODNESS, IF WE'RE 90 PERCENT OF THE WAY, THAT'S A YES VOTE IN

MY OPINION.

SO I WOULD LOVE TO BE -- I WOULD BE HONORED IF I COULD BE ADDED AS A CO SPONSOR.

I'LL LEAVE IT TO COUNCILWOMAN GREEN AND COAN IF THEY WANT TO ADD CO-SPONSORS.

- >> I WOULD LOVE TO BE ADDED TO THIS BECAUSE I'VE BEEN WORKING
 DILIGENTLY AS MANY OF YOU HAVE BEEN, HERE LOCALLY TRYING TO GET
 DIFFERENT PIECES OF OUR LEGISLATION CODIFIED TO BE THE THINGS FOLKS
 VOTED EVERY ONE OF US TO DO.

GET UP ON THE COUNCIL, ROLL OUR SLEEVES UP AND MAKE HARD DECISIONS.

I'M GOING TO VOTE YES TONIGHT.

THANK YOU, MR. PRESIDENT.

COUNCILMAN YATES.

>> THANK YOU FOR THOSE THAT HAD THEIR OPINIONS.

I THINK IT IS TRULY IMPORTANT AT TIMES LIKE THIS THAT WE'RE AS FORWARD AND OPEN AND HONEST AND TRANSPARENT WITH THE CONSTITUENTS AND THE PEOPLE AND THOSE WATCHING.

I THINK THAT SOMETIMES WHEN PEOPLE ARE JUST WATCHES BLIPS OF NEWS,
THEY'LL SEE IN THE HEADLINES OF IF YOU PASSED A BILL OR ORDINANCE
THAT YOU MADE SOME KIND OF RAPID IMPACT, AND IT IS KNOWN THESE POLICIES
ARE IN PLACE, RIGHT NOW.

COUNCILMAN BARTLETT POINTED OUT.

THAT'S POSITIVE.

I MAKE A LOT OF SENSE OF THIS IN THE EVENT THAT OFFICER, THERE'S A REPORT MADE, AND THEY CLAIM WHAT THE REASON WAS.

WE TALKED TO CHIEF GENTRY TODAY.

IT MAKES SENSE.

I THINK THAT LOUISVILLE IS GOING TO LEAD THE WAY AND THAT'S WHAT WE'RE ASKED TO DO.

IF WE'RE GOING TO LEAD THE WAY AND ASK THE STATE LEGISLATURE TO PASS STATE LAW.

I THINK IT MAKES SENSE FOR US TO DO SOMETHING LOCALLY.

I'M VERY CRITICAL OF POLITICIANS, OF ALL DIFFERENT BACKGROUNDS OR FIREFIGHTERS OR LAWYERS OR WHAT NOT, POLICE OFFICERS, AND TO COME IN AND TRY TO BREAK AN ORDINANCE THAT WE'RE NOT [INDISCERNIBLE] WITHOUT THE BEST EXPERT OPINION.

THEY WORK WELL WITH A LOT OF EXPERTS.

ONE MAJOR CONCERN IS CHIEF GENTRY AND ADDITIONAL POLICY.

I HOPED WE WOULD GET THAT INFORMATION.

WE KNOW -- THERE MAY BE SOMETHING ELSE TO ADD IN AND SOMETHING THAT MAKES IT BETTER.

I'M A BIG BELIEVER IN SLOW DOWN AND MAKE THE BEST.

BUT WE'RE HERE.

WE'RE HERE RIGHT NOW.

AND WHETHER OR NOT THIS PASSES OR DOESN'T PASS, WE KNOW THAT'S IN THE GOING IT CHANGE THE WAY THE LMPD OPERATES BECAUSE THE POLICY IS

ALREADY IN PLACE.

WHAT MY FEAR IS, IF YOU DON'T KNOW TODAY, WHAT KIND OF PINCH WILL THAT SEND TO THE PUBLIC NOW THAT WE'RE HERE.

TO ME IN THIS TIME, THIS IS MORE IMPORTANT THAN ANYTHING ELSE.

THEY GOT TO KNOW THAT WE'RE TOGETHER AND THIS IS OUR BRANCH IS WORKING FOR THEM.

NEW ADMINISTRATION IS WORKING FOR THEM AND THE LMPD HAS POLICIES IN PLACE AND YOU WANT SUPPORT.

I THINK CHIEF GENTRY TODAY, MY CONCERN IS THAT -- IS THAT THE CHIEF KNOWS THAT WE'RE ALSO WORKING WITH THEM, NOT AGAINST THEM.

WE HAVE ALL OF THE SAME.

WE WANT A BETTER LOUISVILLE.

I BELIEVE IN IT.

I THINK WE'RE GOING TO DO GREAT THINGS.

SHE MADE ME FEEL BETTER TODAY.

WANTED TO KNOW WHAT THE ISSUES WERE, WOULD THEY BE HARD TO IMPLEMENT.

SHE MADE IT CLEAR ARE THESE ARE THINGS THAT WE'RE DOING

[INDISCERNIBLE].

SO WITH THAT, I'LL BE A YES VOTE ON THIS.

WHEN WE GET TO THE STATE, I'LL -- WE LOOK AND TRY TO SUBMIT BEST PRACTICES.

WE'LL HAVE A LABOR DEVELOPMENT COMMITTEE COMING UP AND THE S.O.P. CONTRACT.

I'M HOPING THAT -- THAT -- BY THAT TIME OUR CHIEF CAN TELL US

ADDITIONAL POLICIES THAT SHE'S BEEN TALKING ABOUT SO WE DON'T CONTRACT, WE JUST GO TO THE VOTES AND THE [INDISCERNIBLE] WITH ANY POWERS AND I DO THINK IT IS IMPORTANT AGAIN FOR THAT MESSAGE FOR THE COMMUNITY TO LET THEM KNOW WHAT THOSE POLICIES ARE PUT IN PLACE, WHAT IS BEING DONE AND WHAT MATTERS.

WITH THAT I'LL VOTE YES.

COUNCILMAN COAN.

>> THANK YOU, I'LL BE BRIEF.

I WANT TO THANK THE COLLEAGUES THAT VOICED SUPPORT.

COUNCILMAN GREEN DECIDES TO BE A CO-SPONSOR IT IS GREAT.

THE MORE THE MERRIER.

I KNOW COUNCILMAN GREEN SAID THERE'S SOMEONE QUESTIONING

ABOUT -- SOMEONE QUESTIONED WHETHER OR NOT SHE MISSPOKE AND DID THAT.

EVERYONE WAS IN SUPPORT OF THIS, SHE CLEARLY SAID WE HAVE NOT

ENCOUNTERED ANY OPPOSITION FROM EITHER CHIEF GENTRY OR ANYBODY ELSE

BY THE THE SUBSTANCE.

WE ACKNOWLEDGE THERE'S DISCUSSION OVER THIS POLICY AND CODIFICATION QUESTION.

I PUSH BACK ON THIS NOTION OF OVERREACH OR REASSURE PEOPLE, DEPENDING ON HOW YOU SPIN IT, THAT THIS DOES PRESERVE ADEQUATE FLEXIBILITY FOR THE POLICE CHIEF.

I THINK COUNCILMAN FOX GAVE THE EXAMPLE OF WHEN WE SPOKE TO COUNCILMAN GENTRY, I TOLD HER YES, YOU COULD TELL HOW THE REPORTING REQUIREMENT

WORKS.

THAT'S TRUE.

THAT'S HOW THE LAW IS DESIGNED TO WORK WITH ADMINISTRATIVE POLICIES.

WE ENACT BROAD STATUTES THAT LAY OUT THE BROAD GUARD RAILS AND THEN

THE DEPARTMENT AND THE AGENCIES, THEY USE THEIR RULE MAKING PROCESS

TO PASS WHATEVER POLICIES THEY WANT SO LONG AS THEY'RE WITHIN THE

CONSTRAINTS OF THE LAW.

WITH RESPECT TO COMPREHENSIVE REPORTING AND WHEN PEOPLE POINT A GUN AT SOMEBODY.

IF SHE CHOOSES TO HAVE A POLICY THAT THAT IS INCLUDED IN AN ADMINISTRATIVE INCIDENT REPORT.

SHE RETAINS THE FLEXIBILITY THERE.

HOW TO INTERPRET IT AND UPDATE THE POLICY WITHOUT COMING BACK TO THIS COUNCIL FOR ANYTHING.

THERE ARE OTHER EXAMPLES OF POLICIES THAT I CAN'T IMAGINE THAT THERE'S ANY EXCUSE TO CHANGE.

I CAN'T IMAGINE YOU WHO NEED TO CHANGE A POLICY THAT SAYS WE USE A CONTINUUM OF FORCE OR THAT SOMEONE HAS A DUTY TO DE-ESCALATE SITUATIONS.

I'LL NOTE FOR PEOPLE THAT ARE TALKING ABOUT HOW SO MUCH OF THIS HAS BEEN DONE ALREADY, UNTIL RECENTLY WE DID HAVE A DUTY TO INTERVENE POLICY.

THAT'S ONE I WOULD GROUP WITH THE OTHER ONES AS A FUNDAMENTAL PROTECTION FROM EXCESSIVE USE OF FORCE.

WE DID NOT HAVE THAT UNTIL RECENTLY.

THAT'S ONE THAT SHOULD BE IMMUTABLE AND NONNEGOTIABLE.

OTHERWISE, I THINK THERE'S ADEQUATE FLEXIBILITY FOR THE CHIEF AND FOR THE NEXT CHIEF TO DO THEIR JOBS.

THIS IS NOT ABOUT CHIEF GENTRY WHO WE HAVE RESPECT FOR.

IT IS NOT ABOUT DISTRUST FOR THE EXECUTIVE BRANCH.

IT IS JUST ABOUT DOING WHAT THIS COMMUNITY NEED IN ORDER TO MAKE SURE THAT WE THE PUBLIC SAFETY SYSTEM THAT WE WANT GOING FORWARD.

THE TRUTH IS MY YES VOTE TONIGHT IS FOR THE FUTURE SO I DON'T HAVE
TO WORRY ABOUT THE NEXT CHIEF THAT MAY NOT BE GENTRY.

YOU KNOW, OUR CITY HAS CHANGED.

IT WAS A NICE PEACEFUL CITY WHERE WE DIDN'T HAVE PROBLEMS BUT SO MANY THINGS HAVE CHANGED IN THE LAST SIX MONTHS.

WE HAVE TO LOOK AT THAT.

I LOOKED IN MY COMMUNITY AT THE YOUNG PEOPLE RUNNING AROUND AND [INDISCERNIBLE] DOWN THE STREET.

THEY'RE GOING TO GROW UP.

WE DON'T WANT ANYTHING AS FAR AS I'M CONCERNED WHERE WE HAVE A NEW CHIEF COMING IN AND HE DECIDES WELL, I'M GOING TO CHANGE THIS.

IF WE PUT THIS -- THIS -- THIS IN PLACE AS A LAW AND IT IS GOING TO BE THE SAME LAW WHEN THEY GET OLDER, IT IS GOING TO BE THE SAME LAW WHEN THEY GET TO BE GROWN MEN AND I THINK THAT'S MORE IMPORTANT THAN ANYTHING LOOKING OUT FOR OUR YOUTH AND THE PEOPLE COMING UP.

BUT WE WANT SOMETHING TO PROTECT THEM AS THEY GET OLDER.

AND I -- I WILL BE VOTING FOR THIS.

AND I THINK THAT -- I'M HOPING EVERYBODY VOTES FOR IT.

I KNOW WE WON'T COMPLETE FOR EVERYBODY BUT I HOPE IT GOES THROUGH AND AS THEY GET OLDER, WE ALL MAKE MISTAKES AND WE NEED TO LOOK AT THAT TOO.

- I WANT TO START WITH THE HOMICIDE RATE.
- I SHARE THOSE CONCERNS.
- I THINK WHAT YOU'LL SEE HAPPEN IN SHORT OLDER IS HOLLANDER WILL INVITE
 PEOPLE TO TALK HOLISTICALLY ABOUT HOW WE MAKE INVESTMENT TO ADDRESS

CRIME PREVENTION.

I LOOK FORWARD TO THAT DISCUSSION AND HOPE EVERYONE WILL ENGAGE IN THESE EFFORTS.

IT IS A CRITICAL NEXT STEP TO TO ADDRESS THIS.

WE MAY NOT SEE THE OUTCOME OF THE INVESTMENTS FOR SEVERAL YEARS.

THAT DOESN'T MAKE THEM LESS IMPORTANT.

I LOOK FORWARD TO DISCUSSIONS OF THAT CRITICAL ISSUE.

TURNING TO THIS ORDINANCE SPECIFICALLY.

I'LL BE HONEST.

WHEN I WOKE UP THIS MORNING, I WAS A NO VOTE AND HAD CONCERNS ABOUT CODIFYING POLICY INTO LAW AND LEGISLATIVE OVERREACH.

I HAD CONCERNS ABOUT LIMITING FLEXIBILITY AND TYING THE HAND OF OUR NEW POLICE CHIEF.

I HAD CONVERSATIONS WITH GREEN AND OTHERS AND WATCHED THE TESTIMONY
OF THE COMMITTEE MEETING AND THOUGHT ABOUT DO WE CODIFY THE LAW?
WE CODIFY OF POLICY INTO TIME.

WE DID IT OVER THE LOCAL POSSESSION OF MARIJUANA AND DID IT WITH THE SEPARATION ORDINANCE.

ULTIMATELY WE AS THE LEGISLATIVE BRANCH ARE THE CHECK ON THE EXECUTIVE BRANCH.

WE HAVE A RESPONSIBILITY TO SET THE LAW.

AND THAT LAW DEFINES THE POLICY.

SO THE ONLY QUESTION REALLY BEFORE US SHOULD BE ARE THESE EIGHT ITEMS WORTHY OF BEING LAW?

DO WE THINK THEY'RE IMPORTANT THAT THEY DON'T GET CHANGED IN THE FUTURE.

I THINK IT IS HARD TO ARGUE WITH ANY OF THEM.

THEY'RE PRECISELY BECAUSE WE DON'T KNOW WHAT THE FUTURE FOR A MAYOR MIGHT DO IS WHY WE WANT TO CODIFY THEM.

I KNOW IT HAS BEEN SAID, COUNCILMAN GEORGE SAID THAT YOU KNOW, OUR LAWS ARE STATEMENTS OF VALUE.

I AGREE WITH THAT WHOLEHEARTEDLY.

I DO AGREE AND I THINK COUNCILMAN FOX MENTIONED WITH POLICY AND POLICE POLICY IN PARTICULAR, YOU WANT TO MAKE SURE YOU HAVE FLEXIBILITY AND ALLOW PEOPLE IT CHANGE QUICKLY AS TECHNOLOGIES EMERGE.

I AGREE WITH THAT COMPLETELY.

HOWEVER, EVEN AS TECHNOLOGIES EMERGE AND CHANGE, THEY GO BACK AND SAY OUR CORE VALUES ARE THE SAME.

THAT'S WHY AGAIN I THINK THEY NEED TO BE CODIFIED APPROPRIATELY BECAUSE THESE EIGHT ELEMENTS DO PROVIDE ADEQUATE GUARDRAILS.

I THOUGHT ABOUT THIS TOO.

WHAT ABOUT CODIFYING.

WE'RE NOT APPLYING NEW RESTRICTIONS ON POLICE.

THIS IS IN FACT NO WAY AN ANTI-POLICE MEASURE.

IT SIMPLY SAYS WHAT WE'RE DOING NOW IS IMPORTANT ENOUGH FOR US ALSO TO DO IN THE FUTURE.
