Vice Chair George, Councilwoman for District 21, stated that this project is a 50/50 match with Transit Authority of River City (TARC) for the Kenwood Drive, Colonial Gardens and Iroquois Park connectivity. The sidewalks are complete and have great reviews have been received from the community. The budget for this project went over by \$5,000.

Steve Kurosky with Public Works, stated that Transit Authority of River City will be responsible for \$2,500 over the cost being over budget. The \$5,000 over budget was due to large trees needing to be removed that was not in the estimate, as well as additional yard drainage needed, and an additional fifteen foot sidewalk gap needing to be added.
