You are correct - per our discussion at our last meeting, we discussed adding rock as a border in your Brightsites. We would add the border similar to the border at the Fern Valley Brightsite and Outer Loop Brightsite.

This is aesthetically more pleasing and more practical.

Adding all rock instead of mulch is not recommended because:

- 1. Mulch ground cover helps with weed and crab grass control a rock ground cover does not help
- 2. Weed barrier fabric is always necessary to install for weed control in an entire rock bed and will also add substantially to the cost
- 3. Mulch is more beneficial to the plant material because it breaks down and adds minerals and nutrients to the soil, which helps the plants thrive

Maintenance Agreement for July 2016 to June 2017

#### **Brightside will:**

- Monitor and assess site needs regularly
- Create a two foot border of large river rock around the site
- Apply hardwood mulch and reapply as necessary
- Trim all shrubs couple of times throughout the growing season
- Remove weeds at site on a regular basis
- Remove debris from curbs and bed area on a regular basis
- · Water site during times of drought, as needed
- · Apply herbicides and pesticides, as needed
- Apply Woodace 14-14-14 fertilizer, as needed
- Fall installation of additional plant material
- Maintain sponsor sign
- Mow grass bi-weekly
