REQUEST

Category 3 Plan for an addition to Horrigan Hall.

CASE SUMMARY/BACKGROUND/SITE CONTEXT

The Category 3 Plan is for construction of a 3-story, 54,000 sf. addition to Horrigan Hall including 3 floors of classrooms and offices and a mechanical room in the basement.

The FAR is below the max. permitted in the R-5 zoning district. The applicant has submitted elevations that meet building and site design standards. The 10% campus open space requirement will continue to be met through the track and field, soccer, baseball and other recreational areas on campus per the calculations provided on the plan. There are no landscaping or tree canopy requirements for this development because the percentage of development proposed falls below the threshold that would trigger it. Internal pedestrian connections will be provided, and the applicant has updated the parking summary for the overall campus that meets the minimum requirements.




