**A RESOLUTION UPDATING APPROVED NEIGHBORHOOD PLAN EXECUTIVE SUMMARIES AND ADOPTING THOSE EXECUTIVE SUMMARIES AS AN AMENDMENT TO PLAN 2040**

**WHEREAS**, the Metro Council and all jurisdictions with zoning authority within Jefferson county have adopted Plan 2040 as the comprehensive plan for all of Jefferson County; and

**WHEREAS**, the Metro Council have adopted 35 neighborhood plans in accordance with LMCO Chapter 161; and

**WHEREAS**, the Planning Commission and Metro Council have adopted these 35 neighborhood plan executive summaries as amendments to Cornerstone 2020; and

**WHEREAS**, the Planning Commission finds that these 35 neighborhood plans are in conformance with the Goals, Objectives, and Policies of Plan 2040; and

**WHEREAS**, the Planning Commission finds that these 35 neighborhood plan executive summaries should be updated with language identified in Section I of this resolution; and

**WHEREAS**, the Planning Commission finds that these 35 neighborhood plan executive summaries should be adopted as amendments to Plan 2040;

**NOW, THEREFORE, BE IT RESOLVED BY THE LOUISVILLE METRO PLANNING COMMISSION AS FOLLOWS:**
