

ORDINANCE NO. 141, SERIES 2016

AN ORDINANCE APPROPRIATING ~~\$8,250~~ ~~\$10,250~~ \$12,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS, IN THE FOLLOWING MANNER: \$2,000 FROM DISTRICT 13; \$1,000 EACH FROM DISTRICTS 25, 12, 8, 24, 15; \$750 FROM DISTRICT 6; \$500 EACH FROM DISTRICTS 14, 22, 17, 21, 6, 9, 25; \$250 EACH FROM DISTRICTS 3, 7, 20, 5, 10, 2, 16; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO ELDERSERVE, INC. FOR COSTS ASSOCIATED WITH THE MERGER OF ELDERSERVE AND GUARDIACARE. (AS AMENDED)

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$8,250~~ ~~\$10,250~~ \$12,000 is hereby appropriated from Neighborhood Development Funds, in the following manner: \$2,000 from District 13; \$1,000 each from Districts 25, 12, 8, 24, 15; \$750 from District 6; \$500 each from Districts 14, 22, 17, 21, 6, 9, 25; \$250 each from Districts 3, 7, 20, 5, 10, 2, 16; through the Office of Management and Budget, to ElderServe, Inc. for costs associated with the merger of ElderServe and GuardiaCare.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.


