We have only had time for a telecon but this is what I have gathered. Dr. Satavolu can correct me if I misunderstood.

- -BioProducts will take distillery waste and make Xylose & fertilizer. Processes at this site would be low temperature and low pressure (<100F/100psi)
- -I did not perceive that they would be making BioCoal at this site. I imagine that would require higher temperature and pressure and we would be interested in what their design code would be if they start such processes.
- -They promise no odors or loud noise.
- -They plan to meet with the folks at Axis.
- -They expect 4 trucks a day on first shift. If they expand to 2 shifts, no trucks will come at night.

We have posted to our SM and have not heard any objections at this time.
