# CERTIFICATION OF SURPLUS PROPERTY



# **EXHIBIT A**

## POND/KNOB CREEK PROJECT PARCEL NO. 18

A tract of land located south of Kentucky Highway 44, one-half mile, more or less, east of Dixie Highway and lying in both Bullitt and Jefferson Counties, Kentucky, more particularly described as follows:

BEGINNING at the northwest corner of the Albert and Gertrude Hiner Abel tracts, described in Deed Book 58, Page 354 Deed Book 57, Page 614, and Deed Book 75, Page 420, in the Office of the Clerk of Bullitt County, Kentucky, and also Deed Book 2121, Page 460, in the Office of the Clerk of Jefferson County. Kentucky, said point being in the Center of the Old County Road; thence S 46° 27' 10" E, with the centerline of said road and the northern line of said tract, 2,327.48 feet to a point in the west right of way line of the Louisville and Nashville Railroad; thence with said right of way line and the east property line of said tract the following courses: S 44° 29' 21" W, 905.14 feet; S 45° 28' 12" E, 1.12 feet; along an arc concentric to the centerline of said railroad 485.24 feet to the left. having a radius of 1.472.69 feet, the chord of which is S 35° 05' 27" W, 483.05 feet; thence leaving said right of way line S 44° 29' 21" W with said east property line 490.96 feet to a point; thence N 46° 23' 26" W, with the south line of said tract, 1,954.47 feet to a point in the bed of Pond Creek; thence with said bed, the following courses: N 16° 06' 34" E, 165.83 feet; N 19° 51' 34" E, 168.30 feet; N 5° 21' 34" E, 339.90 feet; N 14° 03' 15" E, 472.87 Feet; N 39° 21' 34" E, 201.30 feet; and N 58° 06' 34" E, 713.72 feet to the point of beginning, excepting 3.473 acres dedicated for public use.

The property described above contains 99.795 acres, more or less, of which 3,473 acres has previously been dedicated for public use.

### POND/KNOB CREEK PROJECT Parcel No. 48

A parcel of land located at Stites Station in Bullitt County, Kentucky, north of Kentucky Highway 44 and adjoining the west right of way line of the Louisville and Nashville Railroad, more particularly described as follows:

BEGINNING at the southeast corner of the Otto Moore and Thelma Dodge property, as described in Deed Book 67, Page 437, in the office of the Clerk of Bullitt County, Kentucky, at the intersection of the centerline of the old county road and the west right of way line of the Louisville and Nashville Railroad; thence N 46° 27' 10" W, with the south line of said tract and the centerline of the old county road, 74.01 feet to a point; thence N 44° 29' 21" E, leaving the old county road and following the west line of said tract, 319.72 feet to a point; thence S 47° 26' 24" E, with the north line of said property 74.04 feet to a point in the west right of way line of said railroad; thence S 44° 29' 21" W, with the east side of said tract and said right of way line 321.00 feet to the point of beginning.

# POND/KNOB CREEK PROJECT Parcel No. 281

BEGINNING at a point in the southwest corner of the Oscar Finley and Elmer Pellman tract (under Deed of Contract with Westpoint Development Company, Inc.), said point also being in the north right of way line Kentucky Highway 44, and the east right of way line of the Louisville and Nashville Railroad; thence with the west line of said tract and east right of way of said railroad N 44° 29' 21" E, 908.38 feet to a point, said point being their intersection with the centerline of Weavers Run Road; thence south with said centerline along an arc 183.59 feet to the left, having a radius of 326.92 feet, the chord of which is S 10° 12' 12" W, 181.18 feet; thence continuing with said centerline S 5° 53' 03" E, 755.83 feet to a point in the north right of way line of said Highway 44; thence with said right of way line, the following courses: along an arc 54.43 feet to the right, having a radius of 2,834.79 feet, the cord of which is N 68° 48' 34" W, 54.43 feet; thence N 68° 15' 34" W, 464.31 feet; thence N 21° 44' 25" E, 10.00 feet; thence N 68° 15' 34" W, 219.23 feet to the point of beginning.
