Board of Zoning Adjustment Members,

This letter is submitted in connection with the above referenced application for the proposed construction of an anaerobic digester and methane production facility. STAR BioEnergy LLC, a STAR Holdings subsidiary company, is requesting approval for a Conditional Use Permit (CUP) for the construction of its first anaerobic bio-digester and methane production facility at 821 South 17th Street, 40210.

With strong objection to this development and the approval of the CUP, this letter is a formal request to this Board of Zoning Adjustments committee, to deny approval of the CUP for the Anaerobic Bio-digester, methane plant facilities and other related structures proposed at the location referenced above or other populated locations within West Louisville. As well, please deny any other approval requests for variances or waivers submitted by STAR BioEnergy LLC, Star BioEnergy Holdings LLC, Nature's Methane LLC, Nature's Methane Holdings, Nature's Methane Holdings I LLC, NM Holdings LLC, NM Holdings I LLC, Nature's Methane Group I LLC, STAR Distributed Energy LLC, STAR Energy Holdings LLC, STAR Energy Holdings I LLC, Jefferson AD I LLC, Jefferson AD II LLC, Jefferson AD III LLC, Farmer's Methane, Farmers Renewables LLC, and any related company, for the construction of a facility used to receive food waste or produce any type of gas product within West Louisville. For reference, these Indiana business registrations are attached.

The applicant has been identified with so many different business names that it is difficult to be sure, what entity is responsible for this application, its operations or the promises to this community. So, Why have they had so many different names and when will it change again? Are they running from problems, or lawsuits?

Mayor Fischer and his staff have spent many of our tax dollars, in payroll time, to be a champion for this project and this company (operating under former and current names) that we really know nothing about. There are too many questions still to be answered (i.e. name changes, who is the actual owner, status of the lawsuit pending in St. Louis that names Nature's Methane). This city also needs to know why Mayor

Fischer is so supportive of this project when it does not promote the economic growth of the residents or the economic development in West Louisville. This project only benefits a select few large corporations which will reap huge profits and will not suffer any detriment. This added danger to this community and the on-going horrible air quality in this community must be strongly considered, respecting the community that will be affected with negative outcomes for many years to come.

Louisville Metro's Land Development Code states:

**Chapter 4 Part 2
Conditional Uses**

4.2.1 Intent and Applicability

*"Certain land uses due to their extent, nature of operation, limited application, or relationship to natural resources are considered as exceptional cases. The uses listed in this Part may be permitted in certain districts by Conditional Use Permit following a public hearing before the Board of Zoning Adjustment **provided such uses will not have an adverse effect on neighboring property**, are not in conflict with the goals and plan elements of the Comprehensive Plan, **the proposed uses are essential to or will promote the public health, safety, and the general welfare in one or more zones**, and are in compliance with the listed standards and requirements".*

4.2.42 Potentially Hazardous or Nuisance Uses

*The following uses (manufacture, processing, treatment, or storage unless otherwise specified), having accompanying hazards such as fire, explosion, noise, vibration, dust, or the emission of smoke, odor, or toxic gases may, if not in conflict with other laws or ordinances, be located in **industrial zones** as indicated below by Conditional Use Permit after the location and nature of such use shall have been approved by the Board of Zoning Adjustment. In reviewing an application for a CUP, the Board of Zoning Adjustment shall review the plan and statements of the applicant and the following:*

A. The Comprehensive Plan;

*B. **Environmental and health related concerns raised by the operation and the applicant's proposal to mitigate any adverse effects to the public's health, safety and general welfare;***

C. The applicant's site design, buffering, and security measures and their adequacy to mitigate any adverse effects to the public's health, safety and general welfare;

D. Any other evidence submitted by the applicant and any other party addressing the issues.

A Conditional Use Permit under this section shall be issued only if the evidence shows the applicant's operation and associated nuisances will be properly managed and the public's health, safety and general welfare will be protected. The Board of Zoning Adjustment may impose additional conditions to protect surrounding properties. All Conditional Use Permits under this section shall be issued subject to the applicant also receiving all necessary permits from local, state and federal regulatory agencies.

It is understood this location carries a zoning designation of "EZ1", in a "Traditional Workplace" Form District. However, while it is a huge risk to allow an experienced entity to build such facilities in a highly dense residential area, it is an enormous risk to allow an un-experienced entity that has no history of owning or operating such a facility in any urban area! The executives/owners have clearly stated, they (as Nature's Methane Holdings) have never developed a digester facility. Why should West Louisville be subject to more risk and waste or be their inaugural test ground? Do not risk with the burden of another mess if these applicants pack up and run again!

One example of an existing facility, referenced by the applicant, as in "Louisville's Own Backyard", is the Morris Forman Water Quality Treatment Center. On any given day, take a drive near this facility, enjoy that disgusting smell! For decades, West Louisville residents have and continue to live without

being able to take a breath of fresh air. It is unfair to continue to add more plants such as this in this community!

Statements and projections made by the applicants have been all over the board. It is unclear, even to who the applicant is, what the project really is or what it will become. Bio-Energy is a process that gets a lot of buzz. When the words "Bio", "Green", "High Tech", "Organic", and "Renewable" are stated, people hear these words; they perk up and applaud it, without understanding what they are applauding!

Organic Material: Something that was living and can decay. Wasted or spoiled food, plant clippings, animal manure, meat trimmings, and sewage are common types of organic material used with anaerobic digestion.

The applicant has admitted that there will be odor, there will be noise, and trucks will require washing before leaving the proposed facility (Fact VS. Myth by Nature's Methane Holdings).

All unbiased research will state the pros-and-cons of the anaerobic digestion process; however, those who make money from the process, or those who only want support for the process, will only state the pros. That is exactly what the executives and owners have done to miss-lead the community and this committee.

Imagine, in your own neighborhood; large tanker trucks transporting waste to an unsightly industrial plant that houses and stores multiple sources of decaying material, prior to being placed in huge unsightly steel tanks, 42 feet tall and 70 feet in diameter, holding 1.5 million gallons of waste!

The proposed location of this development is very ill considered. It is in the midst of a highly dense residential area, very close to churches and a school, where many neighborhood residents walk. It is near some of our city's highest traffic routes. While our city's building code for this area does not specifically exclude this type of development, this does not dismiss the fact that the location of a facility such as this will create a private nuisance for the community. As well, it will create long-term external issues.

This development provides no benefit to the immediate area or to West Louisville as a whole. It only further degrades the quality of living or working in the area. While West Louisville suffers the consequences, the benefit goes to the companies, their executives and owners that will line their pockets with profits. These same people do not have to live with the consequences on a 24/7 basis.

Furthermore, the risks and consequences these projects present for West Louisville and its residents are enormous. Storage of waste and the safety concerns associated with methane production facilities, in a highly populated/dense residential area, is unhealthy, stressful, and it brings with it many other environmental and health hazards. The waste required for this methane production will be transported through the streets and neighborhoods of West Louisville. Thereby, creating even more dangers, health and environmental related issues.

There are many discussions taking place around the world regarding the dangers and risks of Methane Gas and negative effects that Methane Gas creates. Methane is highly explosive and it can cause death by asphyxiation. Scientific research has revealed that methane can form an EXPLOSIVE mixture in air at levels as low as five (5) percent. While these dangers and risks are discussed, the regulations remain few.

Unbiased professionals should be consulted so the reality is exposed. I wish people such as the professional engineer who kindly posted a comment in the Courier Journal would help everyone understand reality, from experience. This is his comment:

“I am a registered professional engineer and have designed and built leading anaerobic digestion plants in the U.S. and Europe. Anaerobic digestion plants generally produce horrid odors and even the best ones cannot avoid it. If the west end plant is not operated and maintained well, the odors will drive away people, business, and community pride. I think this is a very good idea in the wrong location. This plant belongs in an industrial park.”

Petitions have already been submitted, containing thousands of signatures in opposition of this project.

I am extremely concerned; this could be the beginning of more facilities, such as this, obtaining approval and developed in West Louisville.

West Louisville, has mostly an African-American and white working class population. It has long suffered the ill effects, both environmental and health, of former Black Leaf chemical site, Rubbertown’s host of toxic chemical plants, Morris-Forman water quality treatment center.

Mayor Greg Fischer has labeled this his “Legacy Project”! That is an insult to this community. Maybe his legacy is to continue dumping on West Louisville!

Consider strongly about the expanded/indirect issues such as leaking or dirty trucks traveling through neighborhoods, the type of waste that will be transported in and stored, the smells, rodents and other pest the waste will draw, the decline in property values.

In fact, the residual left from chemical plants and other bad environmental conditions of the past is still affecting West Louisville residents.


The Kentucky Center for Health, Environment and Justice Report lists several actions that describe the past and ongoing fight to remediate the ill effects caused by chemicals, contaminations and unhealthy environmental conditions in West Louisville.

Be serious about planned redevelopment of vacant, abandoned and under-utilized properties in West Louisville. Redevelopment should enhance the community, create meaningful employment opportunities for residents, create pride, and create an environment where people will enjoy fresh air, where the type of business locates, bring jobs and where fresh goods and services are convenient; rather than degrade the community and the quality of life therein. West Louisville deserves better planning, better redevelopment and real economic growth for its residents!

I urge Mayor Fischer and everyone else, to consider strongly the risks, negative effects and conditions that a single anaerobic digester and methane production facility in West Louisville would create.

Please deny this Conditional Use Permit!

West Louisville Food Port's biofuel company in trouble over similar St. Louis project

Nature's Methane LLC, a company that is set to build a facility at the West Louisville Food Port, has found itself in legal trouble over a similar project in St. Louis.

The company, a subsidiary of Markle, Ind.-based Star Distributed Energy LLC, had plans to build an anaerobic digester, which turns food waste into methane gas, in St. Louis as part of a private project called FarmWorks. Plans for FarmWorks also included an aquaponics facility, a fish farm, the digester, a green business incubator, a community education component and a transitional home for ex-offenders who would work at FarmWorks. The home was built, but nothing else, the St. Louis Post-Dispatch reported.

The project went south in fall 2014, when Massachusetts-based engineering firm **GEI Consultants Inc.**, Cornerstone Concrete Construction Inc. and Klitzing Welsch Associates Inc. filed \$710,599.45 in mechanics liens, claiming that Nature's Methane failed to pay for work the company completed.

Nature's Methane is the company that has committed to construct and operate an anaerobic digester at the West Louisville Food Port, a 24-acre food-centric project between Market Street and Muhammad Ali Boulevard at 30th Street. The food port is a public-private partnership led by Seed Capital Kentucky Inc., a nonprofit organization that supports the local food economy and regional farmers.

The digester facility is estimated to cost \$27.4 million. In December, the **Kentucky Economic Development Finance Authority** granted preliminary approval for \$2.1 million in state tax incentives for the project. The incentives are given only once a company has created jobs.

[Caroline Heine](#), project director for the West Louisville Food Port, said she was unaware the allegations against Nature's Methane and declined to comment on the matter.

So far, Seed Capital Kentucky has raised \$3.5 million toward the first phase of the West Louisville Food Port project, which is estimated to cost \$30 million, Heine said. The nonprofit expects to find out about about \$5 million to \$6 million in federal New Markets Tax Credits later this month or in early June. "We are continuing to make steady progress," Heine said.

Progress stalled on FarmWorks

Not long after GEI Consultants filed the liens, the FarmWorks property was foreclosed on, a lawsuit in St. Louis Circuit Court states. The lawsuit was filed by Percheron Investment Management LLC, a Missouri-based company that purchased the property out of foreclosure.

The suit was filed against several parties involved in the FarmWorks project. In the lawsuit, Percheron argues that the mechanics liens render the property valueless. In addition to more than \$50,000 in relief for damages, Percheron

asked in the suit that the court deem the liens invalid and rule that only Percheron owns interest in the property.

The company also alleged in the lawsuit that Steve Estes, owner of Star Distributed Energy and its subsidiaries, committed fraud by authorizing GEI Consultants to begin work on the FarmWorks property even though he did not have the authority to do so. Percheron backs GEI Consultants' claim that Nature's Methane owes the engineering firm more than \$700,000.

Estes and his companies have denied all the allegations against them, according to court records. Estes told the St. Louis Post-Dispatch that the lawsuit is "frivolous" and that the liens resulted from FarmWorks' financial problems "that blew up around me." Estes could not be reached for comment.

Separate from the liens, property owner Hammond Building LLC had failed to make payments on a bank note, the suit states.

Earlier that year, developer Craig Heller, the head of Hammond Building LLC, defaulted on \$12 million worth of bank loans, reported the St. Louis Business Journal, a Business First sister publication. Heller could not be reached for comment. The number listed for his company had been disconnected.

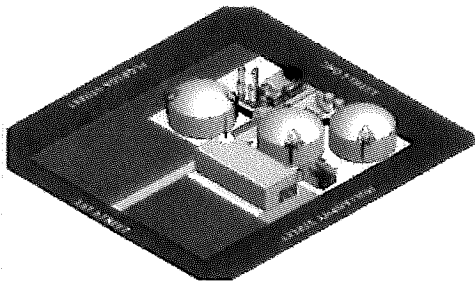

Property dispute stalls FarmWorks project

A property dispute stalling FarmWorks, an urban agriculture project north of downtown, could complicate plans for an NFL stadium on the St. Louis riverfront.

FarmWorks, at Cass and Collins avenues, is on the northern edge of the 35-block area proposed as the site of a 64,000-seat open-air stadium meant to keep the Rams in St. Louis or lure another NFL team to the city.

At least part of the FarmWorks project appears unlikely to proceed. It was promoted as a center of aquaponics, hydroponics and vertical growing systems at a complex of old buildings. Also planned was an indoor fish farm and a "green" business incubator.

So far, the only FarmWorks facility completed is the successful Stamping Lofts project of 56 apartments opened in 2013 in a renovated sheet metal plant built in 1870. Residents are ex-offenders and others, many of whom were to be trained to run FarmWorks' operations.

Stamping Lofts is separate from the dispute between the lender who foreclosed Dec. 29 on much of the FarmWorks site and a company that was to have built a facility to produce methane fuel from food scraps.

Work on the methane producer, called an anaerobic digester, began about a year ago but soon halted. Last fall, contractors on the project filed more than \$700,000 in mechanic's liens against the property, contending they had not been paid.

Percheron Investment Management, which had foreclosed on previous owner Hammond Building LLC, filed suit Feb. 6 to void the liens, contending they make the property worthless.

Larry Callahan, head of Clayton-based Percheron, said Friday that Nature's Methane, the Markle, Ind., company behind the FarmWorks digester project, never had Hammond Building's authority to begin the job. He added that Steve Estes, chief executive of Nature's Methane, had made assurances that the digester project was financed and that no liens would be filed.

Estes said Percheron's suit was "frivolous" and added that the liens resulted from FarmWorks financial issues "that blew up around me." He added that he hoped to build an anaerobic digester at another St. Louis site.

Developer Craig Heller, who began FarmWorks about four years ago, did not return calls seeking comment.

Callahan said FarmWorks might proceed if the lien disputes were resolved but added that the indoor fish farm part of the project now seemed "overly ambitious."

Overlaying FarmWorks is the site of the proposed stadium. Preliminary plans show FarmWorks replaced by parking.

Doug Woodruff, president and chief executive of the Downtown STL booster group, is feeling out owners of stadium-site property on behalf of the St. Louis Regional Convention and Sports Complex Authority. Woodruff said he had discussed with Callahan an option to buy the FarmWorks site if the stadium project proceeded. Woodruff noted that property disputes complicated land transactions.

"Those parcels will be longer and harder to sort," he said.

If the Stamping Lofts building is acquired for the stadium project and demolished, a replacement facility would figure into the purchase price, Woodruff said.

"Its all contingent," he noted. "If we don't have a stadium, nothing happens."

FarmWorks project in north St. Louis begins second phase

Now that Craig Heller has finished a housing development in a complex of old factories and vacant lots north of downtown St. Louis, the developer plans to move forward on the project's second phase: installing a fish farm and other urban agriculture operations.

Heller said he hoped to have the entire project, dubbed FarmWorks, operating by early next year.

The developer said the urban agriculture portions of the project, at First Street and Cass Avenue, would cost about \$7.5 million. The completed housing development, a renovated former sheet metal factory built in 1870, cost \$9.8 million.

The housing development, called Stamping Lofts, comprises 56 studio apartments for ex-offenders, homeless veterans and others, many of whom will be trained to help run FarmWorks.

Residents pay 30 percent of their monthly income in rent, up to a maximum of \$473, a leasing official said. The lofts, opened in February, already have 16 residents.

As the newspaper previously reported, a main component of FarmWorks will be an "aquaponics" fish farm inside a building adjacent to the four-story Stamping Lofts. Gardens will fill vacant lots on the 4.5-acre site. A "green" industry business incubator will focus on food processing and distribution to area restaurants and groceries.

Gateway Greening, a nonprofit provider of community food programs, will help direct FarmWorks' production and train Stamping Lofts residents to grow and market food. St. Patrick Center workers will screen potential residents and provide job placement. Officials expect that most Stamping Lofts residents will move within a year as they gain job skills that will lead to other employment.

Stamping Lofts construction suffered a setback 13 months ago when high wind toppled part of an exterior brick wall. Workers had to stabilize, then rebuild the area that collapsed. The building, once the home of St. Louis Stamping Co., is on the National Register of Historic Places.

The housing project's financing came from the sale of federal and state historic preservation tax credits, plus low-income housing tax credits issued by the Missouri Housing Development Commission. The St. Louis Equity Fund and Pinnacle Entertainment bought the tax credits. Pinnacle's \$2 million investment was part of its redevelopment agreement with the city over construction of Lumière Place, which is about six blocks south of FarmWorks.
