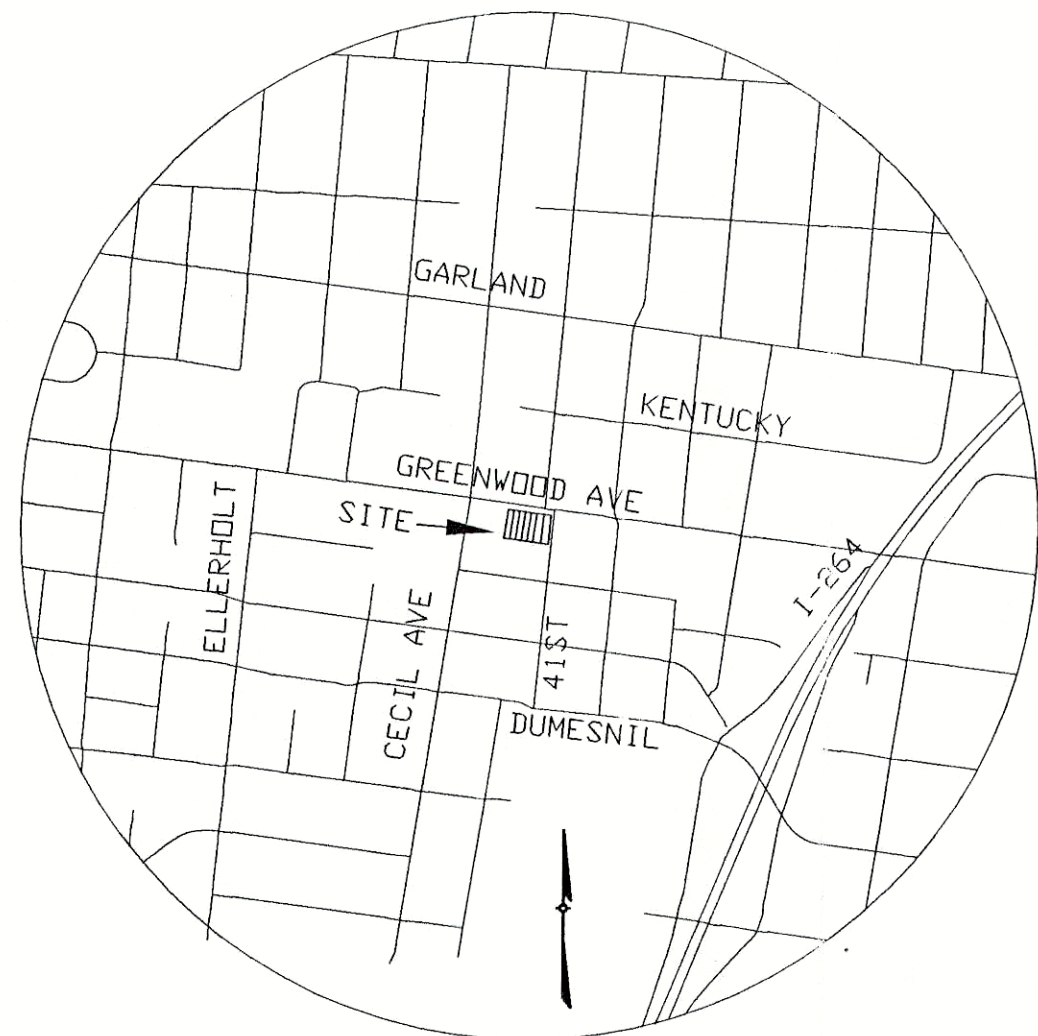

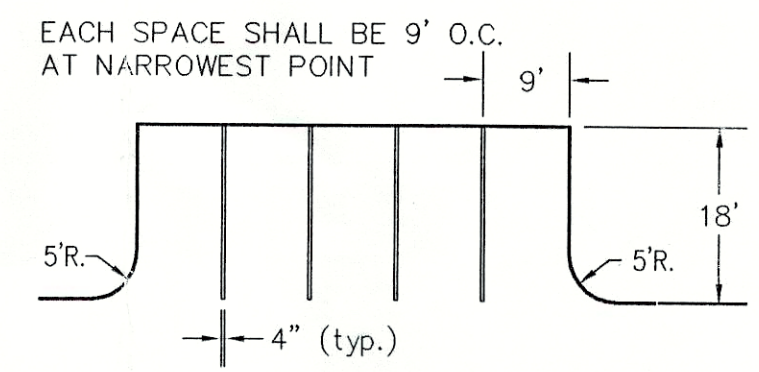
CONDITIONAL USE DESCRIPTION

BEGINNING AT THE NORTHEAST CORNER OF THE PROPERTY CONVEYED TO CHRISTAL WILLIAMS IN DEED BOOK 7473, PAGE 166 IN THE JEFFERSON COUNTY COURT CLERK'S OFFICE, SAID POINT BEING IN THE SOUTH RIGHT-OF-WAY LINE OF GREENWOOD AVENUE AND BEING 40.00' WEST OF THE WEST RIGHT-OF-WAY LINE OF CEMETERY DRIVE; THENCE LEAVING SAID SOUTH RIGHT-OF-WAY LINE OF GREENWOOD AVENUE S05°56'38"W, 150.00 FEET TO A SET IRON PIN IN THE NORTH RIGHT-OF-WAY LINE OF A 15' ALLEY; THENCE WITH SAID NORTH RIGHT-OF-WAY LINE N82°34'04"W, 167.04 FEET TO A SET IRON PIN; THENCE LEAVING SAID NORTH RIGHT-OF-WAY LINE N 08°43'52"E, 65.56 FEET TO A POINT; THENCE S80°43'48"E, 52.10 FEET TO A POINT; THENCE N09°16'12"E, 86.09 FEET TO A POINT IN THE SOUTH RIGHT-OF-WAY LINE OF GREENWOOD AVENUE; THENCE WITH SAID SOUTH RIGHT-OF-WAY LINE OF GREENWOOD AVENUE S82°33'43"E, 106.83 FEET TO THE POINT OF BEGINNING AND CONTAINING 0.460± ACRES.

90° PARKING LAYOUT

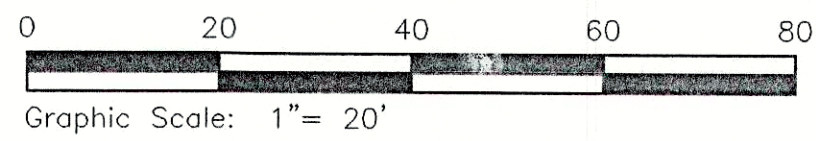

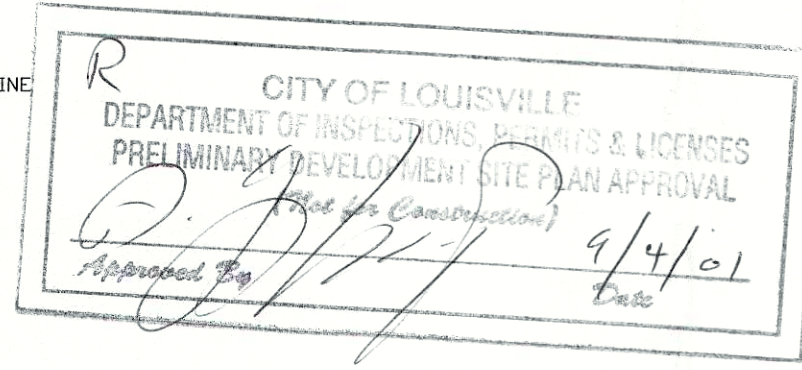

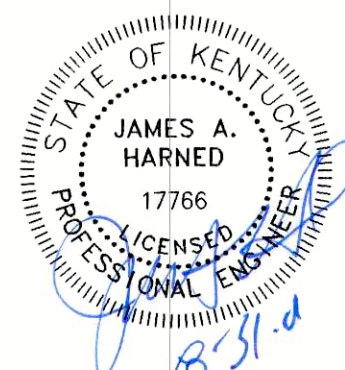
