The following was discussed:

- Department of Justice ("DOJ") will conclude the Patterns and Practices investigation in the next 12 months or so regarding what they saw, what the deficiencies were and where they came from, and how to improve
- Whether DOJ would put in writing that they will accept some of the inactive steps being suggested to shorten the term of the Consent Decree
- What the monitoring will look like
- Required training for LMPD Officers
- Accountability Improvement Bureau
- Whether there would be one central facility or several throughout the city
- Any data regarding residents from other cities that have made these same investments feeling safer, and whether there is measurable crime reduction
- Which agencies provide the reform staffing and monitoring personnel, and whether current staff can be taught via a national program to fill the roles
- Monitoring system
- Oversight for training
- Funding the reform for about four years at \$8M to \$10M per year
- Requirements and qualifications for Inspector General came from other cities with Consent Decrees
- Whether the \$8M to \$10M is eligible for funding from the American Rescue Funds
- Some of the investments will not go away when the obligation ends because they are improvements for the LMPD
- Goal is to make the city safe, combat violent crime, and protect Constitutional rights at the same time
