

ORDINANCE NO. 153, SERIES 2019

AN ORDINANCE APPROPRIATING ~~\$1,500 \$2,300 \$5,300~~ \$6,100 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,500 FROM DISTRICT 8; \$1,000 FROM DISTRICT 26; \$500 EACH FROM DISTRICTS 1, 4, AND 10; AND \$300 EACH FROM DISTRICTS 4, 2, AND 21; \$250 EACH FROM DISTRICTS 7 AND 12; AND \$200 EACH FROM DISTRICTS 3, 6, 14, 15, AND 17; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO LOUISVILLE PRIDE FOUNDATION, INC. FOR COSTS ASSOCIATED WITH THE FIFTH ANNUAL LOUISVILLE PRIDE FESTIVAL ON SEPTEMBER 21, 2019 (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$1,500 \$2,300 \$5,300~~ \$6,100 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,500 from District 8; \$1,000 from District 26; \$500 each from Districts 1, 4, and 10; and \$300 each from Districts 4, 2, and 21; \$250 each from Districts 7 and 12; and \$200 each from Districts 3, 6, 14, 15, and 17; through the Office of Management and Budget, to Louisville Pride Foundation, Inc. for costs associated with the fifth annual Louisville Pride Festival on September 21, 2019.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
