On 8/8/22, Christina Tomasulo with MSD stated:

"I spoke to Mr. Sample a little while ago and we discussed the landscaping around the pump station. I advised him that MSD does not have a landscaper on staff or under contract for pump station properties and our crews have priorities of sanitary treatment, flood protection, and storm water drainage. Saying that, I have asked our Collections System and Emergency Response Manager (Jeremy Goodwin) to call him to discuss what we can and cannot do to the site. We also discussed MSD service levels and how they apply to all of Louisville Metro equally. Mr. Sample was appreciative of the information and he has my contact information if he has any future questions or concerns."
