PRESIDENT YATES: First of all, thank you. I am honored and privileged to accept your vote as the president of the Metro Council. I give you my word that I will do everything that I can to lead with integrity and to make each one of your jobs' better.

I look around this room and I see colleagues. I also see friends. I had a football coach that told me after four years of working and sweating together you become family. Guys, we work, we sweat, we have cried together, we have shared experiences together. And at the end of the day, we have the same goal, public service.

I want to thank my daughters. They are getting to be big girls, but they are still babies. This is Ava and this is Grace. You have all seen them since they were one years old. They are my driving force. When I come on, I think about how to make the city a better place and I think about them. Sometimes I get so frustrated and I beat my head against the wall. They are the reason that I want to serve in this capacity and they help my ability to understand. I am so grateful for these babies.

Behind me is my father, my grandfather, and my uncle Jim. All know a lot about public service. My grandfather has been in the house for 23 years. I was a young attorney at the AG's office assistant attorney general and went to work for companies when he came to me and talked about public service and giving back. And we had a long conversation about how I was fortunate enough to have some scholarships, to have gotten my law degree, got some experience. And he was the push to make me decide to file to run for office, and really my hero growing up because he always had the highest levels of integrity. It means a lot for him to be here today. I am honored to have the help of people like my grandfather. And it wasn't long ago in May that my mother passed away. We talk about family. Y'all reached out to me in the worst year of my life. I didn't know if I was going to make it through it. Yesterday was her birthday, and I thought when she passed, what do you do? How do you carry their memory on? And I thought honor. And so that's what I plan on doing. And in this capacity, she is probably the only individual I know that DVRed every single one of our meetings and watched them back. And because of that, it pushes me to want to do good for the community.

I have butted heads with almost every single one of you. I have also hugged and shook hands with you as well. I look forward to working with you. I know that you wouldn't be in this capacity, I know you wouldn't do this job, you wouldn't want to do this service if you didn't care about your community. Please utilize me. I will humbly serve as your president. I don't pretend to be a know-it-all. I ask for each of your help. I know we are so diverse. Each one of your seats represents a different spot on the city of Louisville. It represents more than that, the individuals who have faces out there, and they need us and lean on us and together we will make it a better place.

Last year we did a lot. Next year we have more challenges. Whether if we are dealing with -- last year was the MSD with the flooding issues, putting together more paving dollars. Every one of us gets a phone call about the grass and the issues you see year after year. But with the public safety, the pop-up parties, we may have saved some lives.

The cameras on each one of our officers, you talk about transparency and accountability, those big key words, we lead in that.

And it also gives them some backing. I have a young officer who is proud to have that because it gives him some backing.

We led the nation, the first syringe exchange program. I knew that was a political hot-button when we came into it. And we all got together and voted unanimously because it was needed because we had a heroin epidemic. We put aside any of our political issues and we did what is best for our community, and I just applaud you and I know we can do that when we come together.

We are going to have a lot of work ahead of us. Our good friend Jim King, he used to always say, it wasn't work, it wasn't problems, it was opportunities. Do you remember him saying that? That we had a lot of opportunities ahead of us. When I was thinking, I wanted to remember one thing that Jim said when he came down on the floor, and he said, I quoted it, my election as president puts me in a position of service to you, since any power the president has is drawn from you. I remember him coming down and saying that. And I thought it was humble, but he believed it. And it meant a lot. And I promise you I meant it as well. I am pleased to work out. Please work with me. And together we can accomplish a lot. I look forward to working with you, and I am so humbled by your support and your confidence. Thank you.

For all you listening out there tonight, I hope you have heard the news, but if you have not, I am proud to let you know Star Energy has withdrawn from asking for a conditional use permit, which is wonderful. Again, there will be no meetings on the 14th, as scheduled, by Star Energy. And as far as I know, there will not be a BOZA meeting because they have withdrawn their proposal.

So I'm just saying this, people. When people unite, they cannot be defeated. I thank everybody out there for their support and help. It was a coalition of people. This should never have been in our residential

neighborhood, and we didn't allow it, and we sent a strong message to the administration. Please, sir, don't bring any unwanted economic development to West Louisville. Thank you.

PRESIDENT YATES: Thank you, Councilwoman. Thank you for your leadership on that.

COUNCILMAN OWEN: Thank you, Mr. President. Two announcements real quickly.

I think you will get that rhythm that once a month I have a Talk with Tom in my district. Normally it is the last Saturday of the month. Actually, starting out the first month of the year, it is going to be the Talk with Tom on Saturday the 23rd of January. And it will be from 9:00 to 11:00. The way I do it, Mr. President, I start in the outer edge of my district and I work my way along coffee shops along Bardstown Road, Baxter, all the way to Broadway. So I'm starting at the Waterton Expressway at Heine Brothers Coffee. The Talk With Tom will be from 9:00 to 11:00 on the 23rd of January.

The Tyler Park Neighborhood Association has an annual event that is really very popular, and that is a wine tasting that is held in Mid City Mall, and it will be from 4:00 to 6:00 on January the 31st that Sunday afternoon. That's the Tyler Park Neighborhood Association wine tasting on January 31st from 4:00 to 6:00. Thank you very much.

COUNCILMAN MULVIHILL: Thank you, Mr. President. And congratulations.

Councilwoman Butler and I are hosting a Naloxone training, and it will be known as train the trainer course. Folks may be wondering what that is, but it is a course that trains community members how to administer Naloxone, and this drug is used to counteract heroin or other opiate drug overdose. It really is an important tool because it is a life-saving tool. And we are going to host this training. It is going to be held January 26th, 2016, from 6:00 to 8:00 p.m. at Eastern Parkway

Baptist Church. The training is being conducted by the Kentucky Harm Reduction Commission.

To anybody that has any interest in learning more about this and if they want to call our office, they can too ahead of time to let us know, but we welcome anybody who would like to know more about Naloxone. Thank you.
