The following was discussed:

- Question about the purpose of the no mow areas
- The no mow areas reduces the emissions caused by continuous mowing
- Question about whether moving the main headquarters to Charlie Vettiner Park is still in the future
- The Energy Project Assessment District (EPAD) money is still available for residential, business and commercial use
- The Springhurst Tennis Club used the EPAD Program to do energy efficiency improvements for their building, HVAC improvements and operational improvements for efficiency
- The application for the EPAD program is on the Develop Louisville, Advanced Planning and Sustainability website
- Question about whether other departments are still using Louisville Metro Government's power
- With the EPAD program there would be savings with renewable energy within the city
- Question and concerns about the data gathering that would be needed to do an assessment of our street lights to be converted to LED street lighting
- There are over 22,000 lights that would need to be checked to see about converting them to LED lighting
- Question about what would need to happen to implement a energy improvement plan for long term goals

Council Member Hollander stated that this would be a good project to use some of the American Rescue Plan Funds on.
