AN ORDINANCE APPROPRIATING ~~\$20,000~~ ~~\$25,500~~ \$34,500 FROM DISTRICT 26 NEIGHBORHOOD DEVELOPMENT FUNDS, IN THE FOLLOWING MANNER: \$20,000 FROM DISTRICT 26; \$7,500 FROM DISTRICT 7; \$5,000 FROM DISTRICT 9; ~~\$500~~ \$2,000 FROM DISTRICT 18; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE WAGGENER WILDCAT BOOSTER CLUB, INC. FOR THE RENOVATION OF THE TRACK AT WAGGENER HIGH SCHOOL (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$20,000~~ ~~\$25,500~~ \$34,500 is hereby appropriated from District 26 Neighborhood Development Funds, in the following manner: \$20,000 from District 26; \$7,500 from District 7; \$5,000 from District 9; ~~\$500~~ \$2,000 from District 18; through the Office of Management and Budget, to the Waggener Wildcat Booster Club, Inc. for the renovation of the track at Waggener High School.


SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
