Chris I have reviewed the links that you have forwarded. They were barely helpful. Nevertheless, why didn't you offer these before when I was asking for more info and guidance or even tell me what I should be looking for? The pages contained mainly general information but not the details I have requested. After our correspondences and conversation yesterday I thought it was clear I was asking for specifics.

I received no details. ful. My reference to the PDF document regarding public participation and guidance that is posted by your department pertaining to rezoning is the type of info I want and have clearly stated that. Although this is so ridiculous at the last hour. Why would you not respond on your own with the info I have been asking for? I assume it is your job as the point person to help us better understand how we as concerned parties in opposition to this can better proceed. The brief link on appealing a decision does not help. How to be specifically be prepared BEFORE a decision would have been more beneficial.

How was I to know this is a request to amend a binding element? The notice I received gave no such info. I only found that out last night when you sent me the attachment! My request for further info from you has only led me to vague pages with forwarding links that are difficult if not impossible to navigate. This is not what I expect from a "neutral" government department Unless someone knew EXACTLY what they were looking for and how to cull through all the non-related conditions how could anyone have a chance here?

This has been frustrating and onerous and I feel as if this has been unfairly put upon us as homeowners and we have been given very little help to do partake in this hearing.

It is more than disappointing that your department seems to be so nonchalant about something of such significance. What's left to do?
