Keith - our contract with Sweep All for the extra litter pick up and sweeping services along Baxter/Bardstown expired June 15th. However, I would like to keep the service continuing uninterrupted thru Wed Sept. 4. Can Jasmine simply transfer \$18,344.40 in NDF to SWMS as soon as FY20 begins (or however else Beth might suggest)? This dollar amount accounts for 24 additional litter pickups and 6 additional street sweepings, all per the same terms of our recently ended contract. In fact, although the agreement expired on the 15th, Sweep All went ahead and continued litter pickup service on the 16th based on Doyle's and my understanding that we would extend thru 9/4 (so the terms would be 6/16-9/4). I think the program has been a good investment so far. If you have any questions, please ask Doyle or me. Thanks very much!
