00:02:36 Michael Hill presented the case and showed a Power Point presentation. He explained that the proposed changes to the Land Development Code will be presented according to sub-committee, or "Attachment" (Infill, Fair & Affordable Housing, etc.)

00:05:47 Mr. Hill gave a brief history of the Round One and Round Two Committees and Sub-Committees, and the proposed amendments that came out of each. This project has taken approximately two years to complete. These items from each sub-committee were voted on by the LDC Main Committee to become "official recommendations". He also explained about "staff recommendations" which are smaller, more procedure-oriented items that were not voted on by the LDC Main Committee.

00:44:56 Mr. Hill described what the Fair and Affordable Housing regulations cover and gave a summary of the proposed amendments. Many proposed changes are related to ADI standards. An annual report will also be submitted to Planning and Design Services to keep track of the types of housing proposed.

01:04:15 In response to a question from Commissioner Butler, Mr. Hill discussed the definition of arterial road or arterial corridor. The point system and the proximity to transit/bus routes were discussed.

01:08:30 On a recommendation from Commissioner Brown, Section 4.5.2.G.2 shall be changed to read, "The distance shall be measured by the shortest walking distance using sidewalks and crosswalks from the bus route."

01:09:24 Regarding MRDI (4.3.2F), Commissioner Brown and Mr. Hill discussed the possibility of multi-family housing on an existing R-4 zoned lot and under what circumstances that would apply.

01:15:37 Cathy Hinko, representing the Metropolitan Housing Coalition and also a member of the Fair and Affordable Housing Committee, spoke in support of the recommendations and the need for affordable housing in the community. She submitted two documents into the record [on file].

01:24:13 Chuck Kavanaugh, Executive Vice President of the Building Industry Association of Greater Louisville, spoke in support of the proposed amendments, particularly the ADI incentives.

01:26:57 On a motion by Commissioner Brown, seconded by Commissioner Peterson, the following resolution was adopted:

RESOLVED, that the Louisville Metro Planning Commission does hereby **RECOMMEND** to the legislative body of the Louisville Metro Government that all of the Land Development Code text amendments for Fair and Affordable Housing regulations, Case No. 14AMEND1003, be **APPROVED with one addition**: That Section 4.5.2G2 include language stating that the walking distance be measured using sidewalks and crosswalks.

01:38:34 In response to questions from Commissioner Brown, Mr. Hill discussed Item #9 (finished attics); Item #18 (restricted uses during certain hours); Item #22 (public art fee-in-lieu, not recommended for approval) and Item #29 (signature entrance sign/wall for major residential or non-residential subdivisions).

Attachment #5 – Permitted and Conditional Uses

Agency Testimony:

01:48:50 Mr. Hill described in detail what the Permitted and Conditional Use amendments are. One of the primary changes proposed was to allow non-residential uses currently permitted in the C-2 Commercial District to be allowed in the M-1 Industrial District.

01:56:36 Mr. Hill discussed Bed & Breakfast Facilities, particularly regarding outdoor events held there (Item #26, paragraph D). He said there was a "significant amount of opposition" to this one item.

02:02:10 Mr. Hill reviewed categories for duplex dwelling units (Item #35) and Boarding and Lodging Houses (Staff Item F). He added that there is an effort underway to make sure that Boarding and Lodging Houses are licensed and that the license will be renewed annually.

02:09:50 Mr. Hill reviewed clarifying language added to alcohol-related land uses (Staff Items C and D). This includes a request from the Louisville Metro Council to break up the single land-use listing of a tavern into three tavern land-use listings.

02:15:39 *NOTE: Commissioner Butler left the meeting at 3:30 p.m. and did not vote on this or subsequent cases.

02:15:56 In response to a question from Commissioner Jarboe, there was discussion about the reason for the outdoor event permits for B&B businesses.

02:19:23 Mr. Hill and several Commissioners discussed regulations as applied to non-Metro-owned Golf courses. Enforcement issues were discussed.

02:22:17 Parking requirements for duplexes in the Traditional Neighborhood form districts was discussed; also, what constitutes a "qualified design professional". IT was agreed to allow staff to come up with a definition.

02:27:34 Commissioner Proffitt asked for clarification regarding "production activities" for breweries.

02:29:50 Cathy Hinko, from the Metropolitan Housing Coalition, discussed Boarding & Lodging Houses (Staff Item F). She related some issues that had come up about this type of housing, particularly those related to housing for the disabled, and requested that the item be tabled for now to allow further research and review. She requested that this type of housing be a permitted use in many zoning districts, instead of a CUP. Commissioner Proffitt clarified that the proposed amendment adds two additional zoning classifications.

02:39:02 Michael Trabue said he has questions about item #26 (Vacation Rentals), specifically those in residential areas zoned R-5B. He said this applies to rentals for less than 30 days, and is a commercial use in residentially-zoned areas.

02:47:29 Commissioner Kirchdorfer said he understood about enforcement concerns for vacations rentals, but asked how Vacation Rentals are related to Bed & Breakfast businesses (which is what is addressed in Item #26.) Mr. Trabue clarified his concerns. Commissioner Proffitt discussed BOZA procedures and how they are related to B & B's and CUP's.

02:53:18 Deborah Bilitski, a member of the Main LDC Committee, also discussed Item #26 (the Bed & Breakfast regulation.) She requested that this one item be tabled for further review.

02:56:10 Commissioners' deliberation. **The Commissioners agreed that Item #26 and Staff Item F should be removed from consideration and not voted on today, to allow further review.**

03:03:41 On a motion by Commissioner Brown, seconded by Commissioner Peterson, the following resolution was adopted:
