The following was discussed:

- There are 120 parks throughout Jefferson County, with approximately 13,000 acres and 500 structures under roof
- Question about whether swimming pools are considered part of the deferred maintenance
- Metro Parks is estimating \$176 million of deferred maintenance needs
- Question about what small equipment replacement covers
- Life safety issues are considered top priority for deferred maintenance
- Metro Parks will be replacing roofs on the structures every 20 to 25 years
- Question about how Metro Parks keeps track of deferred maintenance for the fiscal year
- Metro Parks has a general repair account that is for emergency repairs of their equipment
- Question about whether groups are willing to invest in partnership with Metro Parks
- Question about whether there is a Metro Parks deferred maintenance list available that shows what the needs are for each park
- Question about whether making a list of deferred maintenances for each park would help in the future with cost of repairs
- Question about erosion control and the status of the landslide on Upper Road
- Question about whether Metro Parks has applied for the American Rescue Plan (ARP) funding
- Question and concerns about which projects would qualify for ARP funds
- Question about whether ARP funds would supplement the repair projects that Metro Parks has

- Question and concerns about the closures of Metro Park roads that were due to the pandemic
- Question about whether the horse barn at Iroquois Park is included in the deferred maintenance
- If the Parks where to stay close of longer they would need approval from the Metro Council
