IT'S YOUR **RIGHT** TO FIX WHAT'S **WRONG**

**Election Day: Tuesday, November 5, 2019**

***Last day to register or change your voting information is Monday, October 7 by 4 PM***

**Only 17?** If you will be 18 years old on or before November 5 (Election Day), you must register now to vote. Once registered, Jefferson County Clerk will verify your registration via mail. If you do not receive notification within 2-3 weeks or if it's close to the registration deadline, contact the county clerk's office (502.574.6100) to check the status of your registration.

**Polls open at 6 AM and close at 6 PM. If you are in line at 6 PM, you are allowed to vote.** Daylight Saving Time ends on Sunday, November 3!

**What you should take with you:** A valid ID: driver's license, Social Security card, county-issued identification card approved in writing by the State Board of Elections, U.S. government-issued identification card, Kentucky state government-issued identification card with picture, credit card, or another form of ID containing both picture and signature.

**Hard of hearing or vision impaired?** Every polling place has new touchscreen voting machines – BUT they are kind of hidden so you may have to ask for them.

**Need a ride to polls on Election Day?** A. Philip Randolph Institute (502.774.4834) provides free rides. Lyft and Uber may be giving reduced rides to the polls, or call your local party headquarters.

**Name not on the voter list?** Request an immediate hearing if your eligibility to vote is questioned. Any decision can be immediately appealed to a circuit judge – and of course, this has to be done before the polls close at 6 PM.

**If you become sick or are in the hospital, you can still vote with an Emergency Medical Ballot.** Request a paper absentee ballot between Tuesday, October 22 and Tuesday, November 5. Call your local Board of Election office to get an Emergency Medical Ballot. You will have to find someone to notarize your application for a ballot and then take that application to the Board of Elections to get your ballot. Once you've filled out your ballot, someone must take your ballot back to the Board of Elections before 6 PM on Election Day!

**Mailed-in Absentee Ballots:** An application for an absentee ballot must be requested, completed and returned to Jefferson County Election Center office no later than close-of-business on Tuesday, October 29 to receive a ballot.

You will be mailed a ballot which must be returned via mail (postage is \$1.10) to the County Clerk's Office and received in the office on Election Day, Tuesday November 5 (not postmarked that day). NOTE: the mail-in ballot has specific requirements for where to sign, fold, etc. Read the instructions carefully to ensure your ballot will be marked valid.

**Going to be out of town, sick, or pregnant? Early In-House Absentee Voting:** Registered voters in Jefferson County who will be out of town on Election Day can vote early at **Election Center, 701 West Ormsby Avenue, Room 301** (near 7th and Oak Streets).

**Others who can vote early:** A woman in her last trimester of pregnancy, a person or their spouse who is scheduled to have surgery on Election Day, and those who due to age, illness or disability are not able to go to the polls on Election Day.
