- ⤴ Researched and evaluated park and recreation resources and facility needs based on demographic, transportation and land use trends, user surveys, and the needs and interests of park user groups, neighborhood and business groups, nonprofit organizations, elected officials, other government agencies, and internal Parks operations needs;
