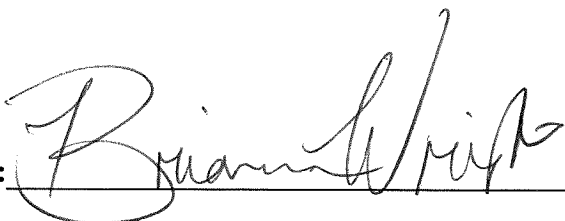

Branden Klayko Alley between N Shelby St & N Wenzel

Between Shelby & Campbell there is one existing light and one available pole that should be able to accommodate a light. Between Campbell & Wenzel, there are two existing lights and one available pole. To add two lights between Shelby & Wenzel would be about \$18.18/month for both lights or \$1,091 for the 5-Year lease. It may be tough to add more poles along this alley because there is limited right-of-way and a lot of tree coverage that would shield the lights.
