**QUALIFICATION OF
MEMBERS**

Members shall reside in Jefferson County and no more than one member shall reside within any council district. The members so appointed shall include persons who are representative of the several social, economic, cultural, ethnic, and racial groups that comprise the population of Metro Louisville.

PURPOSE

The Human Relations Commission-Advocacy shall endeavor to promote and secure mutual understanding and respect among all economic, social, religious, ethnic, and social groups in the metropolitan area, and shall act as conciliator in controversies involving intergroup and interracial relations. 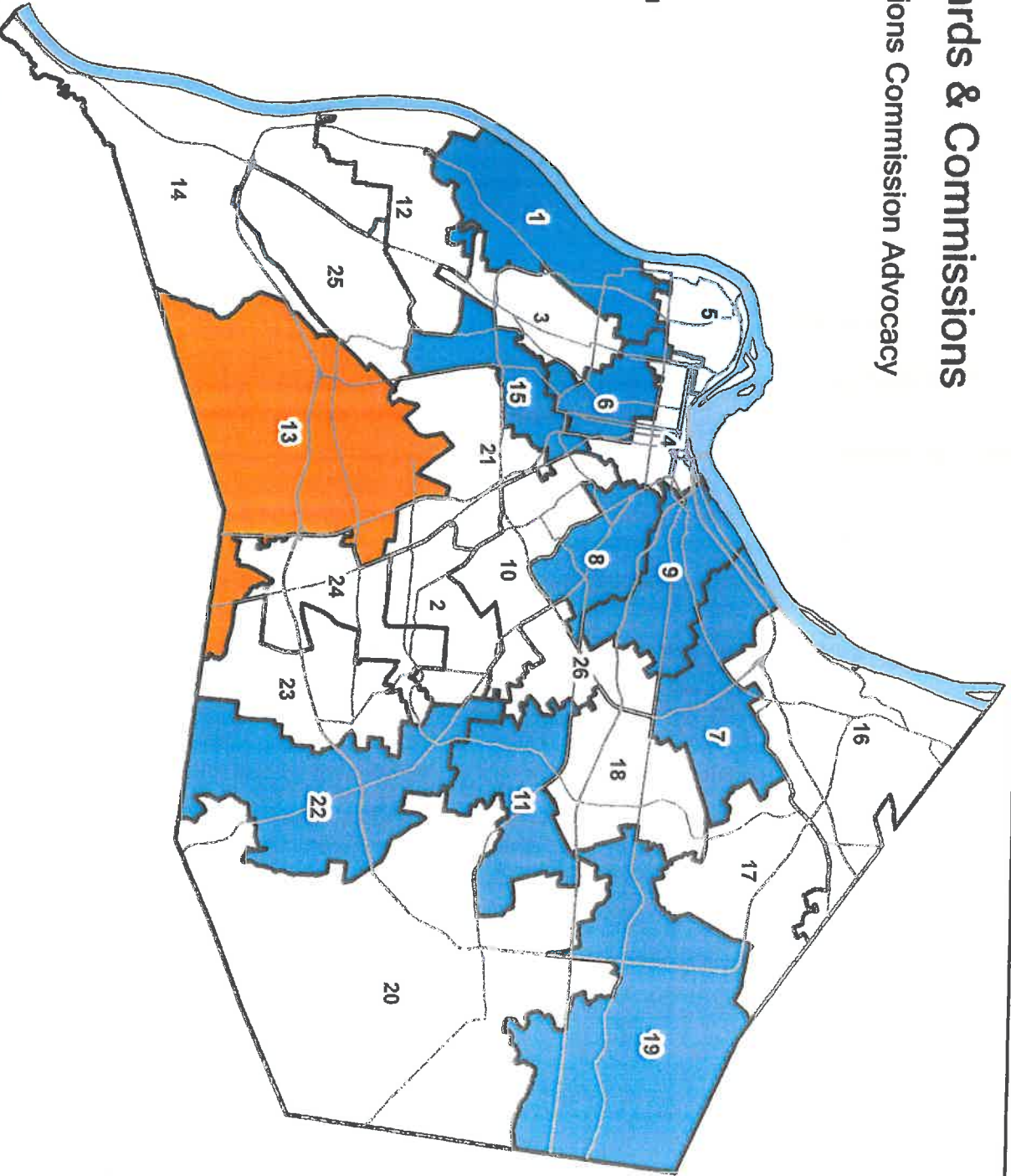
