Erin, In last week's status report, requested by Ms. Stenberg, we stated our intent to have the information requested to the Council by 3rd Quarter FY18.

In July, when the council requested this study, we partnered with Louisville Forward, to ensure we identified all available properties and development opportunities throughout Metro. Since then we have continued to evaluate relocation options for LMPD Headquarters, CSU, and the Impound Lot; such as the Coca-Cola Plant, AT&T Building. Property on Jennings Lane, as well as, Metro owned properties, Rhodeia and 7th & Industry.

Each of these properties present their own set of challenges, purchase cost, site remediation, mechanical replacement, rehabilitation, and/or new construction. Our intent is to address the specific pro/cons of remaining in place and costs of repair or relocating offices to new construction or existing buildings.

We look forward to presenting the best options available to us in this market and time when we complete the report.
