00:01:52 Jeff O'Brien provided a brief overview of the updates to the Comprehensive Plan. Mr. O'Brien discussed the process and timeline of updating the Comprehensive Plan thus far. Mr. O'Brien reviewed the CHASE principles of the Plan, which are Connected, Healthy, Authentic, Sustainable, and Equitable (see recording for detailed presentation).

00:07:01 Joe Haberman provided an overview of the data that was gathered in the process of updating the Comprehensive Plan. Mr. Haberman responded to questions from the Commissioners (see recording for detailed presentation).

00:16:58 Cathe Dykstra, CEO of Family Scholar House and Co-Chair of the Comprehensive Plan Advisory Committee spoke in regard to community input received (see recording for detailed presentation).

00:18:35 Cliff Ashburner, Co-Chair of the Advisory Committee, presented an overview of how the Advisory Committee has operated in working on the Comprehensive Plan (see recording for detailed presentation).

00:20:58 Jeff O'Brien touched on highlights of the goals, objectives, and policies for the various elements of the Comprehensive Plan. The plan elements are Community Facilities, Community Form, Housing, Livability & Environment, Economic Development, and Mobility. Mr. O'Brien responded to questions from the Commissioners (see recording for detailed presentation).

00:55:35 Victoria Markell spoke on behalf of the Louisville League of Women Voters to offer kudos to the entire process of developing the updated plan. Ms. Markell stated the League was happy to see a whole new section on affordable housing (see recording for detailed presentation).

Mr. Porter stated that a number of Louisville's peer cities have been successful at incorporating the preservation of conservation areas in their communities and this is a must do for our community. 01:07:38 Cathy Hinko, Metropolitan Housing Coalition, spoke in regard to fair and affordable housing. Ms. Hinko stated she believes the Community Form part of the plan promotes, even furthers, segregation. Ms. Hinko responded to questions from the Commissioners (see recording for detailed presentation).

01:18:35 Pat Durham stated he found this process to be very inclusive of our entire community and the document was very well thought out. Mr. Durham stated he doesn't want to encourage us to think about things like urban growth boundaries (see recording for detailed presentation).

01:23:57 Jon Henney stated he is here as a member of the consulting team that is assisting staff with the preparation of the final draft of the Comprehensive Plan which includes some basic things to make it more readable, including, but not limited to, introductory text before each of the plan elements, captions on pictures, and info graphics (see recording for detailed presentation).

01:25:04 Jeff O'Brien suggested the Commissioners provide their comments element by element so they can keep track of what they're going through. The Commissioners discussed infrastructure and incentives for infrastructure for reinvestment in the community.
