AN ORDINANCE APPROPRIATING ~~\$3,250~~ ~~\$12,000~~ \$11,200 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: ~~\$4,100 FROM DISTRICT 2;~~ \$1,750 FROM DISTRICT 3; \$1,500 FROM DISTRICT 9; \$1,000 EACH FROM DISTRICTS 2, 4, 7, AND 8; AND \$750 EACH FROM DISTRICTS 15 AND 21; \$500 EACH FROM DISTRICTS 12 AND 20; \$350 FROM DISTRICT 24; \$300 EACH FROM DISTRICTS 6 AND 14; AND \$250 EACH FROM DISTRICTS 13 AND 17; THROUGH THE OFFICE OF BUDGET AND MANAGEMENT, TO LOUISVILLE INDEPENDENT BUSINESS ALLIANCE, INC, FOR COSTS ASSOCIATED WITH THE 2026 BUY LOCAL FAIR TO BE HELD MAY 31, 2026 (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (“THE COUNCIL”) AS FOLLOWS:

SECTION I: The sum of ~~\$3,250~~ ~~\$12,000~~ \$11,200 from Neighborhood Development Funds in the following manner: ~~\$4,100 from District 2;~~ \$1,750 from District 3; \$1,500 from District 9; \$1,000 each from Districts 2, 4, 7, and 8; and \$750 each from Districts 15 and 21; \$500 each from Districts 12 and 20; \$350 from District 24; \$300 each from Districts 6 and 14; and each \$250 from District 13 and 17; through the Office of Budget and Management, to Louisville Independent Business Alliance, Inc, for costs associated with the 2026 Buy Local Fair to be held May 31, 2026.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
