WHEREAS, the Louisville Downtown Management District ("District") established pursuant to LMCO Chapter 160, Section 160.01-160.98 ("Ordinance") for the purpose of providing and financing of economic improvements that specifically benefit privately-owned property within the District;

WHEREAS, the Board of Directors for the District has developed and approved a budget for the period from January 1, 2021 through December 31, 2021 ("Budget") and economic improvement plans ("Plans") as required by the Ordinance;

WHEREAS, the Board of Directors has submitted the Budget and Plans as attached hereto as Exhibit A; and

**WHEREAS**, a public hearing to solicit comments was held on October 11, 2021 prior to the Council review and approval of the budget.

**SECTION III**: That this body directs the Board of Directors of the District to publish the Budget and the Plan pursuant to KRS Chapter 424.

**SECTION IV:** That this Resolution shall take effect upon its passage and approval or otherwise becoming law.

Proposed 2022 Operating Budget




