Along with these below can I get an estimate for Thornberry Ave, Taylor Blvd to Warren Ave? I am not sure where Thornberry intersects Warren.

Also, Vetter Ave – Can we get an updated estimate and rating. Would it be fair to say Vetter is "60" or below? Vetter is rated at 56 and 68 from 2012. I would say it is fair to assume it is all under a PCI of 60 as of now. I estimate this would be \$40,000.00 to repave. Please note there a quite a few parking pads on the side of the roadway which public works will not be replacing if this project is funded.

Sorry about the rush however Beth & LaTonya are pushing for us to spend our extra \$money. (Clean up accounts) Can we get these estimates and rating sooner than later? Thank you Sir! Sorry for the inconvenience!

Our office is requesting resurfacing estimates for several District 15 streets. They are as follows:

- 1.) Woody Ave – all PCI of 34 and 49, estimate of \$30,000.00
- 2.) Whitmore Ave – all portions pci range from 45 to 81 with an average around 50. The section of the road off Arlington is a gravel road which will need to be fully constructed. I estimate this roadway at \$65,000.00.



- 3.) Lynnhurst Ave (District 15 portion – Lonsdale Ave to Taylor Blvd) rating range from 59-72 with an average around low to mid 60s estimated at \$100,000.00
- 4.) Lonsdale Ave – all PCI from 44 to 68 with average around 60, estimated to repave at \$100,000.00
