AN ORDINANCE APPROPRIATING ~~\$5,500~~ ~~\$6,500~~ \$16,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3,000 FROM DISTRICT 12; \$1,500 EACH FROM DISTRICTS 14, 15, 17, AND 25; ~~AND \$500 EACH FROM DISTRICTS 1, 2, 3, 7, 9, 10, 13, 14, AND 17, 19, 20, AND 21, 22, AND 24;~~ AND \$250 EACH FROM DISTRICTS 5, 6, 8, AND 23; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO HARBOR HOUSE OF LOUISVILLE, INC. TO HELP PAY FOR THE 17<sup>TH</sup> ANNUAL KENDUCKY DERBY FUNDRAISER (AS AMENDED).


BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of ~~\$5,500~~ ~~\$6,500~~ \$16,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 from District 12; \$1,500 each from Districts 14, 15, 17, and 25; ~~and \$500 each~~ from Districts 1, 2, 3, 7, 9, 10, 13, 14, and 17, 19, 20, and 21, 22, and 24; and \$250 each from Districts 5, 6, 8, and 23; through the Office of Management and Budget, to Harbor House of Louisville, Inc. to help pay for the 17<sup>th</sup> Annual KenDucky Derby fundraiser.


**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
