- The state child care law applies to all facilities
- Question about capping the number of children in a child care home at 12 including related children
- Kentucky law uses 12 as the number of children to be at child care home of a primary residence of the care giver
- Question about whether the Ordinance would apply to subdivision's with deed restrictions
- Concerns about parking restrictions in subdivisions with homeowner's associations
- Question about the Conditional Use Permit (CUP) process and whether it can be revoked if state requirements are not being followed
- Question about R-4 and R-5 zoning areas and the CUP process
- State certified child care homes can have up to six children with the exception of an additional four that are related
- Question about the difference between a certified child care home and a certified child care center
- Type 2 child care facilities have 7-12 children, whereas child care centers can have any number of children
- Question about who would be responsible for monitoring child care facilities locally
- Question and concerns about the parking in the dense area
- An annual parking plan would need to be approved if you have seven or more children
- Question about whether a CUP should be required for 6-12 unrelated children in a facility
- Question about the CUP changes in residential zoned areas
- Question about whether Code and Regulations Department has expressed any concerns
- Question and concerns about the number of employees for ten children all under the age of two
- Question about whether the local fire departments will be notified that a home is a child care facility
