

ORDINANCE No. 173, SERIES 2014

AN ORDINANCE AMENDING ORDINANCE NO. 102, SERIES 2014, RELATING TO THE FISCAL YEAR 2014-15 OPERATING BUDGET FOR THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT, BY TRANSFERRING \$7,600 OF GENERAL FUND FROM ECONOMIC DEVELOPMENT TO PUBLIC HEALTH AND WELLNESS DEPARTMENT.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: Part I., F., 1. Economic Development, of Ordinance No. 102, Series 2014, is hereby amended as follows:

1. ECONOMIC DEVELOPMENT

a. General Operations

(1) General Fund	41,625,000	<u>11,617,400</u>
(2) Design'd General Fund Bal.	150,000	
(3) Design'd Other Fund Bal.	4,341,700	
(4) Community Development	0	
(5) Agency and Other Receipts	<u>11,564,700</u>	
Total- Economic Development	<u>27,681,400</u>	<u>27,673,800</u>

The reduction of \$7,600 above listed in Item 1.a. (1) removes the funding associated with the West Louisville Youth Space (Adventures in Theatre Camp program) from the Arts, Cultural Assets, and Parks Fund administered by Economic Development.

SECTION II: Part I., E., 3. Public Health & Wellness, of Ordinance No. 102, Series 2014, is hereby amended as follows:

1. Public Health & Wellness

a. General Operations

(1) General Fund	43,877,900	<u>13,885,500</u>
(2) Design'd Other Fund Bal.	15,000	
(3) Agency and Other Receipts	1,064,200	
Total-Public Health & Wellness	26,484,300	<u>26,491,900</u>

The increase of \$7,600 above listed in Item 1.a. (1) increases the funding for Family Health Center as it relates to that entity's moving expenses.

SECTION III: The Council has determined the funds requested in this ordinance will be expended for a public purpose.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
