PRESIDENT YATES: MR. CLERK, A ROLL CALL, PLEASE.

MR. CLERK: [CALLING ROLL]

MR. PRESIDENT, YOU HAVE 20 IN ATTENDANCE AND A QUORUM.

PRESIDENT YATES: THANK YOU, MR. CLERK. I BELIEVE THOSE

NUMBERS WILL COME UP SHORTLY, AS I BELIEVE THEY ARE IN THE

HALLWAY. MAY I ALSO HAVE THE RECORD REFLECT THAT COUNCILMEMBER

REED HAS AN EXCUSED ABSENCE.

THANK YOU. MR. CLERK, WOULD YOU CALL THE FIRST SPEAKER.

MR. CLERK: MARIAM KALLUM.

MERYEM KAHLOON: HI, SO I'M MERYEM KAHLOON, MY DISTRICT IS 16 AND COUNCILMEMBER IS SCOTT REED, I'M HERE IN SUPPORT OF SANCTUARY CITY. I THINK IT'S IMPORTANT WE MAKE IT A SANCTUARY CITY FOR A COUPLE REASONS. ONE IS FOR THE SAKE OF OUR CHILDREN, TWO IS FOR THE SAKE OF OUR COMMUNITY AND THIRDLY THE SAKE OF HUMANITY. WHEN PEOPLE COME HERE AS REFUGEES THEY COME IN DIRE NEED. THEY DON'T COME BECAUSE THEY HAVE MANY OPTIONS. THEY LEAVE THEIR COUNTRIES THEY KNOW, THE CULTURE THEY KNOW, THEIR FRIENDS, THEIR FAMILIES, AND I MEAN, FOR ME, THE ONLY THING THAT WILL MAKE ME LEAVE THAT IS ABSOLUTE POVERTY OR ABSOLUTE FEAR. THE

CHILDREN OF THESE PEOPLE, WHEN WE DETAIN PEOPLE BASED ON THE FACT THEY ARE HERE ILLEGALLY, OR JUST DIDN'T COME IN CORRECTLY BUT THEY ARE TRYING TO BETTER THEIR LIFE, WHICH MAJORITY OF THEM ARE TRYING TO DO, AND WE LEAVE THEIR CHILDREN CARE, WE ARE STICKING THEM IN FOSTER CARE SYSTEMS AND MAKING THOSE CHILDREN FEAR THIS COUNTRY, FEAR THEIR TEACHERS, FEAR POLICE, FEAR ANY AUTHORITY, WHICH IS NOT GOOD. BECAUSE THEY NEED TO FEEL COMFORTABLE TO GO TO THOSE PEOPLE DURING THEIR TIMES OF NEED. WHEN THEY FEAR PEOPLE OF AUTHORITY, THAT MAKES THEM VULNERABLE TO THOSE THAT WISH TO HARM THEM AND IT MAKES THEM LESS LIKELY TO SEEK HELP, OR EDUCATION-WISE, TO ASK THEIR TEACHER A QUESTION, OR TO ATTEND SCHOOL ON A DAILY BASIS.

AND ANOTHER REASON IS BECAUSE I THINK MOST OF US, AND ESPECIALLY BEING THE UNITED STATES OF AMERICA, WE PRIDE OURSELVES ON HUMANITY, WE INTERVENE WITH OTHER COUNTRIES WHEN THINGS ARE GOING WRONG. WE SHOULD UNDERSTAND THAT REFUGEES AND ILLEGAL IMMIGRANTS AND EVERYBODY HERE MAYBE NOT HERE LEGALLY ARE HERE BECAUSE THEY NEED OUR HELP. SO IT'S OUR JOB TO HELP THEM. FROM PREVIOUS EXPERIENCE, I HAVE GONE TO BOON COUNTY AND I'VE SEEN PEOPLE WHO HAVE BEEN DETAINED. THESE PEOPLE ARE HARD WORKING PEOPLE TRYING TO MAKE A LIVING FOR THEIR FAMILY, FOR THEIR KIDS, TO BETTER THEIR LIFE. IF LOUISVILLE IS A SANCTUARY CITY, THAT WILL ALLOW THEM TO FEEL SAFE. THAT WILL ALLOW THEM TO SEE LOUISVILLE IS ON THEIR SIDE. THAT THEY CAN MAKE A DIFFERENCE HERE. THAT THEY CAN DO A LEGIT REAL JOB AND THEY WILL BE OKAY,

THEIR KIDS CAN GO TO SCHOOL. THEY DON'T HAVE TO GO TO SCHOOL AND FIGURE OUT HOW TO WORK OR GET FOOD BUT THEY WILL BE ABLE TO LIVE A LIFE LIKE ANY OTHER AMERICAN WOULD WISH TO DO. THEY ALL COME FOR THE AMERICAN DREAM. WE ALWAYS TELL PEOPLE THAT AMERICA IS THE PLACE OF DREAMS AND HOPE.

SO LET'S ALSO START HERE IN LOUISVILLE AND MAKE
LOUISVILLE A PLACE OF DREAMS AND HOPE BY MAKING THIS A SANCTUARY
CITY. THANK YOU FOR YOUR TIME. [APPLAUSE].

MR. CLERK: CARL SITGRAVES.

CARL SITGRAVES: MY NAME IS CARL SITGRAVES, I COME BEFORE YOU TODAY, ASK THAT YOU WOULD CONSIDER CREATING A LAW THAT WOULD MAKE ALL CLUBS BE REQUIRED TO HAVE METAL DETECTORS AT THE ENTRANCE OF THE CLUB. HAVING METAL DETECTORS WOULD IMPROVE THE SAFETY OF THE PATRONS AND DETER PEOPLE WHO CARRY GUNS TO COME TO THE CLUB WITH THEM. WE CANNOT AFFORD TO LET THIS NOT HAPPEN. AS WE ALL KNOW, SAVANNAH WALKER DIED IN A CLUB WITH 50 PEOPLE IN IT. THE FACT OF THE MATTER WAS THEY HAD NO DETECTORS. I KNOW THAT SOME OF YOU WILL OPPOSE THIS LAW THAT WE ARE TRYING TO GET. I KNOW THAT SOME OF YOU HAVE FRIENDS WHO HAVE CLUBS AND THEY WILL BE OPPOSED AGAINST IT TOO. BUT I ASK YOU ALSO, THAT IF THIS IS TO BECOME A LAW OR SOME TYPE OF A LAW AND YOU VOTE AGAINST IT, I WONDER IF YOU WOULD MIND GOING TO ANY PARENT'S HOUSE AND TELLING THEM THEIR SON OR DAUGHTER WAS KILLED IN A CLUB AND YOU VOTED AGAINST HAVING METAL DETECTORS. THE OTHER PROBLEM ALSO THAT COMES FROM ALL OF THIS SHOOTING AND THINGS, I

FIND INTERESTING, MR. ACKERSON, IS HE HERE? HE HAS A PROPOSAL TO GET \$9 MILLION TO FIGHT CRIME IN THE AREA OF DRUGS.

YEARS AGO I SAT HERE AND I WATCHED THE ALDERMAN THAT
LIVED IN THE WEST END ASK FOR MONEY TO FIGHT THE CRACK COCAINE
AND THEY GOT VERY LITTLE. NOW ALL OF THE SUDDEN, YOU HAVE THIS
HEROIN. I GUARANTY IF THE HEROIN PROBLEM IS IN YOUR
NEIGHBORHOOD, IF IT ISN'T, IT WILL GET THERE. FURTHER MORE IF IT
DOES, OR IT IS, IT WILL BRING THE VIOLENCE AND ALL THE OTHER
PROBLEM THAT'S GO ALONG WITH USING DRUGS. I BELIEVE WE CAN SLOW
DOWN THE VIOLENCE BY HAVING METAL DETECTORS IN THESE CLUBS AND
BY PEOPLE BEING CHECKED. SOME OF THESE OWNERS MAY COMPLAIN ABOUT
THE ADDED COST AND INCONVENIENCE OF HIRING SECURITY PEOPLE. BUT
IF I COULD, I WOULD ASK SAVANNAH WALKER WHAT SHE THOUGHT OF A
METAL DETECTOR BEING WHEN SHE WALKED IN PORTLAND AND DIDN'T COME
OUT. THANK YOU.

MR. CLERK: DEBRA MUMFORD.

DEBRA MUMFORD: MY NAME IS DEBRA MUMFORD, I'M FROM
DISTRICT 11. ON NOVEMBER 11TH, 2011 LOUISVILLE METRO COUNCIL
UNANIMOUSLY VOTED TO ADOPT THE CHARTER FOR COMPASSION, A 10-YEAR
CAMPAIGN FOR COMPASSIONATE CITIES, ESTABLISH APRIL AS
COMPASSIONATE ACTION MONTH AND DECIDED LOUISVILLE, KENTUCKY IS
THE COMPASSIONATE HEART OF AMERICA. AT FESTIVALS AND SPEECHES
AROUND THE CITY AND NATION, MAYOR GREG FISHER DEFINES COMPASSION
FOR RESPECT FOR EACH AND EVERY PERSON SO THEIR HUMAN POTENTIAL

IS FLOURISHING, THRIVING, OR SHINING LIKE THE SUN. THE CITY WHO SPENT THE LAST SIX YEARS WHO DEDICATED COMMITMENT TO FLOURISHING ALL IT'S CITIZENS IS TO BECOME A SANCTUARY CITY.

IN LEVITICUS 13, THEY SAID WHEN THERE'S STRANGERS
LIVING AMONG THEM, THEY SHOULD LOVE THE STRANGERS AS THEY LOVE
THEMSELVES. GOD REMINDED THE PEOPLE OF ISRAEL THERE WERE ONCE
STRANGERS IN THE LAND OF EGYPT AND THEY SHOULD TREAT STRANGERS
THE WAY THEY WISH THEY HAD BEEN TREATED THEMSELVES.
COMPASSIONATE CITIES WHERE THEY REFUSE TO COOPERATE WITH UNJUST
LAWS FOR DETAINMENT AND DEPORTATION OF PEOPLE. THEY RECOGNIZE
MOST PEOPLE IMMIGRATING TO THIS GREAT NATION WANT WHAT WE ALL
WANT, SAFE PLACES TO LIVE, WORK AND RAISE THEIR FAMILIES AND
OPPORTUNITIES TO NOT JUST SURVIVE, BUT TO THRIVE. THEY WANT THE
AMERICAN DREAM. SANCTUARY CITIES ARE COMPASSIONATE CITIES THAT
ADVOCATE FOR THE HEALTH AND WELL-BEING OF ALL PEOPLE. WHILE
SIMULTANEOUSLY WORKING AND ADVOCATING FOR IMMIGRATION REFORM.

SANCTUARY CITIES SEEK TO ENSURE THIS NATION COMES EVER
CLOSER TO LIVING UP TO THE TRUE MEANING OF IT'S CREED THAT ALL
PEOPLE, NO MATTER THEIR RACE, ETHNICITY, NATION OF ORIGIN,
IMMIGRATION STATUS, SEXUAL ORIENTATION OR GENDER IDENTITY ARE
ALL CREATED EQUAL. SANCTUARY CITIES ARE COMPASSIONATE CITIES,
THEREFORE IT ONLY MAKES SENSE THAT OUR CITY WHICH HAS DECLARED
ITSELF TO BE THE COMPASSIONATE HEART OF AMERICA, SHOULD ALSO
COMMIT TO BECOMING A SANCTUARY CITY.

MR. CLERK: ELIJAH LEACH.

DONNA POLLARD.

DONNA POLLARD: GOOD EVENING, AND THANK YOU FOR YOUR TIME TODAY. MY NAME IS DONNA POLLARD AND I'M THE PRESIDENT-ELECT OF THE UNITED NATIONS ASSOCIATION, KENTUCKY DIVISION, AND I'M ALSO A MEMBER OF OUR STATE ATTORNEY GENERAL'S COUNCIL. YOU MAY HAVE HEARD OF THE DOCUMENTARY "I AM JANE DOE" AND SCREENING BEING HOSTED BY UNIVERSITY OF LOUISVILLE, MAY 8TH FROM 6:30-9:00. AS ONE OF THE PANEL IN THE POST-FILM DISCUSSION I HAVE HAD AN OPPORTUNITY TO PREVIEW THE FILM AND CAN ATTEST TO HOW POWERFULLY IT CONVEYS THE EPIDEMIC OF CHILD SEX TRAFFICKING IN OUR COUNTRY.

I WOULD LIKE TO INVITE EACH OF YOU TO ATTEND THE SCREENING OF THIS DOCUMENTARY. I FIRMLY BELIEVE IN ORDER TO FULLY ADDRESS AND ELIMINATE THIS HORRIFIC OFFENSE, WE MUST CONTINUE TO RAISE COMMUNITY AWARENESS OF THE ISSUE, AS WELL AS COMPASSION FOR ALL VICTIMS. A FORM OF TRAFFICKING NOT COMMONLY CONSIDERED IS CHILD MARRIAGE. FORCED MARRIAGE HAS BEEN RECOGNIZED BY ORGANIZATIONS AS MODERN DAY SLAVERY.

AND APPROPRIATELY SO, CONSIDERING THE MINOR CHILD IS

FORCED TO BECOME DEPENDENT ON THEIR OFTEN-TIMES ADULT SPOUSE

WITHOUT THE ABILITY TO ESCAPE SHOULD THE MARRIAGE BECOME

ABUSIVE. FOR EXAMPLE, A MARRIED MINOR CANNOT SEEK REFUGE IN A

DOMESTIC VIOLENCE SHELTER NOR RENT AN APARTMENT ON THEIR OWN

BECAUSE OF THEIR UNDER-AGE STATUS. THIS PLACES THE MINOR WITHIN

A POSITION OF SERVITUDE WITHOUT THE ABILITY TO ESCAPE ABUSIVE
AND EXPLOITIVE SITUATIONS. I KNOW THIS ALL TOO WELL BECAUSE I'M
A SURVIVOR OF CHILD MARRIAGE BY A PREDATOR THAT WAS TWICE MY
AGE. A FEW MONTHS AGO THE CITY OF JEFFERSON TOWN PASSED TWO
RESOLUTIONS, ONE SUPPORTING EFFORTS AGAINST HUMAN TRAFFICKING
AND THE OTHER ENCOURAGING OUR STATE LEGISLATORS TO ADDRESS THE
CURRENT LAWS AROUND CHILD MARRIAGE.

I HOPE TO BE ABLE TO SECURE THE SAME SUPPORT FROM YOU AS OUR LOUISVILLE METRO LEADERS. THE STATISTICS OF CHILD MARRIAGE IN OUR COMMONWEALTH ARE CURRENTLY BEING ASSESSED. THESE STATISTICS WILL GIVE US INSIGHT NOT ONLY THE VOLUME OF CHILD MARRIAGES BUT ALSO THE DISPARITY AND AGE BETWEEN THE UNDER-AGE PARTIES AND THE ADULTS THAT AGAIN THEY ARE OFTEN MARRYING. ONCE THE FINAL ANALYSIS HAS BEEN COMPLETED I WILL SHARE THIS DATA WITH YOU. AGAIN, I HOPE TO SEE YOU AT THE SCREENING OF "I AM JANE DOE" AND RAISING AWARENESS TO BRING AN END TO THIS CHILD VIOLENCE. THANK YOU.

MR. CLERK: JENNIFER MIDDLETON.

JENNIFER MIDDLETON: GOOD EVENING, THANK YOU FOR THE
OPPORTUNITY TO SPEAK WITH YOU TONIGHT. MY NAME IS JENNIFER
MIDDLETON, DISTRICT 21 AND I'M A PROFESSOR AT THE UNIVERSITY OF
LOUISVILLE SCHOOL OF SOCIAL WORK AND DIRECTOR OF HUMAN
TRAFFICKING RESEARCH INITIATIVE AND I'M HERE TO TALK ABOUT CHILD
SEX TRAFFICKING IN OUR CITY. WE RECENTLY CONDUCTED A STUDY AMONG
OUR MOST VULNERABLE YOUTH, INCLUDING HOMELESS AND RUN AWAY

YOUTH. WE CALL IT THE YES STUDY, YOUTH EXPERIENCES SURVEY AND A COPY OF OUR STUDY IS INCLUDED IN THE LINK ON THE FLYER THAT'S BEEN HANDED OUT TO YOU. SO WE INVITE YOU TO THE SCREENING OF "I AM JANE DOE" TO HELP CREATE AWARENESS, AS WELL AS TAKE TIME TO REVIEW SOME OF THE FINDINGS OF THIS STUDY. WE CONDUCTED THIS STUDY WITH YOUTH AGED 12-25 IN OUR COMMUNITY. AND WE HAD 132 YOUTH WHO WERE EXPERIENCING HOMELESSNESS AT THE TIME OF THE SURVEY.

OUR RESULTS INDICATE THAT 40.9%, ALMOST 41% OF OUR YOUTH EXPERIENCING HOMELESSNESS IN OUR COMMUNITY HAVE BEEN SEX TRAFFICKED, PER THE FEDERAL DEFINITION BY LAW. IN OUR SAMPLE, WHEN WE LOOK AT GENDER, THAT'S APPROXIMATELY 1 IN EVERY 2 GIRLS, AND 1 IN EVERY 3 MALES, WITH THE AVERAGE AGE OF THEIR FIRST SEX TRAFFICKING EXPERIENCE BEING 16 YEARS OLD. ALSO 70% OF THE YOUTH WHO WERE SEX TRAFFICKED IN OUR COMMUNITY REPORT THAT TECHNOLOGY PLAYED AN IMPORTANT ROLE IN THEIR SEX TRAFFICKING AND REPORTED THE REASONS FOR THEIR TRAFFICKING WERE PRIMARILY FOR SHELTER. 48% OF OUR YOUTH SAID THEY WERE SEX TRAFFICKED, SIMPLY FOR A PLACE TO STAY. WHEN WE COMPARE THE SEX TRAFFICKED HOMELESS YOUTH TO THOSE NOT SEX TRAFFICKED, WE FIND THE SEX TRAFFICKED YOUTH HAVE SIGNIFICANTLY HIGHER RATES OF MENTAL HEALTH DIAGNOSES, 94% OF THEM. DRUG USE AND DRUG ADDICTION, SELF-HARMING BEHAVIORS, SUICIDE ATTEMPTS, 83% OF THEM. DATING VIOLENCE, 73% OF THEM. AS WELL AS CHILDHOOD TRAUMA AND ABUSE.

SO THE STUDY, WE THINK, REALLY PROVIDES A SNAPSHOT OF THE COMPLEXITIES FACING OUR HOMELESS YOUTH PARTICULARLY THOSE EXPERIENCING SEX TRAFFICKING IN OUR COMMUNITY. WE ENCOURAGE YOU TO REVIEW THE REPORT. IN ORDER TO ENHANCE AWARENESS IN OUR COMMUNITY WHICH IS THE FIRST STEP TO COMBATING THIS PROBLEM, WE INVITE YOU TO COME TO THE SPECIAL SCREENING, THE PREMIER OF THE FILM "I AM JANE DOE" AT THE CLIFTON CENTER IN LOUISVILLE. IT STARTS AT 6:30 ON MAY 8TH. THANK YOU, VERY MUCH.

TEENA HALBIG: AS PRESIDENT OF THE UNITED NATIONS

ASSOCIATION OF THE UNITED STATES OF AMERICA, KENTUCKY DIVISION,

KNOWN AS U.N.A. U.S.A. KENTUCKY, I'M HERE TO THANK ALL OF METRO

COUNCILMEMBERS WHO MADE IT POSSIBLE TO HAVE A WONDERFUL

COMMUNITY EVENT FOR HUMAN RIGHTS DAY PROGRAM, HUMAN TRAFFICKING

CONFERENCE, GLOBAL TO GLOBAL. I ESPECIALLY WANT TO THANK OUR

SPONSOR MARY WOOLRIDGE OVER THERE, THANK YOU. YOU HELPED ENHANCE

LEARNING FOR THE PUBLIC. BRING SCHOOL OF LAW STUDENTS,

CRIMINOLOGY, NURSING STUDENTS AND PROFESSIONALS. WE KNOW THEY

WILL BE ABLE TO IDENTIFY VICTIMS IN OUR COMMUNITY AND BEYOND

OVER THE YEARS. I KNOW I HAVE ALREADY RUN INTO FOUR CASES

MYSELF. ATTENDEES THERE WERE ALSO ABLE TO OBTAIN C.E.U.'S.

U.N.A. U.S.A. KENTUCKY ADVOCATES FOR THE HUMAN TRAFFICKING

HOTLINE NUMBER, 888-373-7888 AND THE TEXTING OF BE FREE. BY

USING THIS NUMBER, MANY AGENCIES COULD BE ACCESSED WHEN THE CALL

IS ROUTED TO THE APPROPRIATE FEDERAL OR STATE AGENCY. 1,300

AGENCIES ARE BEING LOOKED AT TO DECIDE WHERE IT GOES TO. IT'S

NOT NECESSARY TO BE COMPLETELY SURE OF INFORMATION REPORTING AND

THE PERSON REPORTING THE INFORMATION COULD REMAIN ANONYMOUS.

IT'S HELPFUL IF THE CALLER COULD OBTAIN A LICENSE PLATE NUMBER OR ANY OTHER PERTINENT INFORMATION OR DESCRIPTION. U.N.A., U.S.A. KENTUCKY WORKED IN THE KENTUCKY GENERAL ASSEMBLY FOR HOUSE BILL 465 TO HAVE THE HUMAN TRAFFICKING HOTLINE NUMBER IN RESTROOMS AND REST STOPS ACROSS THE COUNTRY. IT PASSED, BUT THE BUDGET BECAME THE FOCUS. WE HAD THE SAME LEGISLATION AS HOUSE BILL 331, BUT DUE TO CHANGES IN THE TRANSPORTATION DEPARTMENT. HOWEVER THIS LEGISLATION WAS INCLUDED IN-HOUSE BILL 524 AND PASSED THE HOUSE. IT ACTUALLY WENT TO THE JUDICIARY COMMITTEE AND PASSED HOUSE AND SENATE. AFTER CHANGES IT PASSED THE HOUSE 94-0. THE GOVERNOR SIGNED IT APRIL 10TH, THIS YEAR. HOWEVER THE NAME HAS CHANGED TO BE UNDER AN ACT RELATING TO CRIMES OF PUNISHMENT UNDER K.R.S. 17500. IT WAS ADDED THAT EVERY PUBLIC SCHOOL SHOULD PROMINENTLY DISPLAY HUMAN TRAFFICKING REPORTING HOTLINE NUMBER BY THE HEALTH AND HUMAN SERVICES THAT ALREADY REQUIRES THE STATE-WIDE CHILD ABUSE HOTLINE NUMBER.

THIS PAST SATURDAY OUR MEETING WAS COMBATING HUMAN
TRAFFICKING, LOCAL NATIONAL AND GLOBAL. THE KEYNOTE IS JESSICA
CALHOUN WHO HAS WORKED WITH THE POLARIS PROGRAM FOR YEARS. IT
TAKES CARE OF THE NATIONAL HUMAN TRAFFICKING HOTLINE NUMBER AND
TEXTING. AS THE NUMBER IS KNOWN UNIVERSALLY MORE AND MORE

VICTIMS COULD BE HELPED. THANKS AGAIN FOR YOUR SUPPORT. THANK YOU.

MR. CLERK: ARIEL BROOKS.

ARIEL BROOKS: MY NAME IS ARIAL BROOKS AND I WORK FOR SAFE PLACE IN DISTRICT 16. YOUNG ADULTS 18-24. I'M HERE ON BEHALF OF THE LOUISVILLE AFFORDABLE HOUSING TRUST FUND. THE COALITION IS LOOKING TO HOUSE MORE THAN 150 YOUNG ADULTS AGES 18-24 AND THOSE ARE JUST THE ONES WE HAVE STATS ON AND ARE COMMUNICATION WITH ON A REGULAR BASIS. THE REASON YOUTH HOMELESSNESS IS IMPORTANT FOR ALL DISTRICTS, THESE KIDS COME FROM EVERY DISTRICT IN THE CITY.

RIGHT NOW MY CASELOAD, I HAVE CLIENTS LIVING IN

ABANDONED HOUSES, SOME BUSINESSES, PARKS, IN DISTRICT 6, 15, 1,

4, 5, 8, AND 9. AND THOSE ARE JUST THE KIDS WHO TOLD ME WHERE

THEY ARE SLEEPING EVERY NIGHT. A LOT OF THEM ARE LIVING IN

HOMELESS CAMP, WATERFRONT PARK, I HAVE ONE YOUNG MAN WHO USED TO

STAY BEHIND THE PIANO AT THE CHAPEL AT JEWISH HOSPITAL. MOST OF

THEM THAT AREN'T LIVING OUT, ARE LIVING IN SHELTERS LIKE WAY

SIDE OR SALVATION ARMY WHICH ARE NOT SAFE PLACES FOR YOUNG

ADULTS TO BE LIVING. THEY ARE VERY VULNERABLE TO DRUG ABUSE,

TRAFFICKING AND OTHER SEXUAL CRIMES WHILE LIVING IN SHELTERS.

THEY CAN ONLY STAY IN SHELTERS UP TO 30 DAYS, SO THEY ARE BACK

TO LIVING ON THE STREETS. SOME COUCH SURF, BUT IF COUCH SURF YOU

AREN'T ELIGIBLE FOR PUBLIC HOMELESS HOUSING OR ANYTHING LIKE

THAT. MOST HOMELESS HAVE AGED OUT OF FOSTER CARE, ABOUT HALF OF THEM, WITH NO SUPPORT WHATSOEVER AFTER THEY TURNED 18.

A LOT WERE KICKED OUT FOR MENTAL ILLNESS-RELATED
BEHAVIOR. RESISTING PARENT'S AUTHORITY, HURTING PEOPLE, KICKED
OUT OF SCHOOL. AT THAT POINT THEY HAVE NO PLACE ELSE TO GO. THE
JOBS THEY ARE ABLE TO WORK ARE NOT ENOUGH TO MAINTAIN HOUSING.
IT TAKES TWO PEOPLE IN MY HOUSEHOLD TO AFFORD WHERE WE LIVE, THE
MONEY OF MINIMUM WAGE JOBS ARE NOT ENOUGH. THE GOOD JOBS LIKE
G.E., U.P.S. AND AMAZON, IF THEY GET THERE, THEY CAN'T MAKE IT
EVERYDAY WITH THE ISSUES THEY FACE. THEY HAVE ONLY RECEIVED PART
OF THE MONEY THEY WERE PROMISED A DECADE AGO. THE GOAL IS TO
CREATE HOUSING YOUNG PEOPLE COULD AFFORD AS WELL AS OTHER PEOPLE
IN THE CITY. THE WAIT LIST FOR HOUSING IS MORE THAN A YEAR
DEPENDING WHAT PROGRAM YOU ARE IN. DURING THAT YEAR YOU AREN'T
STAYING WITH YOUR FRIEND, YOU ARE SLEEPING ON THE STREETS FOR
THAT ENTIRE TIME, I FEEL THAT'S A NECESSARY CHANGE THAT NEEDS TO
HAPPEN WITH THE CITY.

[APPLAUSE].

MR. CLERK: WE HAVE ONE MORE, JEANETTE WESTBROOK.

JEANETTE WESTBROOK: GOOD EVENING. I WOULD LIKE TO
THANK ALL OF THE COUNCILMEMBERS THAT SO GENEROUSLY SUPPORTED
FUNDING FOR THE HUMAN TRAFFICKING CONFERENCE HELD IN DECEMBER. I
WANT YOU TO KNOW THAT MANY OF THE GUESTS THAT WERE THERE TOOK
THIS INFORMATION TO OTHER PARTS OF THE COUNTRY AND I, MYSELF,
TOOK INFORMATION TO THE UNITED NATIONS, MY 13TH TIME AT THE

COMMISSION ON THE STATUS OF WOMEN. AND VIA REPORTS FROM CNN, I STARTED GETTING CALLS. WHAT IS HAPPENING IN LOUISVILLE, KENTUCKY? WELL, MY FRIENDS, I WANT YOU TO KNOW THAT THE INTERSECTION OF HUMAN TRAFFICKING, PROSTITUTION, THE HOMELESSNESS ISSUE, WHAT'S HAPPENING OR POTENTIALLY HAPPENING TO OUR REFUGEES AS A SOCIAL WORKER, I WORK IN ONE OF THE D.U.I. PROVIDERS AND I HAVE LOTS OF REFUGEES THAT I SEE, AND YES, THEY ARE BEING DEPORTED FOR ONE D.U.I. SO THAT IS A VERY BIG CONCERN. MOST THAT I SEE ARE VERY HARD-WORKING FAMILY PEOPLE. NOT CRIMINAL PEOPLE.

WHEN YOU TALK ABOUT DRIVING UNDER THE INFLUENCE THESE DAYS, IT'S MORE LIKELY TO BE DRIVING UNDER THE INFLUENCE OF SOME OTHER TYPE OF DRUG, INCLUDING HEROIN, THAN ALCOHOL. KENTUCKY AS A WHOLE HAS THE HIGHEST RATE OF D.U.I.'S IN UNITED STATES OF AMERICA. AND WE WANT PEOPLE TO CONSUME, HURRY AND GET ON THE BOURBON TRAIL, THIS BUD'S FOR YOU AND YOU HAVE PEOPLE WHO COME WITH NO TOLERANCE FOR ALCOHOL AND THEY DESPERATELY WANT TO ASSIMILATE INTO OUR CULTURE AND OUR COMMUNITY. AND CLEARLY, ALCOHOL IS NOT WHERE THEY NEED TO BE. AND I DEFINITELY DO MY DUTY IN EDUCATING AND TREATING THOSE INDIVIDUALS TO MAKE SURE THAT A SUBSEQUENT D.U.I. DOESN'T COME ABOUT. BUT ONCE AGAIN, THANK YOU, BECAUSE WHAT YOU HAVE DONE, WE ARE CONTINUING TO WORK WITH COUNCILMEMBERS AFTER THE HUMAN TRAFFICKING CONFERENCE ON OTHER INITIATIVES AND AS OUR COMMUNITY IS FLOODED WITH HEROIN, MY FRIENDS, WE HAVE TO PUT IT ALL TOGETHER. THE PROSTITUTION,

THE TRAFFICKING, THE DRUG DEALING, IT'S ALL ONE BIG BALL OF WAX.

THANK YOU, AGAIN, FOR SUPPORTING.

MR. CLERK: MR. PRESIDENT, THAT CONCLUDES THE ADDRESSES TO COUNCIL.

OPPORTUNITY. I THINK IT'S A GREAT PROGRAM. IT'S A GREAT WAY FOR
NEIGHBORS TO GET INVOLVED IN THEIR COMMUNITY, TO MAKE IT BETTER.
MY SECOND THING IS EACH OF YOU, I'M NOW KNOWN AS THE EASTER

BUNNY, SO YOU HAVE A LITTLE PACKAGE OF JELLY BEANS AND AN EGG
BECAUSE OUR COUNCILMEMBERS ARE DEFINITELY EXCEPTIONAL. SO THANK
YOU FOR A JOB WELL DONE. AND THE MEANING OF EASTER, IN MY LIFE,
IS ON THE PACKAGE OF YOUR JELLY BEANS. THE EGG REPRESENTS YOU AS
OUR COUNCILMEMBERS, IT'S WHAT'S INSIDE THAT COUNTS AND I REALLY
APPRECIATE. NOW MY THIRD THING, AND MY MOST IMPORTANT THING, IS

1953, BUT MADONNA SAID IT'S RECORD BEING THE LONGEST, I BELIEVE

IT WAS IN 1896 AND IT'S BEEN OPERATING AS A COMMERCIAL

ESTABLISHMENT IN A RESIDENTIAL AREA. SO IT'S NEVER CHANGED.

OTHERWISE IT WOULD HAVE TO CHANGE ITS ZONING MANY, MANY YEARS

AGO. NOBODY SPOKE AGAINST IT AT A NEIGHBORHOOD MEETING IT WAS

COUNCILWOMAN FLOOD: THANK YOU, I WOULD LIKE TO TURN THIS OVER TO COUNCILMEMBER BILL HOLLANDER, THIS IS HIS ORDINANCE, FOR EXPLANATION.

PRESIDENT YATES: THANK YOU COUNCILMEMBER.
COUNCILMEMBER HOLLANDER, THE FLOOR IS ALL YOURS.

COUNCILMAN HOLLANDER: THANK YOU, MR. PRESIDENT. THIS IS A SECTION OF LEXINGTON ROAD THAT RUNS FROM BAXTER TO JUST EAST OF SPRING STREET WHERE LEXINGTON ROAD CROSSES BEAR GRASS CREEK FOR THE SECOND TIME. JUST EAST OF SPRING STREET. IT'S A FAIRLY SMALL SECTION OF ROAD BUT IT'S IN VERY ACTIVE TRANSITION. WE HAVE ALONG THAT SECTION OF ROAD, A NEW COFFEE SHOP WHICH HAS JUST OPENED, IN WHAT USED TO BE AN AUTO DEALERSHIP. WE HAVE A \$45 MILLION TIF-FUNDED APARTMENT COMPLEX NEXT WEEK AND OTHER DEVELOPMENT ALONG THE STREET AND A LARGE AMOUNT OF INDUSTRIAL ZONING. IN VARIOUS PARCELS ON BOTH SIDES OF THE STREET. SO WE HAVE, FOR EXAMPLE, ON THE SOUTH SIDE OF THE STREET, MSD-OWNED PROPERTY. WHICH IS CURRENTLY USED BY METRO PUBLIC WORKS, WHICH I'M TOLD WILL BE ABANDONED. AND IT ADJOINS KATE HILL CEMETERY AND PUBLIC PARK CURRENTLY ZONED INDUSTRIAL, M2. WE HAVE A LARGE PARCEL OF M3 PROPERTY ON THE OTHER SIDE OF THE STREET AND WE HAVE SOME INDUSTRIAL PROPERTY AT PAYNE STREET REALLY ADJACENT TO THE COFFEE SHOP THAT I JUST MENTIONED.

IT SEEMS TO ME THAT IN A NEIGHBORHOOD THAT IS IN VERY ACTIVE TRANSITION, IT MAKES SENSE TO LOOK AT THE ZONING AND THE LAND USE ALONG THAT STRETCH OF PROPERTY. SO IN CONJUNCTION WITH

COUNCILWOMAN BARBARA SHANKLIN, WHO REPRESENTED ONE SIDE OF THIS ROAD, I REPRESENT BOTH SIDES OF PART OF THE SECTION OF THE ROAD, WE HAVE PROPOSED A LAND USE STUDY AND A MORATORIUM ON DEVELOPMENT, CERTAIN DEVELOPMENT WITHIN THAT AREA, WHILE THAT LAND USE STUDY IS BEING CONDUCTED. THIS IS A VERY LIMITED PERIOD. IT EXPIRES ON ITS OWN IN 180 CALENDAR DAYS. WE HAVE ALREADY TALKED TO COUNCILWOMAN SHANKLIN SMITH AND I TALKED ABOUT POTENTIAL MEMBERS OF AN ADVISORY GROUP.

WE HOPE THIS COULD ALL BE DONE WITHIN THE SIX-MONTH PERIOD, BUT IT'S VERY IMPORTANT, SUPPORTED BY THE IRISH HILL NEIGHBORHOOD ASSOCIATION, ALL OF THIS IS IN IRISH HILL. IT'S SUPPORTED BY BUSINESS OWNERS ACROSS THE STREET. SO I WOULD MOVE APPROVAL. I DO HAVE A -- AND THIS HAS BEEN ON THE SYSTEM FOR SOME DAYS, A PROPOSED FLOOR AMENDMENT. IF YOU WILL CLICK UNDER LEGISLATION TEXT, YOU WILL SEE PROPOSED FLOOR AMENDMENT. I WILL READ THE CHANGES, BUT AGAIN THIS IS ALL IN THE SYSTEM. THIS IS IN THE TITLE, THE WORD "MAJOR" WOULD BE ADDED PRIOR TO SUBDIVISION ON THE SECOND LINE, PLANNED CERTAIN WOULD BE ADDED IN THE THIRD LINE.

AND THEN IN THE FOURTH "WHEREAS" CLAUSES WE WOULD ADD
"NON RESIDENTIAL DEVELOPMENT APPLICATIONS INCLUDING WITHOUT
LIMITATION AND MODIFIER MAJOR SUBDIVISION, END OF MODIFIER, PLAN
CERTAIN. AND THEN AGAIN, IN SECTION 1, WE ADD THE LANGUAGE PLAN
CERTAIN. AND I BELIEVE, LET ME TAKE A LOOK HERE BUT I BELIEVE
THOSE ARE -- SORRY, SECTION 1. MODIFYING SUBDIVISION. IT SAYS

MAJOR SUBDIVISIONS AND THEN THE LANGUAGE PLAN. I MOVE APPROVAL OF THE AMENDMENT FIRST. THE FLOOR AMENDMENT.

PRESIDENT YATES: I HAVE A MOTION AND SECOND. IS THERE ANY DISCUSSION ON THE FLOOR AMENDMENT? HEARING NONE -- SORRY, COUNCILMEMBER JULIE DENTON, QUESTION ON THE FLOOR AMENDMENT.

COUNCILWOMAN DENTON: YES, IT SEEMED THERE WERE A LOT
OF THINGS GOING IN DIFFERENT PLACES, DO YOU HAVE THIS IN
WRITING?

>> YES, IT'S ON YOUR SYSTEM.

COUNCILWOMAN DENTON: WELL, I PULLED UP --

>> IF YOU GO TO DOCUMENTS UNDER LEGISLATION TEXT, THE FIRST DOCUMENT IS PROPOSED F.A.M., THAT'S FLOOR AMENDMENT. 041317.

COUNCILWOMAN DENTON: THANK YOU, SORRY. I OPENED EVERYTHING BUT THAT.

PRESIDENT YATES: WHAT WE HAVE BEFORE US, WE VOTE ON
THE FULL AMENDMENT. ALL THOSE IN FAVOR SAY "AYE", OPPOSED "NO."
THE AYE'S HAVE IT. THE FLOOR AMENDMENT PASSES. NOW WE ARE OVER
TO THE ORDINANCE.

IS THERE ANY FURTHER DISCUSSION ON THE ORDINANCES?

>> NO, I THINK THIS IS AN APPROPRIATE LAND USE STUDY

AND MORATORIUM FOR A LIMITED PERIOD, AND I WOULD URGE YOUR

APPROVAL.

PRESIDENT YATES: COUNCILWOMAN DENTON, YOU ARE IN THE QUEUE.

COUNCILWOMAN DENTON: I GUESS MY FIRST QUESTION IS, I'M NOT AWARE OF HAVING MORATORIUMS LIKE THIS. HAVE WE DONE THIS BEFORE?

PRESIDENT YATES: QUESTION TO MR. HOLLANDER.

COUNCILMAN HOLLANDER: YES, WE HAVE.

COUNCILWOMAN DENTON: WHERE WERE THOSE?

COUNCILMAN HOLLANDER: I TOOK LANGUAGE FROM A WYANDOTTE. AGAIN, WHEN YOU ARE DOING THIS KIND OF LAND USE STUDY. MORATORIUM MOST OF US VOTED FOR ON BIO-DIGESTERS.

COUNCILWOMAN DENTON: BUT THAT WAS JUST ON
BIO-DIGESTERS, IT DIDN'T APPLY TO ALL RESIDENTIAL APPLICATION.
COUNCILMAN HOLLANDER: THOUGHT YOU WERE ASKING ABOUT

MORATORIUMS.

COUNCILWOMAN DENTON: HAVE THERE BEEN MORATORIUMS LIKE

THIS, WHERE IT'S APPLIED ACROSS-THE-BOARD TO ALL DEVELOPMENT?

PRESIDENT YATES: IS THAT A QUESTION TO COUNCILMEMBER

HOLLANDER?

COUNCILMAN HOLLANDER: WELL, I DON'T KNOW ANYONE WHO KNOWS THE ANSWER.

PRESIDENT YATES: MR. WHITTY IS HERE TO ANSWER SOME QUESTIONS. CAN YOU TALK ABOUT IN THE PAST, YOUR HISTORY, I KNOW YOU HAVE A LOT OF INSTITUTIONAL KNOWLEDGE.

PAUL WHITTY: YES, SIR, MR. PRESIDENT, PAUL WHITTY, THE OFFICE OF THE JEFFERSON COUNTY ATTORNEY, MICHAEL O'CONNELL. I'M NOT AWARE IN MY TENURE OF A MORATORIUM OF THIS SCOPE. HOWEVER,

MORATORIA ARE A LAWFUL EXERCISE OF THE LAND USE AUTHORITY THAT

IS VESTED IN THIS BODY BY THE GENERAL ASSEMBLY. PROVIDED THAT

IT'S BON FIDE AND REASONABLE EXERCISE SOVEREIGN POWER, YOU CAN'T

DEPRIVE SOVEREIGN POWERS BY VIRTUE OF A PRIVATE CONTRACT THAT

MIGHT BE IMPAIRED.

I WOULD TURN THE WHOLE THING AROUND TO SAY THAT, IT IS
THE LAWFUL POWER OF THE GOVERNMENT TO DO MORATORIA AND A PRIVATE
CONTRACT UNBEKNOWNST TO GOVERNMENT CANNOT DEPRIVE OF IT OF ITS
LAWFUL AUTHORITY. HAD THIS BODY BEEN AWARE OF SOME USE THEY
WANTED TO PREVENT THAT'S BEEN FILED AND IN THE PROCESS, THAT
WOULD NOT WITHSTAND JUDICIAL SCRUTINY, BUT THAT'S NOT THE CASE
HERE. THERE'S NO CONSTITUTIONAL PROPERTY RIGHT OR INTEREST IN A
PERSPECTIVE LAND USE. THIS IS SOMETHING THAT IS A PRIVILEGE THAT
IS BESTOWED BY THE GOVERNMENT.

COUNCILWOMAN DENTON: CAN YOU TELL ME WHAT STATUTE OR
IS IT IN THE CONSTITUTION?

PAUL WHITTY: IT'S IN THE FEDERAL CONSTITUTION THAT YOU SHALL NOT IMPAIR A CONTRACT. BUT THAT'S NOT AS BROAD AS IT MAY SEEM. THERE'S BEEN CASE LAW NATIONALLY ON MORATORIA, AND THEY HAVE BEEN STRUCK DOWN WHEN THEY ARE REACTIONARY TO AN EXISTING PROPOSED LAND USE, BUT THAT'S NOT THE CASE HERE.

COUNCILWOMAN DENTON: WHAT PROPOSED LAND USES ARE OUT
THERE FOR THIS STRETCH YOU THINK FOLKS DON'T KNOW ABOUT?

PAUL WHITTY: WELL, I'VE ONLY HEARD JUST TODAY, LATE
THIS AFTERNOON, THAT THERE'S SOMEONE WHO HAS A CONTRACT TO BUILD

A CEMENT PLANT ON LEXINGTON ROAD. AND THIS PERSON HAS SENT A LETTER CLAIMING THAT IS IMPAIRING THEIR CONTRACT, AND I DON'T THINK THAT'S THE CASE.

COUNCILWOMAN DENTON: SO YOU THINK THEIR CONTRACT AND THEIR ABILITY TO BUILD THE CEMENT FACTORY OR PLANT ISN'T GOING TO BE IMPAIRED BY THIS MORATORIUM.

PAUL WHITTY: WELL, IT'S NOT GOING TO BE IMPAIRED IN
THE LEGAL SENSE. AS A RESULT OF THE MORATORIUM, IT MAY BE THE
STUDY WILL RECOMMEND THAT CURRENTLY INDUSTRIALLY ZONED
PROPERTIES BE DOWNZONED TO COMMERCIAL OR RESIDENTIAL. THAT WOULD
REQUIRE COMING BEFORE THE PLANNING COMMISSION AND THIS BODY FOR
A CHANGE IN THAT ZONING. THAT MAY, OR MAY NOT BE THE CASE. IT
ALL DEPENDS ON THE RESULT OF THIS STUDY. AND YOU HAVE THE RIGHT
TO PUT A FREEZE ON LAND USE ACTIVITIES DURING THE PENDENCY OF
THE CASE.

COUNCILWOMAN DENTON: WELL THAT MAY BE THE CASE, I'M

NOT AN ATTORNEY AND I DON'T PLAY ONE ON TV, BUT I'M WORRIED

ABOUT THE MORAL IMPLICATIONS OF FOLKS THAT HAVE PROPERTIES OF

THAT STRETCH WHO HAVE ENTERED INTO CONTRACTS WITH PLANS THAT MAY

OR MAY NOT BE SCUTTLED BY VIRTUE OF WHAT HAPPENS OVER THE NEXT

SIX MONTHS. SO I GUESS I HAVE CONCERNS THAT IF THERE ARE PLANS

CURRENTLY, WHETHER THEY HAVE BEEN EXECUTED OR NOT, BUT IF THERE

ARE PLANS CURRENTLY FOR THOSE PROPERTIES, I THINK THOSE PLANS

SHOULD BE ABLE TO MOVE FORWARD BECAUSE THEY WERE THERE BEFORE WE

TOOK ACTION ON THIS. AND HOW CAN WE ENSURE THAT THOSE PROPERTIES

ARE NOT GOING TO BE IMPEDED OR THOSE PLANS AREN'T GOING TO BE IMPEDED.

PAUL WHITTY: FIRST, LET ME ADDRESS MS. DENTON, THE

MORAL ISSUE YOU RAISED. I THINK IT'S A MORAL ISSUE THIS COUNCIL

BE PROTECTIVE OF THE HEALTH, SAFETY AND WELFARE OF THE

COMMUNITY. AND THESE MORATORIA ARE DIRECTED FOR THAT PURPOSE.

AND THEN SECONDLY, THE FACT THAT SOMEONE MAY HAVE PLANS FOR A

PROPERTY, DOES NOT VEST THEM WITH ANY RIGHTS. IN KENTUCKY, THE

CASE LAW IS, YOU'RE NOT VESTED WITH ANY RIGHT TO A PARTICULAR

LAND USE UNTIL YOU HAVE ACTUALLY, NOT ONLY SPENT MONEY AND GONE

THROUGH A PROCESS, BUT YOU HAVE TO HAVE IMPLEMENTED THAT PLAN BY

TURNING DIRT, INSTALLING INFRASTRUCTURE AND THE LIKE.

COUNCILWOMAN DENTON: ALONG THIS STRETCH, HAS ANYONE PETITIONED TO HAVE PROPERTIES REZONED DOWN?

PAUL WHITTY: I DON'T THINK SO. WE POSED THAT QUESTION
TO EMILY LU. I THINK THERE WAS ONE CASE THAT INVOLVED A DRIVE
THROUGH FOR A COFFEE SHOP THAT WAS PENDING. BUT THAT'S GOING
FORWARD AND WE WERE NOT AWARE OF ANY OTHER, WELL, OF ANY OTHER
FILED PLANS.

COUNCILWOMAN DENTON: I GUESS I'M A LITTLE CONFUSED AS

TO WHY WE DON'T LET THE PLANNING AND ZONING PROCESS WORK ALONG

THIS STRETCH AND DO SOMETHING PARALLEL AND TAKE A LOOK AT IT,

WHILE WE LET PROPERTY OWNERS HAVE FREE USE OF THEIR PROPERTY

UNTIL SUCH TIME BECAUSE THEY PURCHASED THOSE PROPERTIES AND THEY

HAVE PLANS FOR THOSE PROPERTIES BASED UPON THE ZONING UP UNTIL

THIS POINT. I HAVE A REAL PROBLEM FROM A MORAL PERSPECTIVE, AND A PHILOSOPHICAL PERSPECTIVE OF INTERFERING WITH PRIVATE PROPERTY RIGHTS AND WHETHER IT'S LEGAL OR NOT, TO ME ISN'T THE ISSUE.

PRIVATE PROPERTY RIGHTS AND WE ARE INFRINGING UPON THOSE ESPECIALLY WHEN THERE'S CONTRACTS THAT HAVE BEEN ENTERED INTO AND PLANS HAVE BEEN MADE AND THIS COULD POSSIBLY INTERFERE WITH THOSE.

PRESIDENT YATES: MR. WHITTY, STAY FROM THE LEGAL

QUESTION, I WANT TO KEEP FROM GOING INTO A DEBATE BECAUSE THERE

ARE MORE IN THE QUEUE.

PAUL WHITTY: WELL, MY POINT IS THERE'S NO MORAL ISSUE BECAUSE THERE IS NO PROPERTY RIGHT.

COUNCILWOMAN DENTON: WELL, MAYBE FROM YOUR PERSPECTIVE. BUT FROM MY PERSPECTIVE --

PAUL WHITTY: FROM THE PERSPECTIVE OF MY TRAINING. THAT'S ALL I CAN OFFER YOU.

PRESIDENT YATES: COUNCILMAN REED.

COUNCILMAN REED: THANK YOU, MR. PREIDENT.

WHAT HAPPENS IF WE ARE IN THE 5TH OR 6TH MONTH, AND IT HASN'T BEEN COMPLETED. WILL THIS ROLL INTO ANOTHER SIX MONTHS?

IS THERE AN END DATE AND IT EXPIRES?

COUNCILMAN HOLLANDER: SECTION THREE SAYS IT TAKES

EFFECT UPON PASSAGE AND APPROVAL AND SHALL REMAIN IN EFFECT FOR

180 CALENDAR DAYS UNLESS REPEALED OR EXTENDED. IT WOULD HAVE TO

BE EXTENDED BY THIS BODY.

COUNCILMAN REED: THANK YOU.

PRESIDENT YATES: COUNCILMEMBER STUCKEL.

COUNCILMAN STUCKEL: YES. I VOTED AGAINST THIS IN

COMMITTEE AND SPECIFICALLY ASKED THE SPONSOR IF HE HAD ANY

KNOWLEDGE OF ANYTHING THAT WAS PLANNED TO BE INSTRUMENTED IN

THAT AREA, AND HE SAID NO. I BELIEVE HIM. I ALSO ASKED PLANNING

AND ZONING IF THERE WAS AMPLE TIME, EVEN IF SOMETHING WAS

INSTITUTED TO COMPLETE THE SURVEY. AND THEY SAID THERE WAS. THE

TIME IT TAKES TO WORK THROUGH THAT PROCESS. IT COULD BE WELL

OVER SIX MONTHS. HOWEVER, WE DIDN'T KNOW AT THE TIME, OR I

DIDN'T KNOW THAT THE READY MIX COMPANY THAT HAS CONTRACTED FOR

THIS PROPERTY WAS GOING TO FILE. IN WHICH THEY DID, I GUESS

TODAY.

HOWEVER, GOING ALONG WITH COUNCILMEMBER DENTON'S
BELIEF, THAT PROPERTY IS CURRENTLY ZONED M-3. AND I WAS GOING TO
ASK THE QUESTION, WHETHER OR NOT THE MORATORIUM COULD AFFECT
THAT STUDY. AND IF I UNDERSTOOD YOU CORRECTLY, IF PLANNING AND
ZONING DECIDED TO DOWN-ZONE THAT, THE FACT THEIR CONTRACT IS
PROPERTY M-3 ZONING LEGALLY, IT'S HARD TO BELIEVE THAT WOULD NOT
PROBABLY COME INTO A LEGAL BATTLE IN THE COURTS. THEY WOULD
ARGUE THAT THEY WERE DOING SOMETHING THAT WAS VERY LEGAL AT THE
TIME AND THAT PLANNING AND ZONING IS NOW DOING SOMETHING THAT IS
GOING TO DO THEM GREAT HARM. I DON'T EXPECT YOU TO RULE ON THIS,
BUT I UNDERSTAND IT COULD BE SOMETHING THAT HAS TO BE SETTLED IN
THE COURTS.

PAUL WHITTY: I WOULD MAKE ONE POINT, COUNCILMEMBER
STUCKEL. THAT IS, I COULD ALMOST GUARANTEE YOU THAT CONTRACT HAS
A PROVISION THAT IT IS NULL AND VOID IF THE PROPOSED USE OF THE
PROPERTY IS NOT APPROVED. IF THEY AREN'T GOING TO BUY THE
PROPERTY THAT HAD BEEN, SAY IT DOES GET DOWN-ZONED. THEY AREN'T
GOING TO BUY IT IN THAT INSTANCE.

COUNCILMAN STUCKEL: ALL RIGHT. BUT WE DON'T HAVE THAT CONTRACT.

PAUL WHITTY: IN MY EXPERIENCE DEALING WITH LAND CONTRACTS, THAT'S A VERY STANDARD PROVISION.

COUNCILMAN STUCKEL: WELL, PART OF MY OPPOSITION WAS

THE FACT THAT I'M PROBABLY DEAD SET AGAINST MORATORIUMS. WHETHER

THEY ARE GOOD, BAD, OR INDIFFERENT. I JUST THINK IT'S REALLY AN

ANTI-DEVELOPMENT OPERATIVE AND I'M NOT FOR THAT.

PRESIDENT YATES: COUNCILMEMBER FLOOD?

COUNCILWOMAN FLOOD: THANK YOU, MR. PRESIDENT. HAVING
BEEN ON THIS COUNCIL FOR YEARS YOU HAVE HEARD ME PREACH AND
PREACH AGAINST THE MORATORIUM. I DON'T LIKE TELLING PEOPLE WHAT
TO DO WITH THEIR PROPERTY. THE THING ABOUT PROPERTY RIGHTS, I
UNDERSTAND THAT.

BUT IF YOU GO BACK TO WHEN THIS COUNCIL FIRST STARTED,
WE HAD TO MAKE SOME DECISIONS AS IT PERTAINS TO M-3 PROPERTIES,
AND THOSE FOUR COUNCILMEMBERS WHO REPRESENTED THIS METRO COUNCIL
IN THE LAWSUITS, MYSELF, COUNCILMEMBER HENDERSON, AND ON THE
REPUBLICAN SIDE COUNCILMAN HUNTER AND COUNCILWOMAN JULIE ADAMS.

EVERYBODY IS GETTING HUNG UP ON A CONCRETE PLANT THAT COULD GO
IN, OR MIGHT GO IN, OR WHATEVER. BUT THERE ARE FAR WORSE THINGS
THAT M-3 ALLOWS. AND ALL OF US THERE AT THE BEGINNING FOUGHT
HARD FOR A NUMBER OF YEARS. WE HAD TO HAVE THE COUNTY ATTORNEY
BRING IN A SPECIAL ATTORNEY TO WORK ON SOME OF THESE ISSUES.

SO I ASSURE YOU, THERE ARE FAR WORSE THINGS THAN A CONCRETE PLANT IN M-3, BY VIRTUE OF THIS CITY COUNCIL, BECAUSE IT WAS A UNANIMOUS VOTE. NONE OF US WOULD WANT TO LIVE NEXT TO AN M-3 PROPERTY WITH SOME OF THESE THINGS WE FOUGHT SO HARD TO KEEP OUT OF RESIDENTIAL AREAS. NEXT TO OUR CHURCHES, NEXT TO OUR SCHOOLS, NEXT TO RESIDENTIAL PROPERTIES BECAUSE OF THE SECONDARY EFFECTS. THAT'S WHERE I'M COMING FROM, NOT GETTING HUNG UP ON A CONCRETE PLANT THAT MAY OR MAY NOT GO IN, IT'S EVERYTHING IN THAT M-3 AREA THAT GOES RIGHT UP AGAINST RESIDENTIAL PROPERTY, THAT WE PAID A LOT OF MONEY FOR ATTORNEYS TO MAKE SURE WHAT IS ALLOWED IN M-3'S WOULD BE THERE, SO WE WOULDN'T HAVE SECONDARY EFFECTS IN OTHER AREAS AND OTHER ZONING ISSUES.

SO YOU MIGHT WANT TO TAKE A LOOK AT WHAT M-3 ALLOWS. I CAN TELL YOU RIGHT NOW, THERE'S NOT ONE OF US SITTING ON THIS COUNCIL THAT WOULD WANT TO LIVE NEXT TO SOME OF THE THINGS THAT ARE ALLOWED IN M-3 ZONING. THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

COUNCILMEMBER HOLLANDER.

COUNCILMAN HOLLANDER: I WILL PASS AT THIS TIME.

PRESIDENT YATES: COUNCILMEMBER KRAMER.

COUNCILMAN KRAMER: THANK YOU, MR. PRESIDENT. TWO THINGS. FIRST, I WOULD REMIND THE COUNCIL, AS COUNCILMEMBER FLOOD SAID, SEVERAL OF US WERE VERY CONCERNED ABOUT THE WAY M-3 WAS BEING USED AND WHAT WE MIGHT WANT TO LOOK AT AND CONSIDER, BUT I WOULD REMIND THE COUNCIL TOO, WE WEREN'T ARGUING OVER A MORATORIUM AT THAT POINT. WE WERE ARGUING OVER THE USE OF M-3. IF THIS IS A DISCUSSION ABOUT M-3, THAT'S A DIFFERENT DISCUSSION, AND WHAT'S BEFORE US TONIGHT IS A MORATORIUM. I WOULD ASK US TO REDIRECT OUR ATTENTION BACK TO THAT, AS THE REALITY. IN LIGHT OF THAT, I WOULD JUST ASK THE QUESTION OF THE COUNTY ATTORNEY OR MORE IMPORTANTLY RHETORICALLY ASK MY COLLEAGUES, DO WE BELIEVE THERE'S AN ATTORNEY SOMEWHERE THAT WOULD MAKE THE ARGUMENT THAT THE REASON WE PUT THE MORATORIUM IN TONIGHT IS TO SPECIFICALLY STOP READY-MIX TO PUT A CONCRETE PLANT IN THAT LOCATION? WHETHER THAT'S THE REASON OR NOT, WHETHER 26 OF US THINK THAT'S A RIDICULOUS ARGUMENT, IS IT A SAFE BET, A REASONABLE ASSUMPTION THERE ISN'T AN ATTORNEY OUT THERE THAT WILL MAKE THAT ARGUMENT.

AND IF THAT ARGUMENT IS MADE, HOW DO THE COURTS

RESPOND? I THINK THAT'S SOMETHING WE SHOULD CONSIDER. THIS ISN'T

JUST ABOUT A MORATORIUM AT THIS POINT ANY MORE. SOME OF THESE

PHILOSOPHICALLY OPPOSE MORATORIUM AS MENTIONED. AT THIS POINT,

IT CAN BE PERCEIVED THAT THIS IS A VOTE TAKEN BY THIS COUNCIL,

SPECIFICALLY WITH THE INTENT OF STOPPING A COMPANY FROM

PERFORMING WHAT, UNDER CURRENT ORDINANCE, UNDER CURRENT ZONING, WOULD BE PERFECTLY LEGAL.

PRESIDENT YATES: COUNCILMEMBER PARKER.

COUNCILWOMAN PARKER: YES. COULD WE HEAR AGAIN WHAT THE M-3, WHAT IS M-3 PROPERTIES ALREADY ADJACENT TO THIS PROPERTY.

COULD WE HEAR THAT AGAIN? COUNCILMEMBER HOLLANDER, COULD YOU REITERATE THAT?

PRESIDENT YATES: COUNCILMEMBER HOLLANDER.

COUNCILMAN HOLLANDER: I'LL DO ME BEST. -- MY BEST. LET ME SAY, THERE'S A LOT OF DISCUSSION ABOUT THIS ONE PROPERTY AND THERE'S A STATEMENT BY COUNCILMEMBER, IT COULD BE PERCEIVED THIS IS ABOUT THIS ONE PROPERTY. I'M TALKING ABOUT THE ENTIRE CORRIDOR AND I'M TALKING ABOUT INDUSTRIAL PROPERTY ON EITHER SIDE OF THE ROAD THROUGHOUT THE ENTIRE CORRIDOR. SOMEBODY MAY PERCEIVE THAT, BUT I DON'T, AND THAT'S NOT WHAT I'M TALKING ABOUT. BUT SINCE YOU ASKED ABOUT THIS PARTICULAR PIECE OF PROPERTY, DIRECTLY ADJACENT TO THAT PROPERTY HAS BEEN REZONED AS MULTI-FAMILY RESIDENTIAL, AND A \$45 MILLION 300-UNIT LUXURY APARTMENT BUILDING WILL BE DEDICATED THERE NEXT WEEK. IT IS FUNDED BY A TIF THAT WAS ADOPTED BY THIS METRO COUNCIL. THAT'S DIRECTLY ADJACENT TO THAT M-3 PROPERTY. IN ADDITION, THERE ARE, I BELIEVE, 10-12 SINGLE FAMILY HOMES ALSO ADJACENT TO THE M-3 PROPERTY. SO THOSE ARE THE ADJOINING USES. LET ME SAY, BECAUSE WE ARE TALKING ABOUT THIS PROPERTY, AND I THINK IT'S VERY IMPORTANT TO KEEP IN MIND -- MY CONCERN IS THIS WHOLE CORRIDOR BUT SINCE PEOPLE ARE FOCUSING ON THIS ONE PROPERTY, I WANT TO SAY A LITTLE BIT ABOUT THIS PROPERTY BECAUSE I HAVE TALKED TO ANOTHER COUNCILMAN TONIGHT ABOUT SORT OF WHY THIS IS COMING UP AT THIS POINT. THIS PARTICULAR PIECE OF PROPERTY WAS GOING TO BE AN MSD CSO BASIN. SO THROUGHOUT THE TIME THAT I WAS RUNNING FOR OFFICE, AND THROUGHOUT THE ENTIRE TIME THAT I'VE BEEN HERE, THERE HAVE BEEN NUMEROUS PUBLIC MEETINGS INVOLVING THE NEIGHBORHOOD, INVOLVING THE PROPERTY OWNER, INVOLVING MSD ABOUT THIS PARTICULAR PROPERTY. THAT IT WAS GOING TO BE AN MSD CSO BASIN.

WE HAD MEETINGS AND VOTED WHERE ON THE PROPERTY THE BASIN WOULD BE LOCATED AND WHAT SECTIONS WOULD BE USED AND WHAT SECTIONS WOULDN'T BE USED AND HOW THE REST OF IT COULD BECOME PARK-LIKE. AND IN THE LAST FEW MONTHS, THE MSD CSO BASIN WENT AWAY. MUCH, I THINK, TO THE CHAGRIN OF ME, AND PROBABLY TO THE PROPERTY OWNERS. THEY SAID THEY DIDN'T NEED THE PROPERTY ANY MORE FOR THE CSO BASIN BECAUSE THEY ARE DOING THE BIG TUNNEL DOWNTOWN. AT THAT POINT THE PROPERTY CAME ON THE MARKET.

SO THAT'S MAYBE SOME EXPLANATION AS TO WHY, AS IT RELATES TO THAT PARTICULAR PROPERTY, WE ARE HERE NOW. BUT I WANT TO SAY CLEARLY, THERE ARE LOTS OF PROPERTIES ON THIS STRETCH OF ROAD I THINK NEED TO BE LOOKED AT IN A LAND USE STUDY, INCLUDING SOME OWNED BY MSD.

COUNCILWOMAN PARKER: WHAT ARE THE EXISTING M-3 USES THAT ARE ON THAT STREET, OR NEARBY?

COUNCILMAN HOLLANDER: IT'S VACANT LAND.

COUNCILWOMAN PARKER: THERE'S NO M-3 USAGE AROUND THAT AREA, ON THAT CORRIDOR?

COUNCILMAN HOLLANDER: I'M NOT AWARE OF ANY M-3 USES.

THERE'S AN M-2 USE. SIGN SHOP. AN AUTO SHOP THAT'S AN M-2 USE. I

BELIEVE THE CORNER LOT IS VACANT. AS I SIT HERE, I'M NOT AWARE

OF ANY.

COUNCILWOMAN PARKER: I WILL MAKE ONE OTHER COMMENT.

THIS KIND OF REMINDS ME WHEN THERE'S A QUESTIONABLE HISTORICAL

PROPERTY AND THEN ONCE SOMEONE IS INTERESTED IN THE PROPERTY IN

THE LANDMARK AUTHORITY SWOOPS IN AND REDESIGNATES IT AT THE LAST

MINUTE. THAT IS A LITTLE BIT CONCERNING. BUT I DO SEE YOUR POINT

TOO WITH YOUR RESIDENCE THERE, THANK YOU.

PRESIDENT YATES: COUNCILMEMBER MULVIHILL.

COUNCILMAN MULVIHILL: THANK YOU, MR. PRESIDENT.

I WILL LET MY COLLEAGUE KNOW I WILL BE SUPPORTING THIS ORDINANCE. I BELIEVE, MR. PRESIDENT, THAT'S WHY WE HAVE 26 COUNCILMEMBERS, BECAUSE THEY KNOW PROBABLY WHAT'S BEST FOR THEIR DISTRICT. I WOULDN'T KNOW WHAT'S BEST FOR MY COLLEAGUE'S DISTRICT. I DO KNOW M-3, LIKE MY COLLEAGUE COUNCILMEMBER FLOOD SAID. WE HAVE FOUGHT TO KEEP THINGS OUT OF OUR NEIGHBORHOODS. THAT'S THE ONLY PLACE IT COULD BE LOCATED IS M-3. SO I WILL BE SUPPORTING THIS ORDINANCE. AND AGAIN, I BELIEVE EACH ONE OF US KNOW WHAT IS BEST FOR OUR VARIOUS COUNCIL AREAS, THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN.

COUNCILMEMBER BENSON.

COUNCILMAN BENSON: THANK YOU. MR. WHITTY, AN M-3, A CONCRETE COMPANY, WHERE YOU MAKE CONCRETE, YOU MAKE IT M-3. CAN THEY MAKE IT TO THE M-2, OR M-1.

PAUL WHITTY: THAT'S THE MOST INTENSE HEAVIEST INDUSTRIAL APPLICATION.

COUNCILMAN BENSON: SO IF WE ELIMINATE ALL THE M-3'S IN OUR COUNTY AND WE GO TO SOME OTHER COUNTY TO GET CONCRETE. THAT KIND OF BOTHERS ME. THOUGH, LIKE YOU SAID, THEY CAN GET OUT OF THE CONTRACT. BUT THE PERSON WHO OWNS THE PROPERTY, THE ONLY THING I'M WORRIED ABOUT, IF THAT PROPERTY BECOMES LESS BECAUSE THEY HAD A CONTRACT AND NOW THEY CAN'T FIND SOMEBODY TO BUY IT FOR WHAT THEY COULD HAVE SOLD IT, IF WE WOULD COMPENSATE THEM FOR THE AMOUNT OF MONEY THEY HAVE LOST. MOST PEOPLE DON'T FEEL WHEN THE GOVERNMENT STEALS LAND FROM THEM, I KNOW WHAT IT'S LIKE. THEY STOLE FROM ME. I DON'T LIKE THAT. I THINK GOVERNMENTS SHOULD BE ABOVE THAT. SO WHENEVER WE TAKE REZONING OF THE PROPERTY AND DOWN-ZONE IT FOR WHATEVER REASON, THE PERSON WHO IS LOSING IT SHOULD BE COMPENSATED, SO THEY DON'T LOSE. FOR THE BETTERMENT OF EVERYBODY ELSE, THAT ONE INDIVIDUAL, INDIVIDUAL RIGHTS ARE IMPORTANT. THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILMEMBER.

COUNCILMEMBER PEDEN.

COUNCILMAN PEDEN: THANK YOU. COUNCILMEMBER JUST FED ME
A JELLY BEAN AND NOW I'M CHEWING. YOU STARTED THE DISCUSSION ON

PLANNING AND ZONING SO NOW I HAVE TO GET ON MY SOAP BOX AT THIS POINT. I WILL BE SUPPORTING THE MORATORIUM. BUT NOT, AND I'M SUPPORTING IT FOR THE REASONS THAT COUNCILMEMBER SAID. I'M NOT TALKING ABOUT VETO POWER BUT WE ALL KNOW WHAT SITS AND WHAT DOESN'T. BUT AT THE SAME TIME WE DON'T HAVE EQUALIZED SUPPORT FROM THE OTHER 25 OF US. REPUBLICAN, DEMOCRAT, SOUTHWEST, SUBURBAN, URBAN, WHATEVER IT IS, I WANT THIS MOMENT TO BE RECORDED IN HISTORY AS THE TIME WE ALL REALIZED MAYBE WE ALL OUGHT TO LISTEN TO BRENT EVERY ONCE IN A WHILE. ALL RIGHT?

>> NO.

>> I SCREWED MY ARGUMENT FROM THE BEGINNING. BUT

NEVERTHELESS. I HAVE NEVER SEEN MR. WHITTY THAT IMPASSIONED

ABOUT NOT ZONING SOMETHING. I THINK EVERYBODY, FOR THE MOST

PART, IS CORRECT ON THIS SUBJECT. BUT IT ALL COMES DOWN TO WHAT

HAPPENS TO THE NEIGHBORHOOD? WE ARE INVESTING ALL OVER TO TRY TO

MAKE OUR NEIGHBORHOODS BETTER. WE HAVE A FUND CALLED

NEIGHBORHOOD DEVELOPMENT FUND, BUT AT THE EXACT SAME TIME TO

REMIND EVERYBODY, WHEN MY P.E.D. CAME DOWN THE LINE, THE

PLANNING COMMISSION PURPOSELY TOOK A PIECE OF PROPERTY OUT

BECAUSE THE DEVELOPER WAS UNHAPPY. TELL ME HOW THAT'S FAIR, I

SUPPOSE, ON DOWN THE LINE. HE REALLY WASN'T GOING TO DENY THE

ABILITY TO DO WHAT THEY ORIGINALLY PLANNED TO DO. SO I JUST WANT

THIS MOMENT IN HISTORY TO BE THE TIME WHEN WE ALL FINALLY COME

TOGETHER AND SAY TO OURSELVES, I KNOW COUNCILMEMBER HAMILTON, I

THINK IT WAS LIQUOR STORES AT ONE TIME. WE HAD THE BIO-DIGESTER AND WE HAD BLOOD TRANSFUSION PLACES. WE HAVE ALL HAD IT. MAKE A WORK GROUP, DO SOMETHING. BUT WE HAVE TO COME UP WITH A STANDARDIZED WAY OF TAKING CARE OF OUR OWN STUFF IN A WAY THAT DOESN'T GIVE US INDEPENDENT DISCRETION AT A MOMENT'S NOTICE, I GUESS IS A GOOD WAY TO PUT IT.

RIGHT NOW WE ARE DEALING WITH WHAT WAS GOING TO BE AN OLD FOLKS HOME IS GOING TO BE 600 UNITS NEXT TO MERCY HIGH SCHOOL. THAT AFFECTS THREE COUNCILMEMBERS IN THIS ROOM. FOUR IF YOU COUNT ME WHO USED TO HAVE THE PROPERTY WHEN IT WAS OWNED THE FIRST TIME. COUNCILMEMBER SHANKLIN AND HER AIDE JARED ARE DEALING WITH A SECOND DISTRIBUTION TRANSFER STATION FULL OF TRUCKS COMING IN AND OUT ALL DAY LONG NEXT TO A SET OF APARTMENTS ON FERN VALLEY ROAD. RIGHT WHERE, WHAT'S THE ROAD WITH THE LIBRARY? JEFFERSON BOULEVARD COMES IN FERN VALLEY.

CINDI JUST LOOKED OVER HERE AND I FORGOT ABOUT THE CREMATORIUM.

I WILL PUT THE ONUS ON YOU, I WILL HELP YOU WITH THE KNOWLEDGE-BASED PART BUT WE HAVE TO GET THIS DONE BEFORE WE HAVE ANOTHER ONE OF THESE. THAT'S MY SOAP BOX FOR THE DAY. THANK YOU FOR YOUR TIME.

PRESIDENT YATES: THANK YOU, COUNCILMEMBER.
COUNCILMEMBER DENTON.

COUNCILWOMAN DENTON: GOING BACK TO COUNCILWOMAN

PARKER'S QUESTION IN REGARD TO THE WHOLE CORRIDOR INVOLVED, IS

THE PROPERTY THAT THE PROPOSED CEMENT PLANT, IS THAT THE ONLY M-3 ZONED PROPERTY IN THAT CORRIDOR?

COUNCILMAN HOLLANDER: I'M NOT SURE. IT'S THE ONLY ONE THAT COMES TO MIND IMMEDIATELY. THERE ARE M-2, MULTIPLE M-2 PROPERTIES. I'M NOT SURE THERE'S ANOTHER M-3, BUT I'M REALLY NOT SURE.

>> I COULD ANSWER THAT BECAUSE I HAVE IT PULLED UP ON LOGIC. SO BEHIND IT, OFF EAST MAIN STREET THERE IS AN M-3 CURRENTLY.

COUNCILWOMAN DENTON: BUT THE CORRIDOR ITSELF, THAT LINES THE ROAD, THERE'S NO OTHER M-3 BUT THIS?

>> NO, MA'AM.

COUNCILWOMAN DENTON: OKAY. AND THE REASON I ASK, GOING BACK TO COUNCILMAN KRAMER'S COMMENTS THAT THE CASE COULD BE MADE THAT THE TIMING OF THIS LOOKS A LITTLE FISHY AND COULD SPUR LAWSUITS BASED UPON THAT. I'M WONDERING WHAT IS THE GENESIS OF THE IDEA TO DO THIS RESOLUTION. WHO CAME TO YOU, OR HOW DID THIS EVOLVE TO GET TO THIS POINT AND WHAT WAS THE TIME LINE ON THAT?

COUNCILMAN HOLLANDER: I DRIVE THE STREET EVERYDAY. AND AS I SAID, I HAVE BEEN INVOLVED IN THE DISCUSSIONS ABOUT THE MSD CSO BASIN FOR THREE YEARS. A "FOR SALE" SIGN WENT UP ON THIS PROPERTY. IN ADDITION, I LOOK EVERYDAY AT THE SIGN SHOP, WHICH MSD OWNS AND WHICH I'M TOLD PUBLIC WORKS WILL BE ABANDONING ACROSS THE STREET, WHICH IS ZONED M-2. BUT I'M ALSO VERY CONCERNED ABOUT THAT. I'M NOT ONLY CONCERNED ABOUT M-3 PROPERTY.

AN M-2 PROPERTY NEXT TO A PUBLIC PROPERTY AND CEMETERY IS A CONCERN OF MINE IN THIS REDEVELOPING CORRIDOR. I ALSO DRIVE BY THE NEW APARTMENT BUILDING EVERYDAY AND SEE THAT COMING OUT OF THE GROUND AND SEEING THERE ARE PEOPLE MOVING IN THERE.

I DRIVE BY THE NEW COFFEE SHOP EVERYDAY, WHICH HAS TAKEN OVER FROM THE AUTO DEALERSHIP. THE COMBINATION OF ALL OF THOSE, WE BEGAN LOOKING AT THE CORRIDOR AND SAYING WHAT REALLY MAKES SENSE IN THIS CORRIDOR. WE PULLED OUT A 2002 IRISH HILL NEIGHBORHOOD PLAN AND BEGAN THINKING ABOUT WHAT SHOULD REALLY HAPPEN IN THIS CORRIDOR.

COUNCILWOMAN DENTON: AND WHO IS WE, OUT OF CURIOSITY?

COUNCILMAN HOLLANDER: ME AND MY ASSISTANT KYLE

ETHERIDGE.

COUNCILWOMAN DENTON: AND WHO OWNS THAT APARTMENT COMPLEX?

COUNCILMAN HOLLANDER: I'M NOT SURE I KNOW THE OWNER,

IT'S CALLED ACCESS ON LEXINGTON. INDIANAPOLIS DEVELOPER. AGAIN,

THIS IS A TIF THAT WAS APPROVED BY METRO COUNCIL.

COUNCILWOMAN DENTON: I KNOW THAT, I JUST COULDN'T REMEMBER WHO THE OWNER WAS.

AND THEN THE ZONING ALONG THE CORRIDOR WHETHER IT'S M-2 OR M-3. GOING BACK TO COUNCILWOMAN FLOOD'S COMMENTS ABOUT THE M-3 WAS AN ISSUE THAT WAS LOOKED AT AND ADDRESSED AND THERE WERE CONCERNS AT THE BEGINNING OF METRO COUNCIL'S GENESIS. AND

IT'S BEEN UMPTEEN YEARS SINCE THEY HAVE BEEN CREATED. COULD THESE M-2'S AND THIS M-1 BEEN THIS WAY FOR ALL THOSE YEARS?

PRESIDENT YATES: IS THE QUESTION DIRECTED TO MR.

WHITTY?

COUNCILWOMAN DENTON: I DON'T KNOW MR. WHITTY WOULD NECESSARILY KNOW THE HISTORICAL --

PRESIDENT YATES: COUNCILWOMAN FLOOD.

COUNCILWOMAN FLOOD: WHEN THE COUNCIL SAID, I BELIEVE
THIS WAS A RECYCLING CENTER. AND IT WASN'T WHAT WE WERE DOING
WITH M-3'S. IT WAS WHAT WE WERE ADDING TO BE STUCK IN M-3
ZONING. IF YOU LOOK ONLINE YOU COULD SEE WHAT M-3 ALLOWS. AND I
GUARANTY YOU THAT CONCRETE PLAN IS NOT THE WORST THING THAT
COULD GO THERE. YOU SAY THERE'S A DEAL ON IT, IF THAT DEAL FALLS
THROUGH AND THERE'S AN M-3 SITTING THERE NO LONGER A RECYCLING
PLANT, NO LONGER USED BY MSD AND IT'S UP AGAINST RESIDENTIAL
PROPERTIES THERE ARE SOME ISSUES THAT NEED TO BE ADDRESSED.

COUNCILWOMAN DENTON: AND IF THAT'S THE CASE, I GUESS
MY QUESTION IS, WE ARE TAKING A WHOLE CORRIDOR IF THE CONCERN IS
JUST THE ONE PIECE OF PROPERTY. IS THAT THE ONE WE SHOULD
ADDRESS.

COUNCILWOMAN FLOOD: IT'S NOT JUST THAT, IT'S M-2. BUT TO ME, WHEN EVERYBODY KEPT THROWING THIS THING AROUND ABOUT CONCRETE PLANT, I ASSURE YOU, HAVING WORKED ON WHAT WE ALLOWED IN M-3, I'M MORE CONCERNED ABOUT WHAT THIS COUNCIL PUT M-3 THAN THE CONCRETE PLAN.

PRESIDENT YATES: I THINK IT'S EDUCATION TO DEBATE BACK AND FORTH, I KNOW WE HAVE A QUEUE FULL OF PEOPLE I WANT TO GET TO.

COUNCILMEMBER KRAMER.

COUNCILMAN KRAMER: I APPRECIATE THE CONVERSATION, I HOPE THAT NONE OF MY COLLEAGUES DERIVE FROM MY COMMENT THAT I WAS MAKING AN INFERENCE WHY A PERSON MIGHT BE MAKING THIS CHOICE, I WILL SAY, I CERTAINLY DID NOT IMPLY, AND DO NOT BELIEVE THAT COUNCILMEMBER HOLLANDER HAS MADE THIS DECISION BASED ON SOMETHING FILED TODAY. IF YOU FOLLOW THE WAY OUR PROCESS WORKS, HE HAS BEEN WORKING ON THIS FOR AT LEAST TWO WEEKS.

THAT WAS HIS PLAN, THAT'S ABSOLUTELY NOT WHAT I WANT PEOPLE TO INFER. THIS IS NOT SOMETHING THAT JUST CAME UP TODAY. IT WOULDN'T BE BEFORE US IF THAT WAS THE CASE. I'M NOT MAKING THAT INFERENCE AND I APOLOGIZE IF IT SOUNDED LIKE I WAS. I THINK TO COUNCILWOMAN FLOOD'S POINT, I COULDN'T AGREE MORE THAT THERE ARE THINGS ALLOWABLE IN M-3 THAT YOU WOULDN'T WANT RIGHT NEXT TO APARTMENT COMPLEXES. THERE HAVE BEEN SOME TREMENDOUS DEVELOPMENTS ALONG THAT STRETCH IN CRESCENT HILL AND I WOULDN'T WANT TO SEE US DO ANYTHING THAT WOULD, YOU TALK ABOUT PROPERTY OWNERS, IF YOU OWN APARTMENTS OVER THERE, ALLOWING SOME OF THE THINGS THAT M-3 ALLOWS WOULD DRIVE THEIR PROPERTY VALUES DOWN.

IF YOU MAKE THE ARGUMENT ABOUT PROPERTY OWNERS, WE SHOULD MAKE THE ARGUMENT ABOUT PROPERTY OWNERS. THAT BEING SAID, THE PROBLEM ISN'T IF WE ARE IN FAVOR OF THE M-3 OR NOT. THE PROBLEM IS, WE ARE TALKING ABOUT A MORATORIUM. LOOKING AT THIS PROPERTY AND TRYING TO DETERMINE IF IT SHOULD BE M-3 OR M-2 OR ANY OF THOSE PROPERTIES ON THAT CORRIDOR, THERE'S A PROCESS FOR THAT. MY FEAR IS, WHEN WE START PUTTING MORATORIUMS IN PLACE, ESPECIALLY IF THERE ARE RUMORS HAPPENING AND WE SEE THINGS MOVING AND SHIFTING, IT MAKES THINGS DIFFICULT FOR PEOPLE RELYING ON STABILITY. NOT ONLY DOES THE MORATORIUM CREATE STRESS, I THINK THAT IT OPENS US UP, EVEN THOUGH I DON'T BELIEVE MYSELF THAT IT IS TRUE, I WOULD POINT AGAIN, IT TOOK TWO WEEKS JUST TO FILE THIS THING, MUCH LESS THE TIME IT TOOK TO DO THE RESEARCH. IT STILL PUTS US IN AN AWKWARD PLACE.

I WOULD ABSOLUTELY SUPPORT A REQUEST OF PLANNING AND ZONING, OR PLANNING AND DESIGN, TO LOOK AT THAT CORRIDOR AND CONSIDER DOWN-SIZING NOT ONLY M-3 BUT PERHAPS EVEN DOWN-ZONING FROM M-2. BUT I WOULD REQUEST WE DO THAT IN THE NORMAL PROCESS OF THINGS.

PRESIDENT YATES: COUNCILLOR JOHNSON?

COUNCILMAN JOHNSON: I HONESTLY BELIEVE IF THEY FILED ALREADY THAT WE COULDN'T CHANGE IT WITH THIS AND IT WILL BE A WEEK OR SO BEFORE THE MAYOR SIGNS IT. I THINK IT'S ALL RIGHT, AND I CALL THE QUESTION.

PRESIDENT YATES: MOTION TO CALL THE QUESTION. DO I HAVE A SECOND?

>> SECOND.

PRESIDENT YATES: PROPERLY MOVED AND SECONDED. ALL

THOSE IN FAVOR SAY "AYE", OPPOSED "NO." THE AYE'S HAVE IT. THE

QUESTION IS CALLED. CLERK, WOULD YOU PLEASE OPEN THE ROLL CALL.

>> THE VOTING IS CLOSED.

MR. CLERK: 16 YES VOTES, 8 NO VOTES. THE NO VOTES ARE KRAMER, REED, STUCKEL, PARKER, DENTON, BENSON, ENGEL AND PRESIDENT YATES.

PRESIDENT YATES: THE ORDINANCE PASSES.

MR. CLERK, READ ITEM 52, PLEASE.

MR. CLERK: AN ORDINANCE IMPOSING A TEMPORARY

MORATORIUM ON REZONING, CONDITIONAL USE PERMIT, SUBDIVISION, AND

CATEGORY 2B AND 3 DEVELOPMENT PLAN APPLICATIONS IN AN AREA OF

LEXINGTON ROAD PENDING ASTUDY, REVIEW AND RECOMMENDATION BY THE

PLANNING COMMISSION OF LAND. USES AND ZONING DESIGNATIONS IN THE

AREA.

>> MOTION TO APPROVE.

>> SO MOVED.

PRESIDENT YATES: PROPERLY MOVED AND SECONDED.

COUNCILMEMBER JAMES.

COUNCILMAN JAMES: THANK YOU, THIS WAS PUT FORTH BY THE PRESIDENT. I WILL TURN IT OVER TO THE PRESIDENT.

PRESIDENT YATES: THANK YOU. I GUESS I COULD BRIEFLY
DISCUSS BEFORE THIS CHAIR, IT WAS BROUGHT BEFORE THE COMMISSION
ON BUILDING AND SAFETY, WE DISCUSSED SEVERAL TIMES THERE WERE
TWO MOTIONS MADE, I BELIEVE THE LAST TIME IT PASSED OUT I WASN'T
PRESENT BUT I BELIEVE IT PASSED OUT AFTER SEVERAL CHANGES AND I
BELIEVE THE BASIS WAS TO MAKE SURE THESE FEE STRUCTURES WERE
BROUGHT INTO PLACE, I BELIEVE IT WAS 20 YEARS SINCE THEY WERE
DONE PREVIOUSLY.

COUNCILMEMBER WOOLRIDGE.

COUNCILWOMAN WOOLRIDGE: THANK YOU, MR. PRESIDENT. I
WILL BE VOTING AGAINST THIS ORDINANCE FOR SEVERAL REASONS. I
DON'T THINK WE SHOULD SIT OUT HERE WEEK AFTER WEEK AND TAX
PEOPLE ADDITIONAL MONEY. SECONDLY, I DIDN'T SEE ANYTHING IN THIS
ORDINANCE, AND I MAY HAVE MISSED IT WHERE A PRIVATE TOW OPERATOR
HAS TOWED A CAR, HOW DO YOU RETRIEVE YOUR CAR? IS THERE A
NUMBER? ON A PARTICULAR LOT. WE HAVE BEEN THROUGH THIS, THE CITY
OF LOUISVILLE, WHERE WE HAD A PRIVATE TOW. THEY WOULD TAKE YOUR
VEHICLE, YOU DIDN'T KNOW WHERE YOUR VEHICLE WAS, YOU DIDN'T KNOW
WHEN YOU COULD GET YOUR VEHICLE, AND THE PRICE WAS EXORBITANT
WHAT HE WAS CHARGING. SO THEREFORE, I WILL NOT BE VOTING TO PUT
ADDITIONAL TAXES -- YOU KNOW, WE SIT HERE AND TALK ABOUT THE
WATER COMPANY WHEN THEY BRING OVER THEIR INCREASE. WE TALK ABOUT
MSD, WHEN THEY BRING OVER THEIR INCREASE. WE TALK ABOUT LG & E
WHEN THEY BRING THEIR INCREASE, HERE WE ARE AS METRO COUNCIL

PUTTING ADDITIONAL TAXES ON PEOPLE AS WELL. I WILL NOT BE VOTING IN FAVOR OF THIS ORDINANCE, AND THESE ARE MY REASONS. THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILMEMBER.

I BELIEVE COUNCILMAN PEDEN MIGHT BE ABLE TO ANSWER THE QUESTION ABOUT THE ORDINANCE.

COUNCILMAN PEDEN: I THINK THE PRESIDENT IS LIMITED ON WHAT HE COULD SAY WITHOUT GIVING UP THE CHAIR.

AS A MEMBER OF THE COMMITTEE, THIS WENT THROUGH AT LEAST TWO COMMITTEE HEARINGS, IF NOT THREE. HE WAS CORRECT IN WHAT HE SAID, WE ARE SIMPLY UPDATING THE AMOUNT. WE ARE TAKING IT FROM \$107 FOR A TOW FEE AND RAISING IT UP TO \$138. THAT \$138 IS NOT ARBITRARY. THAT \$138 IS WHAT THE CITY OF LOUISVILLE CHARGES IF THE CITY IMPOUND LOT ACTUALLY TOWS YOUR CAR, METER VIOLATIONS OR WHATEVER WE WOULD DO. TO ANSWER COUNCILMEMBER WOOLRIDGE'S QUESTION SPECIFICALLY, THERE ACTUALLY IS, WRITTEN INTO THE ORDINANCE, YOU MUST LEAVE CONTACT INFORMATION BEHIND, A NUMBER, EVERYTHING. SO THE PERSON WHO SUDDENLY COMES BACK OUT OF THE STORE, OUT OF THE RESTAURANT OR WHATEVER AND SAYS "HOLY CRAP, WHERE IS MY CAR" THERE IS INFORMATION THERE. NOT ONLY THAT, THE TOW OPERATOR IS REQUIRED TO CALL METRO POLICE. SO THE FIRST THING THEY DO ISN'T REPORT THEIR CAR STOLEN, SO IF THEY DO DIAL 9-1-1 AND REPORT THEIR CAR STOLEN, THERE'S A CLEARINGHOUSE OF INFORMATION, SO SOMEONE AT 9-1-1, OR METRO POLICE, WILL BE ABLE TO SAY, NO MA'AM, YOUR CAR WAS NOT STOLEN, IT WAS TOWED AND YOU COULD FIND IT HERE. ONE OF THE AMENDMENTS THAT COUNCILMEMBER LEET PUT ON THIS GIVES SOME PROTECTION FOR INCORRECTLY TOWING.

SIGNS SAY IF YOU ARE NOT IN THIS STORE, WE WILL TOW YOU. IF YOU

COULD PRODUCE RECEIPTS AND BAGS, I WAS IN THE STORE AND PROVE

YOU WERE TOWED INCORRECTLY, YOU COULD GET EVERYTHING WAIVED AND

MONEY BACK, IF ANY WAS INCURRED. I'M TRYING TO THINK OF THE

OTHER THING WE PUT IN THERE. OH, DAYS COUNTED.

IT'S ALSO \$138 FOR THE FEE, STORAGE FIRST 24 HOURS AND \$25 EACH CALENDAR DAY AFTER THAT. I THINK WE PUT IN THERE, A PRIVATE TOW OPERATOR MAY NOT CHARGE FOR DAYS WHEN IT'S NOT OPEN. IF YOU DON'T HAVE THE ABILITY TO GET YOUR CAR, YOU DON'T GET CHARGED A DAY FOR STORAGE. WE HAD A LOT OF CONCERNS OURSELVES IN COMMITTEE, AND WE ADDED SOME AMENDMENTS TO TAKE CARE OF THAT. BUT AS FAR AS YOUR ORIGINAL QUESTION OF NUMBERS TO NOTIFY, I THINK WE HAVE THAT COVERED ABOUT AS WELL AS WE CAN.

PRESIDENT YATES: THANK YOU.

COUNCILMEMBER ACKERSON.

COUNCILMAN ACKERSON: THANK YOU, MR. PRESIDENT. I WANT TO ADDRESS A COUPLE THINGS. FIRST OF ALL, TO MY RESPECTFUL COLLEAGUE, I WOULD DIFFERENTIATE THIS CLEARLY FROM MSD OR LG & E WHERE CITIZENS NEED AND REQUIRE. UNLIKE MSD AND THE WATER COMPANY, WHAT WE ARE TALKING ABOUT HERE IS A TOW FEE. IF YOU HAVE YOUR CAR TOWED, THE ODDS ARE YOU ILLEGALLY PARKED IT AND YOU BROKE THE LAW. THE REASON WE PUT THE FEES IN IS BECAUSE THERE HAS TO BE A MECHANISM IN PLACE TO PAY FOR THE RIGHTING OF THE WRONG. THE REMOVAL OF THE VEHICLE. THE STORAGE OF THE

VEHICLE. WHEN I WAS IN COMMITTEE AND THIS CAME OUT OF COMMITTEE

I MADE THE POINT OF RAISING ADDITIONAL ISSUE. WE AS A BODY

RARELY PASS THINGS THAT WE SAY IS AGAINST THE LAW. IT'S IMPROPER

TO NOT MOW YOUR GRASS, OR BUILD SOMETHING WITHOUT A PERMIT.

WHEN WE PASS THOSE THINGS WE WORK IN PENALTIES AND FINES AND ADMINISTRATIVE FEES. AND THIS BODY, WE HAVE PASSED STUFF 10 YEARS AGO, 20 YEARS AGO, 30 YEARS AGO. WE REALLY NEED TO GO BACK AND LOOK AT THE FEES. FOR INSTANCE, SOMETHING WE DECLARED ILLEGAL IN THE CITY 20 YEARS AGO, WE MIGHT HAVE ESTABLISHED A \$100 FINE AT THAT TIME AND THAT FINE WAS ESTABLISHED BASED UPON FACTORING WHAT IS THE REASONABLE COST TO ENFORCE THIS. AND WE HAVEN'T UPDATED ANY OF THOSE. THIS SHOULD BE THE FIRST STEP, GETTING THE FINES AND PENALTIES IN LINE WITH REALISTIC MODERN DAY PRICES.

A COCA-COLA TODAY COSTS A LOT MORE THAN A COCA-COLA 20 YEARS AGO. THAT'S CALLED INFLATION. THIS CITY IS NO DIFFERENT, THE COST TO DO BUSINESS CONTINUES TO GO UP AND THESE FINES AND PENALTIES HAVEN'T GONE UP. THIS IS A SITUATION, I THINK IS A POSITIVE, AND TONIGHT'S VOTE IS A VOTE IN THE RIGHT DIRECTION. BUT IT'S THE FIRST STEP. WE NEED TO BE GOING BACK AND LOOKING AT ALL OF THESE THINGS WE PUT FINES AND PENALTIES ON AND CONSIDERING SOMETHING THAT HAS AN ANNUAL, OR MAYBE SO MANY YEARS ADJUSTS FOR INFLATION, SO WE DON'T HAVE TO KEEP HAVING THESE ARGUMENTS AND FEEL LIKE WE ARE DOING SOMETHING WRONG OR TAXING

PEOPLE. THESE ARE THINGS WE DECIDED WERE RIGHT A LONG TIME AGO
AND WE PUT A PRICE TAG ON ENFORCING THOSE.

PRESIDENT YATES, THANK YOU FOR TAKING THE FIRST STEP AND GETTING US UP-TO-DATE ON WHAT THE PENALTIES SHOULD BE. I WILL BE A YES, VOTE. THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILMEMBER.
COUNCILMEMBER JOHNSON.

COUNCILMAN JOHNSON: I WOULD LIKE TO MAKE ONE

AMENDMENT. I HAVE TOLD PEOPLE BEFORE WHEN THEY HAVE HAD TO GET

THINGS OUT, IT ALWAYS INCREASES WHEN THEY ARE THERE, I THINK WE

OUGHT TO LEAVE THE REAL ESTATE FEE FROM 13 TO 10. SAY THEY HAVE

TO WAIT UNTIL THE NEXT PAYCHECK TO PICK THE CAR UP. THEN IT WILL

BE \$230 INSTEAD OF \$200. WHY NOT LEAVE \$10 FOR THAT. I MAKE THAT

MOTION.

>> I SECOND THE MOTION.

PRESIDENT YATES: I'M TRYING TO FIGURE WHERE AT YOU ARE IN THE DOCUMENT. COUNCILMEMBER, YOU SAID YOU SECONDED THE MOTION.

COUNCILWOMAN WOOLRIDGE: I WAS SECONDING COUNCILMEMBER JOHNSON'S MOTION.

COUNCILMAN JOHNSON: IT WAS \$10 AND THEY RAISED IT TO \$13. I DON'T THINK THE REAL ESTATE, I THINK IT'S FINE FOR PEOPLE PICKING CARS UP TO HAVE A BETTER PRICE, BUT I DON'T THINK THE REAL ESTATE FEE NEEDS TO CHANGE. THE PARKING FEE.

>> IS IT THE \$25 STORAGE FEE YOU ARE REFERRING TO?

COUNCILMAN JOHNSON: THE \$13 A DAY.

>> THAT WAS THE ORIGINAL BACK IN --

PRESIDENT YATES: THAT'S NOT THE ORDINANCE BEFORE US.

THEY BROUGHT THIS ORDINANCE IN LINE WITH WHAT METRO GOVERNMENT
WAS USING.

COUNCILMEMBER, I BELIEVE THEY SAID YOU MAY HAVE BEEN LOOKING AT AN OLD DOCUMENT.

COUNCILMAN JOHNSON: THEN I CHANGE IT FROM \$25 TO \$10 A DAY. THE STORAGE FEE. THAT \$25 A DAY, IT TOOK YOU TWO WEEKS TO GET YOUR CAR BECAUSE YOU HAD TO WAIT FOR YOUR NEXT CHECK TO COME IN. THAT WOULD BE 14 X \$25, VERSUS 14 TIMES \$10. INSTEAD OF \$140, IT WOULD BE \$300-\$400. TAKE THE WHOLE PERSON'S CHECK, HE WOULDN'T BE ABLE TO BUY GROCERIES. RICH PEOPLE DON'T HAVE THIS PROBLEM. WE ARE TALKING ABOUT PEOPLE WHO NEED THE HELP AND I THINK WE OUGHT TO STAY AT \$10 ON THE REAL ESTATE FEE. THE STORAGE FEE.

PRESIDENT YATES: UNDER SECTION 1, WHERE WE HAD CHANGED NOT MORE THAN \$25 A DAY, YOU WANT TO HAVE IT \$10 A DAY.

PRESIDENT YATES: COUNCILMEMBER WOOLRIDGE, DID YOU HAVE
A SECOND ON THAT?

COUNCILWOMAN WOOLRIDGE: I DID.

PRESIDENT YATES: MOTION AND SECOND. IS THERE ANY
DISCUSSION ON THAT? ALL THOSE IN FAVOR RESPOND BY SAYING "AYE".
ALL THOSE OPPOSED.

>> ROLL CALL.

PRESIDENT YATES: ROLL CALL, PLEASE.

WITHOUT OBJECTION THE VOTING IS CLOSING. THE VOTE IS CLOSED. A VOTE NO WOULD BE AGAINST IT. WITHOUT OBJECTION THE VOTING IS CLOSED.

MR. CLERK: 5 YES VOTES AND 19 NO VOTES AND TWO NOT VOTING. THE FIVE YES, SHANKLIN, WOOLRIDGE, HAMILTON, STUCKEL, AND JOHNSON.

PRESIDENT YATES: OKAY, THE FLOOR AMENDMENT FAILS. THE ORIGINAL ORDINANCE IS STILL BEFORE US. IS THERE ANY FURTHER DISCUSSION ON THE ORDINANCE? HEARING NONE.

COUNCILMEMBER WOOLRIDGE?

COUNCILWOMAN WOOLRIDGE: I WANT EVERYBODY OUT THERE
LISTENING TO THIS VOTE TONIGHT, YOU NEED TO CALL YOUR
COUNCILMEMBER. YOU NEED TO CALL THEM AND TELL THEM WE ARE BEING
TAXED AND WE ARE BEING OVERTAXED AND THIS BODY CONTINUES TO PUT
ADDITIONAL TAXES ON YOU, SO YOU KNOW WHAT TO DO, CALL YOUR
REPRESENTATIVE ON THIS COUNCIL AND LET THEM KNOW YOU'RE NOT
HAPPY ABOUT PAYING ADDITIONAL FEES AND TAXES. AND AGAIN, I'LL GO
BACK TO OTHER FEES AND TAXES. WE TRIED TO RAISE THE MINIMUM
WAGE. AND THE SAME PEOPLE IN HERE TONIGHT, THAT WOULD NOT VOTE
WITH THIS COUNCIL TO RAISE THE MINIMUM WAGE, SOME OF YOU ARE
VOTING NOW TO RAISE THE PRICE ON A TOW. CALL YOUR
COUNCILMEMBERS, IS WHAT I'M SUGGESTING. THANK YOU.

PRESIDENT YATES: COUNCILMEMBER BLACKWELL.

COUNCILMAN BLACKWELL: THANK YOU, MR. PRESIDENT. I

CERTAINLY HEAR COUNCILMEMBER WOOLRIDGE'S PERSPECTIVE. BUT I

BRING ANOTHER PERSPECTIVE, THAT WE HAVE A LOT OF CONSTITUENTS

WHO ARE VERY CONCERNED THAT THERE ARE ABANDONED CARS ON THE

ROADS AND ON THE SIDE OF THE ROADS AND CARS THAT NEED TO BE

TOWED AND WE CAN'T GET THEM TOWED AND PART OF THE REASON WE

CAN'T GET THEM TOWED IS FOR THIS REASON, OUR FEES ARE ARCHAIC.

THERE NEEDS TO BE AN INCREASE FOR SOMEONE TO COME AND TOW THEM.

WE ALL HAVE THEM IN OUR DISTRICTS WHERE YOU HAVE CARS, THEY GET

TAGGED, BUT THEY DON'T GET TOWED FOR WEEKS. IT FEELS LIKE

MONTHS, I THINK IT'S JUST WEEKS, I HOPE.

PRESIDENT YATES: THANK YOU, COUNCILMAN.
COUNCILWOMAN BARBARA SHANKLIN.

COUNCILWOMAN SHANKLIN: THANK YOU, MR. PRESIDENT. I TOO FEEL LIKE THAT. THE COMMENT IS MADE THAT WE BREAK THE LAW, SOMETIMES WE BREAK THE LAW. SOMETIMES THEIR CAR BREAKS DOWN. THEY HAVE A REASON THE CAR IS SITTING ON THE SIDE OF THE ROAD. MAY NOT HAVE ENOUGH MONEY TO GET IT RIGHT THEN. AND THEN WHEN IT GETS TOWED YOU ARE GOING TO PAY DOUBLE TO GET IT OUT. TO SIT HERE AND SAY WHEN WE BREAK THE LAW, THAT'S WHAT SHOULD HAPPEN. THAT'S NOT TRUE. YOU HAVE LOW-INCOME PEOPLE. NOT ALL OF US HAVE LOW-INCOME IN OUR DISTRICT. I AGREE WITH COUNCILMEMBER WOOLRIDGE WHO SAY SOME SITTING IN HERE DIDN'T WANT TO RAISE MINIMUM WAGE. THESE PEOPLE CAN'T AFFORD THAT. THANK YOU.

PRESIDENT YATES: THANK YOU, COUNCILWOMAN SHANKLIN.

COUNCILMEMBER JOHNSON.

COUNCILMAN JOHNSON: AM I THE ONLY COUNCILMEMBER HERE
THAT'S EVER BEEN TO THE TOWING LOT TO HELP PEOPLE GET OUT? IF
YOU GO THERE I THINK WE ARE REALLY SCREWING

WITH -- [INAUDIBLE] SO I WON'T SUPPORT THIS ORDINANCE.

PRESIDENT YATES: THANK YOU, COUNCILMAN.

IS THERE ANY FURTHER DISCUSSION? HEARING NONE, WOULD THE CLERK PLEASE OPEN THE VOTING. WITHOUT OBJECTION THE VOTING IS CLOSED.

MR. CLERK: THERE ARE 19 YES-VOTES. 5 NO-VOTES AND TWO NOT VOTING. THE NO VOTES ARE COUNCILMEMBERS SHANKLIN, WOOLRIDGE, BRIAN HAMILTON, FOWLER AND JOHNSON.

PRESIDENT YATES: THE AMENDED ORDINANCE PASSES.

AT THIS TIME I WOULD LIKE PRESIDENT PRO TEM HOLLANDER

TO PLEASE TAKE THE PRESIDENT'S CHAIR TO PROCEED WITH THE

REMAINDER OF THE MEETING.

COUNCILMAN HOLLANDER: MR. CLERK, A READING OF ITEM 53.

MR. CLERK: AN ORDINANCE AMENDING SECTION 115.451 OF THE. LOUISVILLE/ JEFFERSON COUNTY METRO GOVERNMENT CODE OF ORDINANCES RELATING TO REMOVAL OF VEHICLES BY PRIVATE TOW OPERATORS; FEE LIMITS. (AS AMENDED)

READ IN FULL.

>> SO MOVED.

>> SECOND.

COUNCILMAN HOLLANDER: IT'S BEEN PROPERLY MOVED AND SECONDED. DISCUSSION?

COUNCILMEMBER WOOLRIDGE.

COUNCILWOMAN WOOLRIDGE: THANK YOU, THERE IS SOME DISCUSSION. THIS CAME OUT OF CONTRACTS AND APPOINTMENTS COMMITTEE. AND THERE WERE SEVERAL AMENDMENTS TO THE AGREEMENT. IF YOU PULL UP YOUR DOCUMENT ON PAGE 2, THERE WAS AN ADDITION, NUMBER 5, TIME LINE SHOWING INFORMATION OF ACCUSATIONS WERE FIRST KNOWN. TO WHOM SAME WERE REPORTED, AS WELL AS SUBSEQUENT ACTION AND WHETHER SUCH ACTION FOLLOWED METRO PRACTICES AND POLICIES. AND I GUESS I SHOULD GO BACK AND SAY THIS IS THE AGREEMENT WITH A PUBLIC SERVICE CONTRACT, NON COMPETITIVELY. THAT AMENDMENT WAS ADDED TO THE AGREEMENT AND ADMINISTRATION AGREED TO ADD THIS. IT WAS POINTED OUT TO US BY COUNTY ATTORNEY'S OFFICE THAT THIS HAS NOTHING TO DO WITH THE RESOLUTION, WHAT WE WERE DOING WAS APPROPRIATING THE \$50,000 TOWARD THIS CONTRACT. AND IN SECTION D, ON THE SAME PAGE, 2, THERE WAS AN ADDITION ADDED, BEGINNING AT -- THE FOURTH LINE. AND IT SAYS "AND THE CHAIR OF TWO LARGEST METRO CAUCUSES". THIS WAS FOR REPORTING. ON THE SAME PAGE, E. NEXT TO THE LAST LINE. THE FOURTH WORD. "SHALL IMMEDIATELY" WAS ADDED TO THAT LINE. "SHALL IMMEDIATELY REPORT THE INFORMATION TO THE APPROPRIATE LAW ENFORCEMENT AGENCIES". AND THESE WERE THE AMENDMENTS OFFERED AND WAS ACCEPTED. SO I WOULD LIKE TO MOVE THIS AMENDMENT.

COUNCILMAN HOLLANDER: THANK YOU, COUNCILMEMBER WOOLRIDGE. IS THERE ANY FURTHER DISCUSSION? COUNCILWOMAN SHANKLIN?

COUNCILWOMAN SHANKLIN: [OFF MIC].

>> I WANTED TO ASK, WHEN SHE SAID THE TWO LARGEST COUNCIL COMMITTEES, WHICH ARE THE TWO LARGEST COMMITTEES?

COUNCILWOMAN SHANKLIN: I BELIEVE I SAID CAUCUSES. BOTH THE DEMOCRATIC AND REPUBLICAN CAUCUSES.

>> OKAY, SORRY.

COUNCILMAN HOLLANDER: IS THERE ANY FURTHER DISCUSSION?

SEEING NO ONE IN THE QUEUE, THIS IS A RESOLUTION, ALLOWING A

VOICE VOTE. ALL THOSE IN FAVOR SAY "AYE", OPPOSED "NO." THE

AYE'S HAVE IT. AND THE RESOLUTION IS ADOPTED. THE NEXT ITEM OF

BUSINESS IS NEW BUSINESS.

PRESIDENT YATES: NEXT ITEM OF BUSINESS IS NEW
BUSINESS. AS YOU LEAVE THE CHAMBERS, PLEASE DO SO QUIETLY SO THE
CLERK MAY READ NEW BUSINESS. I WOULD ASK THOSE COUNCIL MEMBERS
THAT WISH TO MAKE ANNOUNCEMENTS TO PLEASE REMAIN IN THE CHAMBERS
AND REQUEST TO SPEAK ON YOUR SYSTEM UNDER ANNOUNCEMENTS.
