

We help young people of Africa and the African Diaspora unleash their social entrepreneurial spirits to solve economic development, education, environmental, girls' rights, and health challenges and link African, African-American, Caribbean and other Diaspora groups for the purposes of friendship, cooperation, and individual and community empowerment.

VISION

At Bridge Kids International we begin with culture. We have a deep and abiding belief that for people of African heritage, our culture is our strength. It links us to our past, binds us together in the present and guides us toward our future. Recalling and reactivating our own wisdom, values and ways of being gives us the tools to reclaim our lives, each other and our communities and thrive with our souls intact. At Bridge Kids International we gather Africans and the African Diaspora in support of young people from birth to young adulthood. Rooted in culture and acting collectively, we work to protect and nurture young people, empower young families, and promote self-determination. We facilitate and accelerate the ascendance of children, youth and young adults, helping them develop creative confidence and positive ethnic/racial/cultural/gender identities, giving them opportunities to take responsibility, and supporting them as they put their ideas into action.

Bridge Kids International believes that young people of Africa and the African Diaspora have within them the genius and capacity to solve challenges in their lives and communities. We link young leaders from Africa and the African Diaspora, creating a dynamic global community based on real work, a sound understanding of the interconnectedness of issues and people, a genuine concern for and curiosity about each other, and a deep recognition that young people - when provided with resources and given the chance- have the ability to create lasting change.

Through Bridge Kids, young people from large urban centers to remote rural villages gain access to the world. They join a network of budding social entrepreneurs who tap into their own creativity to create smart solutions to real challenges. By helping young people improve their lives and home communities, learn about global issues, and travel internationally, the organization gives them a mechanism to exercise their leadership, access their human rights, and expand their worldview while making real friends across the globe. Bridge Kids has a multiplier effect; we impact young people and they impact others in their communities. As the small scale actions of many inspired people coalesce into a wave of transformation, the possibilities for change become limitless.

SERVICES

BKI operates from a belief that the interaction between culture, community, and connection leads to healing, restoration, and the evolution of individuals and communities. BKI organizes and supports BKI Groups comprised of young people ages 13-30 who design and implement projects to transform their lives and communities. There are currently BKI Groups in Congo, Ghana, Haiti, Malawi, Rwanda, Senegal and the USA (Louisville).

In Louisville, Bridge Kids International is establishing its global headquarters Our Place at Ben Washer Park (OPBWP) by turning a deteriorating building in Ben Washer Park into a unique community gathering place centered around youth social entrepreneurship, global citizenship, intergenerational relationships, and sustainable living. BKI Culture is the Cure programs include the annual African Heritage Festival, YAMAH (Young Adult Mothers of African Heritage), The Gathering Table intergenerational program for women, 7 Generations African Heritage Culture Camp, STEM and We Made It, a design & fabrication initiative, Cooking with Kin, Brown Girls LOL, African Heritage Culture Project, the Kizazi Fund and Mending the Bridge, an initiative to strengthen relationships between African-Americans and African nationals in the city.

The 7th annual African Heritage Festival is a celebration of unity, culture, art and history across the African Diaspora. Held on August 16th and 17th, the festival is a joyous event for the whole family with great food, music, dance, sports, fashion, cultural demonstrations, children's activities, resources for healthy living and so much more. This exciting celebration of African, African-American, and Caribbean cultures hosted by Bridge Kids International (BKI), the Kentucky Center for African American Heritage (KCAAH), and the Kentucky Old School Sports Association (KOSSA). The African Heritage Festival is being organized by a dynamic team representing a variety of countries and backgrounds. The whole city will be invited to this unifying event. The last festival drew approximately 1200 participants.

This year, the festival is moving to a new location, Ben Washer Park between 5th & 6th on W. Kentucky Street. Bridge Kids International is renovating a building in the park and, as the location will be our headquarters, we look forward to developing the African Heritage Festival there for years to come.

Some highlights of the 2019 African Heritage Festival are:

Opening Ceremony 7:30pm at Kentucky Center for African American Heritage - a screening of the documentary "Black N Black" about the relationships between Africans and American-Americans, followed by a community discussion

Louisville's African Heritage Festival celebrates the African Diaspora, a wide range of cultural groups in the city, including African-Americans, Africans and Caribbeans. In the past few years, the populations of people from Africa and the Caribbean have been growing in the Louisville. It is important to offer a warm welcome to our new neighbors and educate the wider community about the increasing diversity of cultures in the city. Additionally, some tensions have been reported between African-Americans and new arrivals from Africa. The African-Heritage Festival provides a safe, positive environment for groups to work and play cooperatively and celebrate one another. The African-Heritage Festival is a unifying event and stands proudly in the company of other annual cultural festivals in the city.

By August 30, 2019




