

ORDINANCE NO. 023, SERIES 2020

AN ORDINANCE APPROPRIATING \$20,250 FROM NEIGHBORHOOD DEVELOPMENT FUNDS AS FOLLOWS: \$1,500 EACH FROM DISTRICTS 1, 2, 4, 7, 8, 10, 17, 19, 20, 23, 26; \$1,125 FROM DISTRICT 25; \$750 EACH FROM DISTRICTS 9, 14; \$375 EACH FROM DISTRICTS 13, 15, 21; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE KENTUCKY SHAKESPEARE FESTIVAL, INC. FOR SHAKESPEARE IN THE PARK'S "HAMLET" 2020 TOUR.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The amount of \$20,250 is hereby appropriated from Neighborhood Development Funds as follows: \$1,500 each from Districts 1, 2, 4, 7, 8, 10, 17, 19, 20, 23, 26; \$1,125 from District 25; \$750 each from Districts 9, 14; \$375 each from Districts 13, 15, 21; through the Office of Management and Budget, to the Kentucky Shakespeare Festival, Inc. for Shakespeare in the Park's "Hamlet" 2020 Tour.


**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
